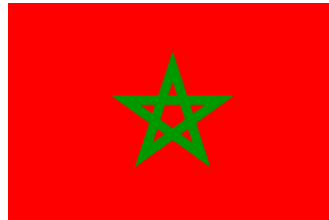
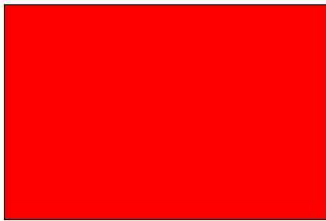

“We were not bought here by slave ships! That is a lie. In fact, it is the greatest lie ever told!”

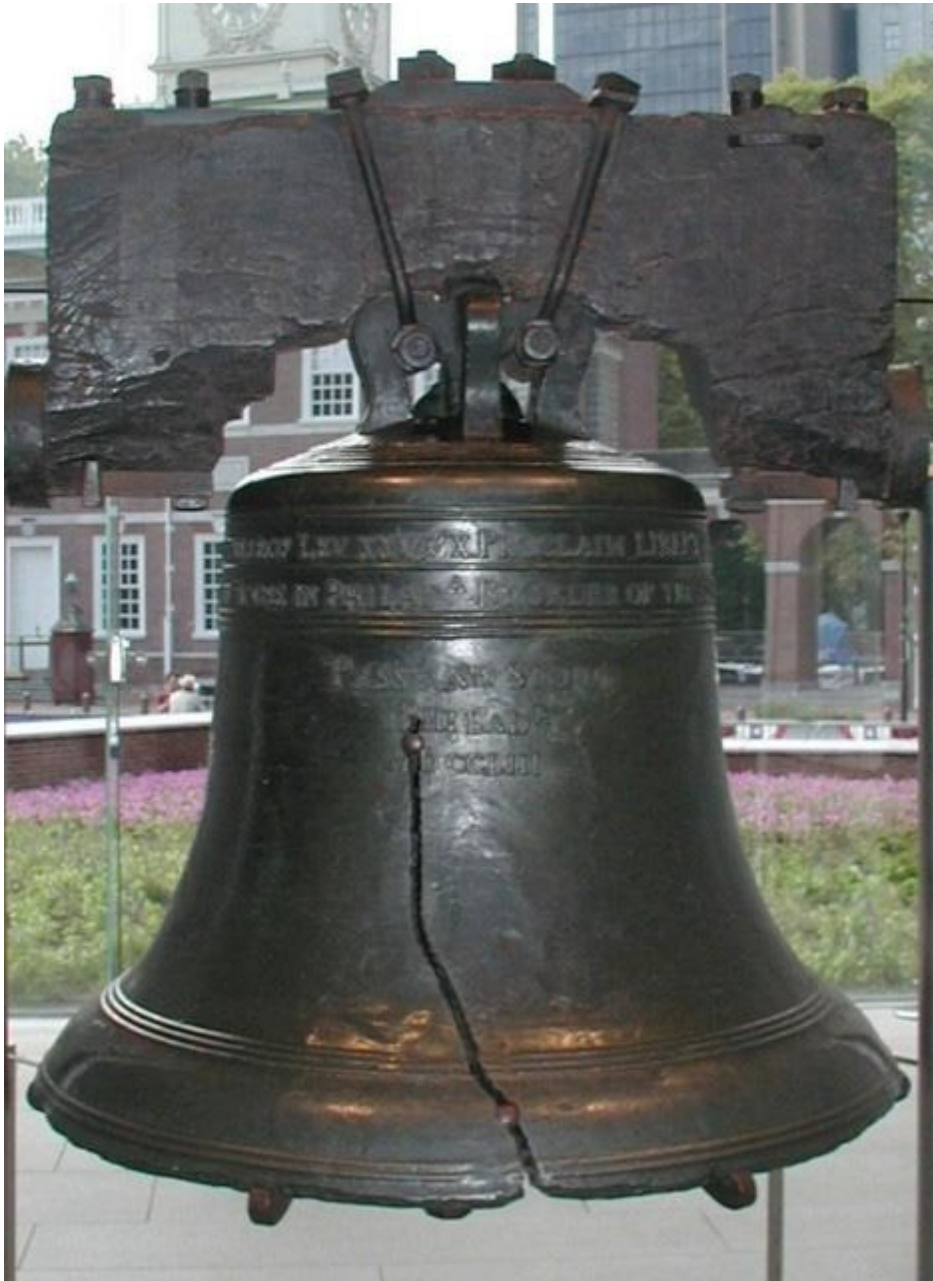

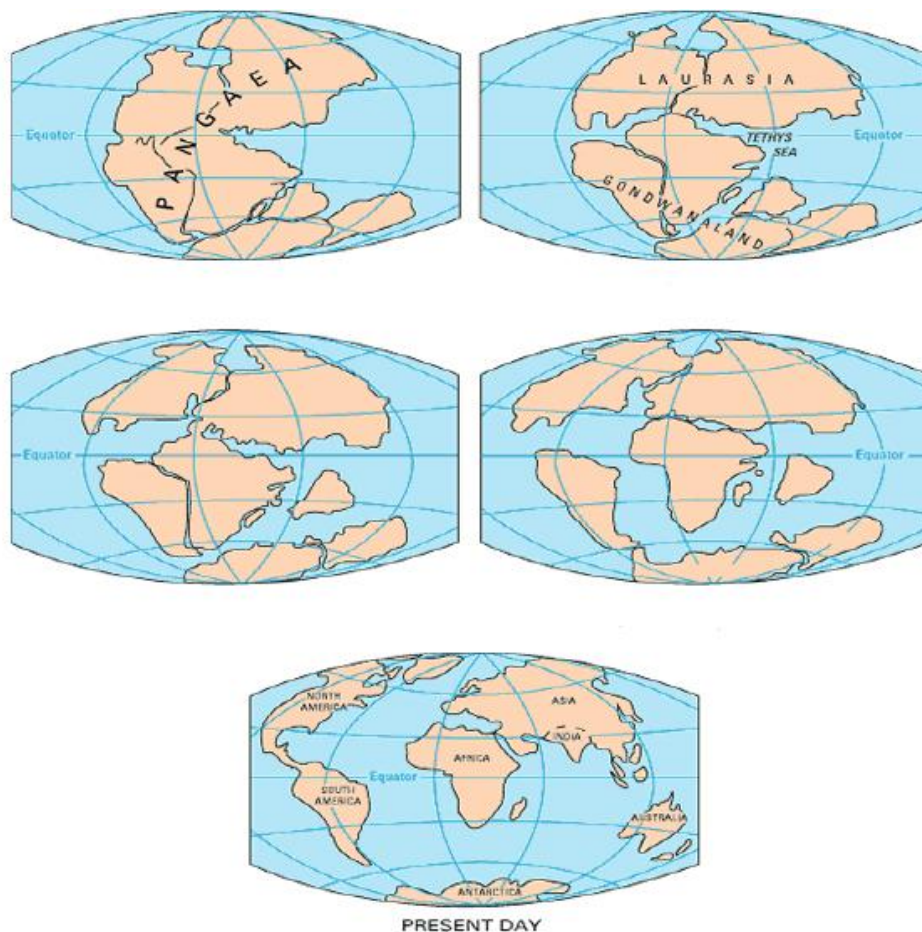
This is in reference to you. Time to wake up and take back what's yours!

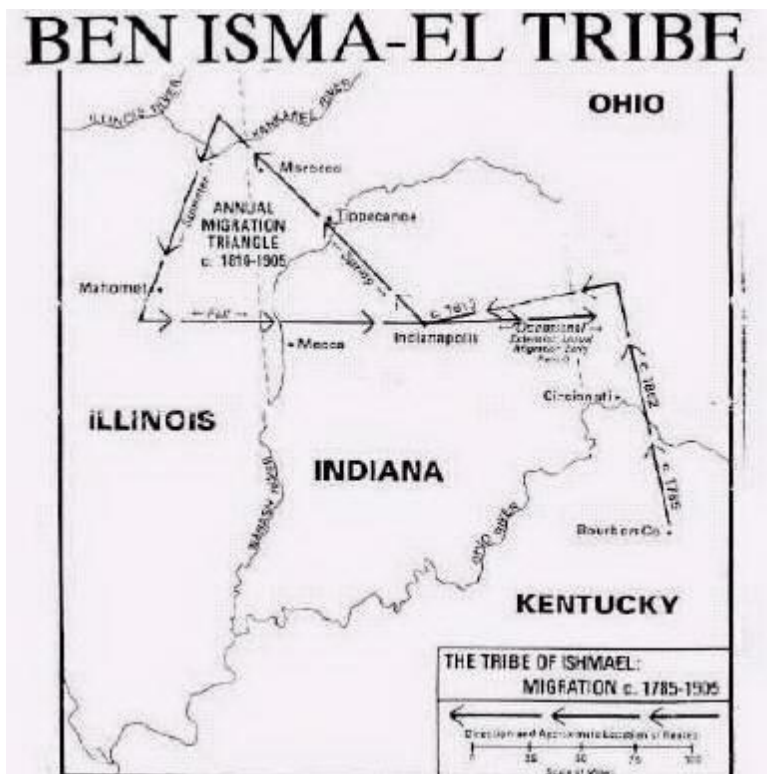


The Etow Ah Mounds in Northern Georgia, U.S.A.

It is often not talked about, but the Moors had enslaved the Europeans before they enslaved so called blacks. Their women sold like commodities into the Harems and concubines of wealthy moors. This is the reason why the Moorish Noble were, for the most part bleached out, and became known as “Twany-Moors”, Turks and Arabs, which are no more than “Fixed Mulatto Races” this also is the reason for the Moors in the Coats of Arms of Noble European Families.

The so called “Black Nobility” of Europe, and the Bilderberger Group. The European Nations paid tribute to the Moors well into the eighteenth century. In the book, “United States and Barbary Powers” the English, French, Dutch, Danes and Swedes, and I may say all Nations are tributary to them.” David Macritchie in the book, “Ancient and Modern Britons” says that the word “Blackmail” is the result of this tribute paid to the “Black Army”, or “Black Oppressors” as the English referred to them. the Moors had control of the Atlantic and Mediterranean. This is why the Marines sing of defeating the Moors “From the Halls of Montezuma (Mexico) to the shores of Tripoli”, confirming in song the extent of the Moorish Empire of Dominions of Amexem, or Atlantis. Below is the first page of the Moroccan Treaty of 1787. It should sldo be noted that Shakespeare’s most famous Moor, Othello, is also described as a Black African. Thomas Jefferson and Benjamin Franklin worked closely with the Moors in the continental Congress to secure this treaty. In the bevans collection there are over two hundred letters to the Bey of Morocco from the continental congress. There were many Moors in

the Conitnental Congress working with the European Masons Originally taught by Moors, to form a “Novus Ordo Seclorum” [New Secular Order of the Ages”, “E Pluribus Unum” out of many peoples and Nations, One]. The Moroccan Trety is very powerful because according to the Constitution, Treaties are the “Law of the Land”.

This treaty specifically deals with Moors. The question then may arise, “How do we know that the treaty says Moors; that so-called “Black” people of that time are being referred to?” The Moors were considered citizens or part of “We the People” who ratified the Constitution. It says; “Thus an act was passed in Massachusetts on the 6th of March, 1788, forbidding any Negro not a subject of the Empire of Morocco, or a citizen of the United States, from tarrying in the commonwealth.” This for one shows that those who were referred to as “Negroes” were actually Moors and that they were on the same footing or status as “State citizens”. Those who remembered that they were Moors, used the Moroccan Treaty of 1787 to secure their rights on the same footing as the state citizens without otherwise being obligated members of their “Social Equality”. While those who were brainwashed into believing they were “Negroes” descendants of Africans brought here by the Europeans were unprotected by the Moroccan Treaty, as well as the Articles of Confederation and the Constitution. This document says “A petition was presented to the house from sundry free Moors, subjects of the Emperor of Morocco; and residents in this state, praying that in case they should commit any fault amenable to be brought to justice, that they as subjects to a Prince (here in North America) in alliance with the United States of America (Via the Moroccan Treaty of 1787), may be tried under the same laws as the citizens of this state would be liable to be tried, and not under the Negro Act, which was received and read. “Thus you had Moors back in 1789 saying what we say now; our Nationality is Moorish and not Negro, Colored Black etc.”

This is from the Moors Sundry Act of 1790:
Free Moors Petition: Ruling

Edward Rutledge reported from the committee referred to the Free Moors petition. The order for immediate consideration of the matter was read and agreed to as follows: "They have Considered the same and are of opinion that no Law of this State can in its Construction or Operation apply to them, and that persons who were Subjects of the Emperor of Morocco being Free in this State are not triable by the Law for the better Ordering and Governing of Negroes and other Slaves."

TREATY

[TRANSLATION]

To all Persons to whom these Presents shall come or be made known—

Whereas the United States of America in Congress assembled by their Commission bearing date the twentieth day of May One thousand Seven hundred and Eighty four thought proper to constitute John Adams, Benjamin Franklin and Thomas Jefferson their Ministers Plenipotentiary, giving to them or a Majority of them full Powers to confer, treat & negotiate with the Ambassador, Minister or Commissioner of His Majesty the Emperor of Morocco concerning a Treaty of Amity and Commerce, to make & receive propositions for such Treaty and to conclude and sign the same, transmitting it to the United States in Congress assembled for their final Ratification, And by one other Commission bearing date the Eleventh day of March One thousand Seven hundred & Eighty five did further empower the said Min-

isters Plenipotentiary or a majority of them, by writing under their hands and Seals to appoint such Agent in the said Business as they might think proper with Authority under the directions and Instructions of the said Ministers to commence & prosecute the said Negotiations & Conferences for the said Treaty provided that the said Treaty should be signed by the said Ministers: And Whereas, We the said John Adams & Thomas Jefferson two of the said Ministers Plenipotentiary (the said Benjamin Franklin being absent) by writing under the Hand and Seal of the said John Adams at London October the fifth, One thousand Seven hundred and Eighty five, & of the said Thomas Jefferson at Paris October the Eleventh of the same Year, did appoint Thomas Barclay, Agent in the Business aforesaid, giving him the Powers therein, which by the said second Commission we were authorized to give, and the said Thomas Barclay in pursuance thereof, hath arranged Articles for a Treaty of Amity and Commerce between the United States of America and His Majesty the Emperor of Morocco, which Articles written in the Arabic Language, confirmed by His said Majesty the Emperor of Morocco & sealed with His Royal Seal, being translated into the Language of the said United States of America, together with the Attestations thereto annexed are in the following Words, To Wit.

In the name of Almighty God,

This is a Treaty of Peace and Friendship established between us and the United States of America, which is confirmed, and which we have ordered to be written in this Book and sealed with our Royal Seal at our Court of Morocco on the twenty fifth day of the blessed Month of Shaban, in the Year One thousand two hundred, trusting in God it will remain permanent.

1.

We declare that both Parties have agreed that this Treaty consisting of twenty five Articles shall be inserted in this Book and delivered to the Honourable Thomas Barclay, the Agent of the United States now at our Court, with whose Approbation it has been made and who is duly authorized on their Part, to treat with us concerning all the Matters contained therein.

2.

If either of the Parties shall be at War with any Nation whatever, the other Party shall not take a Commission from the Enemy nor fight under their Colors.

3.

If either of the Parties shall be at War with any Nation whatever and take a Prize belonging to that Nation, and there shall be found on board Subjects or Effects belonging to either of the Parties, the Subjects shall be set at Liberty and the Effects returned to the Owners. And if any Goods belonging to any

The first page of the peace and friendship treaty between Morocco and America

That's right! You are Moors! This is your land! As you can see, these laws are not your laws. They are commercial laws and as long as you call yourselves Blacks or African Americans, you are admitting to being a slave under the 14th amendment of the United States is a corporation. Yes the United States is a Corporation and it is not a country. The date is February 21, 1871 and the forty-first congress is in session. I refer you to the "Acts of the forty-first congress," Section 34, Session III, Chapter 61 and 62. On this date in the history of our nation, congress passed an Act titled: "an act to provide a government for the District of Columbia, which is a ten mile square parcel of land. In essence, this act formed the corporation known as the "United States." Note Capitalization, because is important. This corporation, owned by foreign interests, moved right in and shoved the original "Organic" version of the Constitution into a dusty corner. With the "Act of 1871," our Constitution was defaced in the sense that the title was block capitalized and the word "for" was changed to the word "of" in the title. Did you know that fifty five Moors help put together the Constitution? Yes we are the constructors of this whole land. That is why they had to hire Benjamin Banneker also known as "Ben Bey" to design the layout of Washington D.C. In fact, it is even rumored that Benjamin Franklin did not even exist but the Identity of Benjamin Banneker was assumed by a European to hide the fact that we built this country and its early technology. The Moors had street light in Seville, Spain Four Hundred Years before anyone else!

5. The act of mooring

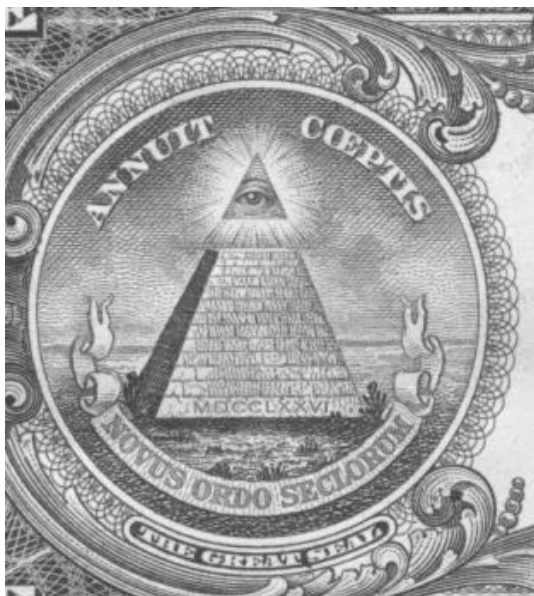
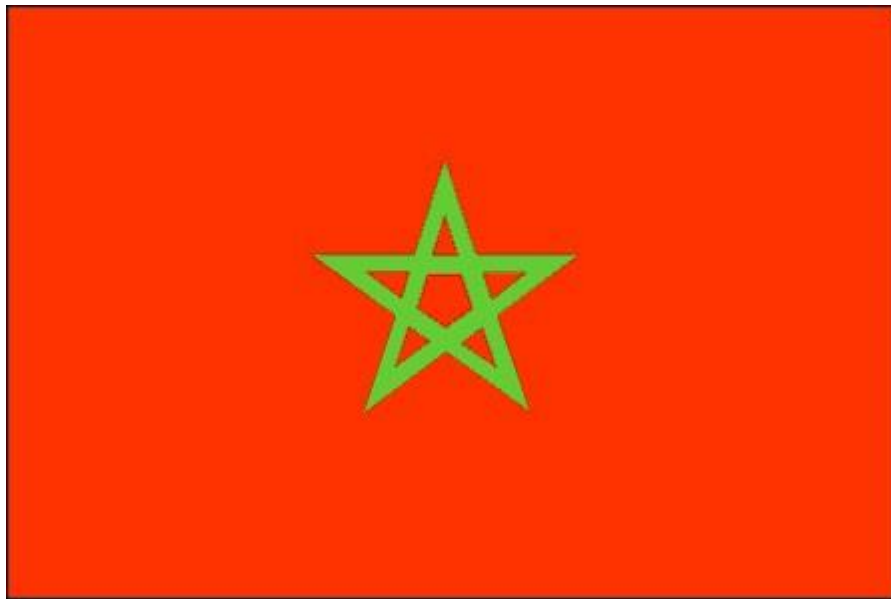
So we can clearly see that Moor has to do with navigating the seas and it is NOT a word that means Black, because if you trace the word Black, in terms of race/nationality, you will find that “The concept of “black” as a metaphor for race was first used at the end of the 17th century when a French doctor named Francois Bernier (1625-1688), an early proponent of scientific racism, divided up humanity based on facial appearance and body type.”

– Wikipedia.com/color/terminology/for/race, You cannot find any traces of our people calling themselves Black before 1500. It is simply not there, because we knew our nationality, Moorish.

How can a person be a color? Black in an adjective, not a noun; you can have a green shoe, but you can’t have a green, that’s impossible. A noun is a person, place or thing. We are people, so we would be defined as a noun. Defining yourself any other way is illogical and foolish. What if someone walked up to you and told you that his Nationality/ Race/ Ethnicity was green, you’d probably laugh. You can be Irish, but you cannot be

green. This is how we act when we call ourselves Black. We also learn in elementary school about colors. We learn that black is a single color and black does not come in different shades, so how can someone be light skinned black, it's just madness. How can someone be light skinned black??? You can be a light skinned Moor or Asiatic, but not Black. This is basic childhood information and understanding, nothing advanced.

Now that we understand that Moor does not mean black, and that we did not call ourselves black before 1500, let's talk about Nationality and why it is so important. Nationality refers to a Nation of People, so when you have a Nationality refers to a certain Nation. This is why if a Chinese person comes to America and commits murder, the United States Government will look to the Nation of China for answers. When you have a nation, you can get reparations, sign treaties, and go to war with other nations. Why did the Jews and Japanese both get reparations for their tragedies? (Since 1953; west Germany has paid out more than \$35 billion in reparations to the Zionist State and to millions of individual Victims of National Socialism) why did we not get any for slavery??? Well, it's fairly simple; we did not have a nation. Israel has a flag, Japan has a flag, but do black people have a flag??? No, because there is no nation behind them. Here is the Moorish Flag. It is a Red Flag with a five pointed Green star in the center; the 5 points represent Love, Truth, Peace, Freedom, and Justice. A nickname for our flag was The Cherry Tree, because of its red and green color. So now you understand why they tell us the story about George Washington chopping down the Cherry Tree.



Our Seal is the Great Seal, which we find on the back of the dollar bill; however the original Great Seal had the capstone attached to the pyramid. The detached capstone represents us straying from our ways and being stripped of our teachings. In other words, debasing ourselves from God/Allah/ANU/The Most High or whatever you choose to call god

Notice that it says The Great Seal under this one and not the Eagle, which represents the European. Also note that whenever government officials speak, they never have this Seal behind them, why? Because it is ours, it is always the Eagle seal, which is theirs.

If another country wanted to help out all of the "Black" people in America, would we even have the power to sign a treaty??? NO.

So what happens if you don't know/don't have your Nationality? You become Stateless. Stateless means you lack citizenship/nationality, which in turn makes you a Refugee. Refugees in turn often have to seek asylum, which means a place where they will not be persecuted because of their status as a refugee. In the US, we call these people asylees. So, a particular Nation is NOT required to give rights to anyone without a Nationality.

Why do you think even after the 15th Amendment, the Black people were still marching for voting rights in the 1960's? If they were truly citizens and had a nationality, there would have been no problem. And if you think that the Voting Rights Act of 1964 gave Blacks the right to vote, think again. Congress keeps extending the Act for however long they feel. Bush just extended it for 25 years in 2006. So this means, it's not a right, but a privilege that Congress is giving Blacks. What if Congress decides not to extend it anymore? Now think about this, if they can sign such a thing into law that easily, then don't you think that with a few signatures they could make those same votes null and void. Now you may begin to understand how and why those Black votes that would've helped Gore win, were thrown out. Because those people were operating on granted privileges and not using their divine birth rights, their human, not civil rights. How can one have civil rights, but not human rights???

When Hurricane Katrina went down, if you were watching closely, they kept calling the "Blacks" refugees, but they never called the Europeans refugees. This is because they were using lawful terms to describe us, they weren't just being mean. They were also being called Looters, which lawfully is correct; technically, they are only in this country because someone let them. So if they break into a store to try and get food to survive, they are still looting because they do not have citizenship to be here.

Some try and say that the 14th amendment made all of the so called Blacks, Negroes, and African Americans citizens; however we know that Citizens make the amendments, not the other way around. How can your citizenship be based on an amendment that can easily be taken away? Also, that same amendment made Corporations, is able to get equal protection because Corporations got considered as legal "persons". Corporations are fictitious/artificial entities, Hence CORPoration. Corpse: meaning Dead. So how can they be persons and get equal protection? The 14th amendment does NOT make you a citizen. It allows you to get granted privileges such as Voting (when they will let you), and entering into Federal programs such as Social Security (as long as you pay taxes).

Not having Citizenship also makes you a second-class citizen, so those are the effects of not having Citizenship and Nationality.

For more clarification, research the legal definitions of these words, try and get a 3rd or 4th edition Black Law Dictionary. 5TH edition sucks. You want the older ones, because they have the old real definitions, just like if you were doing a research paper about ancient Egypt, you would want the oldest sources possible.

Also, look up Jus Soli, and Jus Sanguinis. These are the ways that one has to prove his or her Nationality.

These terms will help you understand things more clearly.

Ok, now time for some of the more raw mind blowing history, to show that we are Moors, and that Moors are native/indigenous to the entire planet, not just Africa.

Moors have been in America for ages untold. When Christopher Columbus (Christobal Colon) got to the Americas, he met Moors; he says it in his diaries. But you never learned about it in school. Look at the first page of a book called Ancient America by Johnathan Norton Leonard and it will say that Columbus saw Moorish women when he got here.

They taught you in their public, private fool system that Christobal-Colon [Christopher Columbus], a said Jew discovered the so called Americas. Obviously, this is not so. 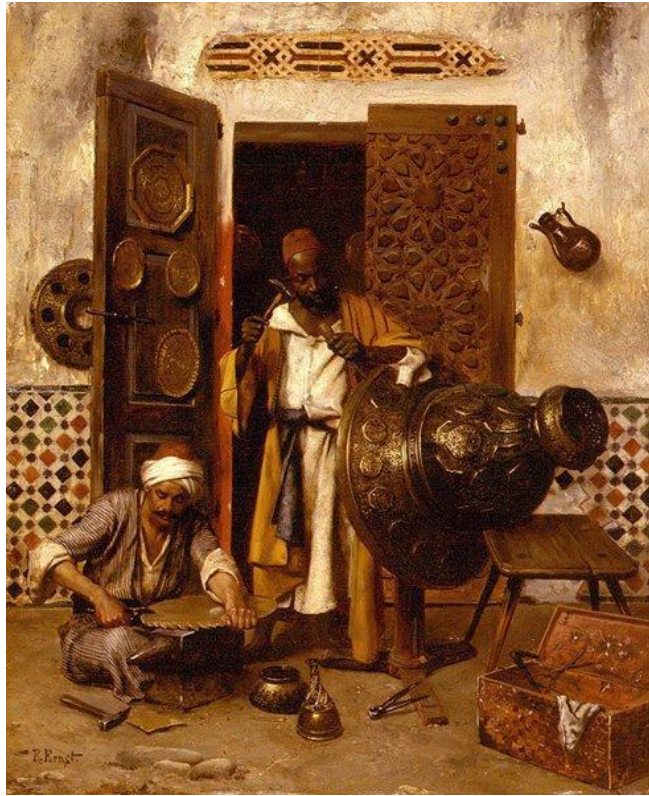

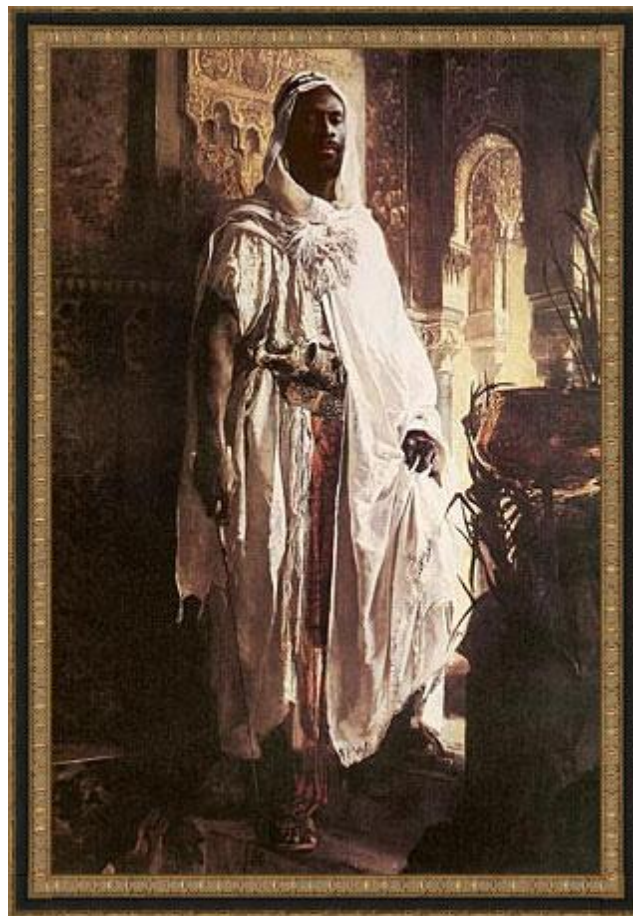

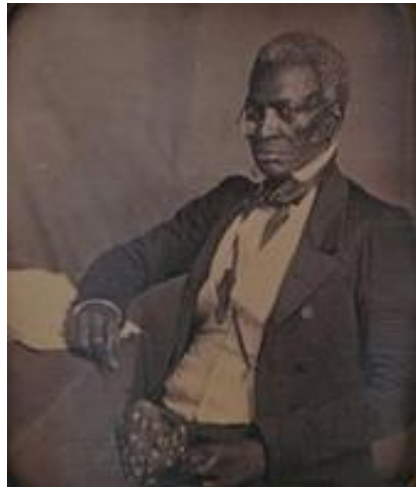

INFINITY LESSON TWO: THE MASONS AND THE MOORS

BY MEHMET SABEHEDDIN

The origins of Freemasonry – **as would be expected of such a “venerable secret society”** – are shrouded in myth, legend and almost impenetrable obscurity. Since at least the late 18th century Masonic writers have sought to establish a link between the Knights Templar and the Freemasons. Freemasonic lore and symbols have been traced to ancient Egypt and Phoenicia. Yet, despite all the books and articles exploring Freemasonry published over the last hundred years, there is one area that has not received **attention. It concerns Freemasonry’s debt to Islamic mysticism and a shadowy tradition connecting the Masons with the Moors of North Africa.**

Moorish Science

The involvement of Freemasons in the establishment of the United States of America is well documented. In fact Masons featured so prominently in drafting the American Declaration of Independence that many people believed it a thoroughly ‘Masonic project’. Not only George Washington but also the US founding fathers Benjamin Franklin and Thomas Jefferson were high-degree Masons. Masonry had a profound influence on the formation of American society, but there was also another secret power which has gone completely unnoticed.

The Kingdom of Morocco under the leadership of Sidi Mohammed Ben Abdullah, known as King Mohammed III, was the first country in the world to recognize the United States of America as an independent nation in 1777. This historic act by the North African Muslim kingdom highlights the relationship then existing between America’s Masonic leaders and the Moors. Before exploring this strange connection further we need to understand the part played by the Moors in the transmission of knowledge to Europe.

Moor is the classical name in Europe of the Muslim people of North Africa. In Spain, where Muslims ruled for over five hundred years, Arabs are still called *Moros*. The term “Moor” came to be synonymous with “Muslim” in many contexts, for example the Muslim communities in the Philippines are known to this day as *Moros*. The Supreme Wisdom of the Moors, much of it derived from ancient Egypt, has come to be known as “Moorish Science”.

The Moors provided the vital link between ancient and modern civilization. The light of knowledge which illuminated the Moorish lands of Spain and Sicily was instrumental in dispelling the gloom of ignorance that enveloped mediaeval Europe.

“It was under the influence of Arabian and Moorish revival of culture,” writes Robert Briffault in *The Making of Humanity*, “and not in the 15th century, that the real renaissance took place. Spain and not Italy, was the cradle of the rebirth of Europe. After sinking lower and lower in barbarism, it had reached the darkest depths of ignorance and degradation when the cities of the Saracenic world Baghdad, Cairo, Cordova, Toledo, were growing centres of civilization and intellectual activity. It was there that the new life arose which was to grow into a new phase of human evolution. From the time when the influence of their culture made itself felt, began the stirring of a new life.”

The Orientalist Stanley Lane-Poole acknowledged the great impact Moorish civilization had on Europe when he wrote:

For nearly eight centuries under her Muslim rulers Spain set to all Europe a shining example of a civilized and enlightened state. Art, literature and science prospered as they then prospered nowhere else in Europe. Students flocked from France and Germany and England to drink from the fountains of learning which flowed only in the cities of the Moors. The surgeons and doctors of Andalusia were in the vanguard of science; women were encouraged to devote themselves to serious study, and a lady doctor was not unknown among the people of Cordova.¹

The 19th century French writer on the esoteric sciences, Gerard Encausse, known as “Papus”, noted how “the Gnostic sects, the Arabs, Alchemists, Templars” form a chain transmitting ancient wisdom to the West. This explains why within the Ritual of Freemasonry there is the admission “we came from the East and proceeded to the West.” A Masonic author Bernard H. Springett says:

The plain fact that much of what we now look upon almost entirely as Freemasonry has been practiced as part and parcel of the religions of the Middle East for many thousands of years, lies open for anyone who cares to stop and read, instead of running by. But it is frequently and scornfully rejected by the average Masonic student...²

So we find that just as Europe borrowed considerably from the learning of the Moors, European Freemasonry took its “secret wisdom” from the Muslim East.

With the end of Moorish rule in Spain, the Europeans began to colonize Africa, Asia and the Americas. In time European Christians conquered Muslim territories and the great debt Western civilization owed to the Moors was quickly forgotten. By the 18th century European Christians saw themselves as the predestined rulers of the world with a divine mission to “civilize” the heathen. Western historians conveniently ignored the immense contribution of the brilliant and energetic Moorish civilization in delivering Europe from mediaeval barbarism. We can only conclude this is a result of the pride and presumption of Westerners, which prevent them from recognizing the truth or importance of their debts to the East.

Seekers of Truth

The founders of the American republic, as high-degree Freemasons, were aware of the importance of Moorish wisdom and culture to the birth of Western civilization. This may explain why Morocco was the first nation in history to recognize the United States, and what’s really behind the story of George Washington being presented with a Moorish flag. Some researchers believe this flag consisted of a red background with a green five-pointed star in the centre of it. The star or pentagram, which the Moors called the Seal of Sulaiyman and coloured green to honour Islam, also figures prominently in Masonic art and architecture. The layout of the city of Washington D.C. – designed by Freemasons – incorporates the pentagram.

When Freemasons travelling in the Moorish lands encountered Sufis, the mystics of Islam, they soon recognized a common bond. “Sufi-ism,” said Sir Richard Burton, was “the Eastern parent of Freemasonry.” John Porter Brown, an American diplomat in Turkey in the mid 1800s, was a Freemason who wrote sympathetically of the Sufi path. In *The Darvishes*, he admits finding it “rather strange that the Dervishes of the Bektashi Order consider themselves quite the same as the Freemasons, and are disposed to fraternize with them.” Brown commented how in Turkey Freemasonry had come to be generally regarded as “atheism of the most condemnable character.” A position not unlike the one held by Papus, the celebrated French occultist and Gnostic bishop, who tried to counter the Masonic lodges which, he believed, were in the service of British imperialism and the international financial syndicates. Papus also viewed Freemasonry as a diabolical perversion of the ancient secret tradition and atheistic at heart.

When Madame Blavatsky (1831-1891) set out in search of hidden wisdom it was to the Moorish land of Egypt that she journeyed. Blavatsky claimed to be a disciple of the Masters Morya and Koot Hoomi. The researcher K. Paul Johnson convincingly shows her tales of the “Masters” to be modeled on real people, many

genuine occult adepts. Prominent among them Jamal ad-Din al-Afghani, a Sufi scholar, tireless political intriguer, and the leader of radical movements throughout the Muslim world, whose travels enigmatically paralleled those of Madame Blavatsky for more than thirty years. Best remembered for co-founding the Theosophical Society and helping to popularize Buddhism and Hinduism in the West, Blavatsky also proudly wrote of “living with the whirling dervishes, with the Druze of Mount Lebanon, with the Bedouin Arabs and the marabouts of Damascus.”

Madame Blavatsky’s “Masters” are very close to the Sufi tradition of *Khwajagan* (Persian: “Masters”). Ernest Scott states “the Khwajagan teachers are entirely corporeal and literal, having been physically located in the Hindu Kush area since the 10th century. The Hindu Kush range is in Afghanistan: geographically, it forms the Western extreme of the Himalayas.”³ Scott quotes from a paper by a Turkish writer who describes how members of the Khwajagan:

...intervene from time to time in human affairs. They do this, not as leaders or teachers of mankind, but unobtrusively by introducing certain ideas and techniques. This intervention works in such a way as to rectify deviations from the predestined course of human history. This inner circle, it is claimed, concentrates its activities in those areas and at those times when the situation is critical for mankind.”⁴

Certainly Madame Blavatsky’s teacher Jamal ad-Din al-Afghani, who was raised in Afghanistan, fits the description of a Master Adept. His life is described as a mysterious odyssey that led through lands as far apart as India and America. Received by heads of state in Cairo and Istanbul, he moved in both underground radical circles and the highest centres of power in European and Oriental capitals.

The idea of living ‘spiritual guides’ or masters is central to Sufism. In the words of Sir John Glubb Pasha: “Sufism cannot be defined in words, nor can it be comprehended by the human intellect. It can only be imperceptibly ‘caught’ or imbibed by association with a Sufi master.” The Sufi master is revered by his disciples for being in contact with a level of higher consciousness, his mission on Earth directed by higher powers. Studying the lives of some of the greatest Sufi masters we often find them to be wandering holy men (& women) whose actions are usually misunderstood by orthodox believers. The shrines of Sufi masters are centres of trance dancing, exorcism, and miraculous healings.

The Sufi tradition is integral to Moorish Science.

Sufi masters are also renowned for communicating with their followers through dreams. There are numerous stories of Sufi saints appearing in a disciple’s dreams and using telepathy to direct followers to undertake a special mission.

Mission to America

A few years after Madame Blavatsky founded the Theosophical Society in New York in 1875, the Master Adept Jamal ad-Din al-Afghani turned up in America around 1882. Two Americans of African descent, who are rumoured to have studied under al-Afghani, were the parents of the man who would one day establish Moorish Science in the United States.

Noble Drew Ali (born Timothy Drew) early in the 20th century took a job as a merchant seaman and found himself in Egypt. According to one legend, Noble Drew Ali made a pilgrimage to North Africa where he studied with Moorish scholars and received a mandate from the king of Morocco to instruct Americans of African descent in Islam. His association with the ruler of Morocco is significant when we recall the historic relationship between this Moorish country and the early United States.

At the Pyramid of Cheops his followers believe he received initiation and took the Muslim name Sharif [Noble] Abdul Ali; in America he would be known as Noble Drew Ali. On his return to the United States in 1913 he had a dream in which he was ordered to found a movement “to uplift fallen humanity by returning the nationality, divine creed and culture to persons of Moorish descent in the Western Hemisphere.” He organized the Moorish Science Temple along lines similar to Masonic lodges, with local temple branches and “Adept Chambers” teaching the esoteric wisdom derived from the secret circle of Eastern Sages, the Master Adepts of Moorish Science.

Noble Drew Ali is said to have made a historic visit to Washington, D.C. in order to reclaim the Moorish flag and obtain official recognition to call his people to their true faith, “Al Islam”. The US president, believing that African Americans would not embrace Islam, gave Noble Drew Ali full authority to teach Moorish Science in America.

By the end of the 1920s, membership in the Moorish Science Temple had grown substantially. With increasing numbers of African Americans rallying behind Noble Drew Ali the Moorish movement soon came under the scrutiny of the FBI. In 1929 several Moors, including Noble Drew Ali, were detained for questioning by the Chicago police. Released from custody, Noble Drew Ali fell ill and never recovered. Many Moors suspected his death the result of a severe police beating.

Following the inexplicable ‘death’ of Noble Drew Ali, the Moorish Science Temple continued and gave rise to unique Islamic groups among the African American community. Much of the known history of Moorish Science in North America is extremely complex and obscure.

By the 1950s some white American poets and jazz musicians came into contact with Moorish Science. The North African cities of Tangiers and Marrakech held a magic attraction for the leaders of America’s counterculture, with writers like William S. Burroughs spending years living in the Moorish lands. The Moorish Orthodox Church of America was formed by white Americans who held Moorish Science passports and had ties with certain “Wandering Bishops” of the Old Catholic and Eastern Orthodox churches.

Joseph Matheny, the American author and media theorist, first encountered Moorish Science when he was researching time travel and quantum consciousness. In his book *Ong’s Hat The Beginning*, the Moorish Orthodox Church is called “one of the most secretive and mysterious religious organizations ever known to man” and:

a revolutionary and heretical sect of Islam that carries on an ancient tradition which sought to counterbalance the forces of orthodox Islam. Despite the controversial and dubious nature of the MOC, part of their tradition has been to serve as the torch bearers of freedom against the tyrannical and repressive aspects of the Earth’s patriarchal power structure as our planetary consciousness shifts to the Age of Aquarius and sets its site on unlimited freedom and the expression of life in all of its true wonder and beauty.

Years before the “War on Terror” and Bush’s invasion of Afghanistan and Iraq, this writer attended a lecture organized by people associated with the Moorish Orthodox Church. The speaker, a Moorish Sheik returned from a long sojourn in the East, claimed Freemasonry is built on a twisting of the truth of Moorish Science. It is the secret power behind the West based on the Supreme Wisdom derived from esoteric Islam. The European colonizers usurped the knowledge of the Moors and created a nefarious system of control that blinds man to his true identity. Freemasonry was identified as a chief player in the world “Babylonian” system, the mastermind of the institutions of indoctrination that prevent the full knowledge of the True God to be known. Moorish Science is the effective counter to the Freemasonic imposters and a force for Truth, Love, Peace, Freedom and Justice. The Sheik also revealed how Afghanistan and Iraq figure in sacred geography and numerology, and mentioned a secret war between the Anglo-American and Asiatic powers.

Is there a struggle between occult brotherhoods to influence human destiny? Are the dramatic events taking place in the world, from the continuing strife in Palestine, Iraq and Afghanistan, to the rivalry between the forces of Atlanticism (Britain and the USA) and Eurasia (Russia and China), just surface manifestations of a deeper conflict? Certainly the strange saga of Moorish Science and the Moorish Orthodox Church adds weight to the observation made by one of the 20th century's most controversial mystics:

...There is a history behind our so-called history that you cannot even conceive of. History has a deeper base. The periphery that we know as history is not the reality. Behind our so-called history continues another history, a deeper one about which we know nothing.⁵

It has been said, that not even the Judges in many of our courts, can understand the second Constitution under which Washington was selected President. Therefore, I will make a humble effort to write a brief university outline in grammar school language, to enable **EVERY-ONE** to fully comprehend some of the most astounding, inspiring and fascinating truths ever brought to the attention of the world's **THINKING PEOPLES!**

"**YE SHALL SEEK THE TRUTH AND THE TRUTH SHALL SET YE FREE**" is as sound advice as when uttered by the lowly Nazarene. I quote it with a view to enthusing our young people—to restore in them "The Spirit of '76" to enable us to return our sacred land into the harbor of **UNSELFISH PURPOSE FOR THE COMMON GOOD**, and forever out of the hands of crooked officials, crooked political parties, hi-jackers, kidnappers, bootleggers, and men whose only "God" is Wall Street and the crooked stock market!

I realize that I am very much alone in the effort I am about to make for truth in United States history. I know that many people would like to knock my head off, but I very respectfully ask for your indulgence until you have read my case—one of the greatest ever put before the thinking people of this world for a verdict.

One can never thoroughly appreciate the American Revolution or the war for the Union in 1861-1865, without first understanding the "Nostradamusian Theory." It was advanced by Michael de Nostradamus, Born in St. Remy, France, in 1503, died July 2, 1566. The German people a few years ago in a popular newspaper contest, as to who was the greatest man in history (not religion) voted Nostradamus, or Notre Dame, the Super-Man of all history, for the books he wrote on the world's war four hundred years in advance. When the German's vote that a French man was the super-man it must be so because the Germans have always claimed to be the Super-men.

Nostradamus wrote of the American Revolution in 1555. The explications were printed in all languages and sent in **Book Form**, all over the world two hundred years before Geo. Washington was born. He also wrote complete information about Napoleon the Great without a mistake and sent it all over the world 229 years before Napolian's own mother saw him. The Explications in Book form Covering 191 Pages.

In 1781, when that which he had written about the Revolution in America had come true, with the surrender of Genneral Cornwallis at Yorktown, Oct. 19th, 1781, a bull was issued from Rome against his books and they were ordered burned. The United States Bible is another book that should be read. It was written by Thomas Jefferson and ordered printed by a concurrent resolution of the Congress and Senate of the United States and paid for out of the treasury of the U. S. A. It is based absolutely upon the Sermon on the Mount and is in Greek, Latin, French and English. Jefferson took up the study of the Hebrew language to enable him to read the original Hebrew manuscripts.

Every boy in school should be compelled to know that the "**Articles of Confederation**" was the first constitution of the United States of America.

In the revolutionary days they burned tallow and wax candles, but did the bringing into the world of the electric light prove that candles were not the first in our system of lighting?

What I am trying to prove beyond any doubt is, that the great United States won the Revolution, and all the liberty and greatness that we enjoy today, in spite of, and without any assistance of any kind, in any way, from the constitution under which Washington was chosen Preesident, and had it not been for the

marvelous success of the United States of America in advance of 1789, there never would have been any need for a constitution such as we live under today. Let all people who think themselves smart laugh that off. Laugh at the great work done under the first constitution, known as the "Articles of Confederation," and then please show me one thing done better in the second constitution under which we live. No real American will laugh at the times, and the deeds of our forefathers, done years before the present constitution was ever dreamed of. We would laugh at men and women today if they walked down Broadway dressed in the clothes of revolutionary days but laughing would not disprove one thing.

UNITED STATES HISTORY

The U. S. A. made the Constitution—the Constitution did not make the United States of America. Remember that.

To begin the study of the basic points in the history of the United States of America, it is absolutely necessary, before we attempt to write or argue, even in very simple form, to get thoroughly into our minds first, that there are several fundamental, basic and very important facts to get clear, and understandable, before we can claim any authority (in fact), to write on the subject if we are honest; because without these very vital facts deeply set in our minds, we will start off wrong, and then find ourselves engulfed in a tremendous and destructive whirlpool of misunderstanding and worthless conclusions.

The first and most important fact that we must get deep down in our mind is, that there was a "UNION", before there were any States. Secondly—the UNION has never changed or ceased to exist. Thirdly—that the only change in the UNION was evolutionary; upward and onward for better in every step, until we find, first eighteen states, and then on up to forty-eight. An expanding Union or Nation, the first ever visualized by the human family, and with the damirction of all the civilized people on earth. Each State with a separate constitution, and out of the thirteen original States, evolved one great government over all. By this you can see, that constitutions can be changed for better at most any time, but you can not change the name of the "Union" under any circumstances; hence the motto "E PLURIBUS UNUM," in Latin

meaning, "out of many, one," or "one out of many." In our case it means that out of many governments among the many states we finally got one.

It was agreed and arranged by the great minds in our early history, that the "UNION" must forever be "perpetual", but constitutions are not. You can change a constitution one hundred times if necessary, but only if it is to give the people more liberty, freedom and happiness; but you can never change the UNION except to expand by admitting more States into the UNION. Our present constitution has been amended over twenty times to try and get it right and it is not right yet, and never will be perfect. When a thing is not amendable to improvement, it dies because of its perfection. On and upward is the law of evolution. So we can plainly see that the first Constitution of the United States known as the "**Articles of Confederation**," was no more defective than our present Constitution under which George Washington was elected President. The change from one to the other was simply evolutionary.

What legal rights had our people to the land called the original thirteen States, until the people, under Gen. George Washington, fought the war for the revolution and conquered the British Army at Yorktown, Oct. 19th, 1781, and forced an unconditional surrender to the American people of everything the British King owned in this country, from the Commander of the British Army, Gen. Cornwallis. All the rights of the American people were secured on Oct. 19th, 1781.

One must keep this important date in mind at all times, as a guide first, then next look at March 4th, 1789, the date upon which the present constitution was adopted, and the one under which Washington was chosen President of the United States, and inaugurated on April 30th, of that year. Any person unless dumb and blind, can see a great gap of nearly nine years, of strenuous, exciting and important activity, with an increase of over one million people in our country.

One can very plainly see that Washington was made Commander on the American Army in 1775, before the "**Declaration of Independence**" was ordered signed by our forefathers on July 4th, 1776, and fifteen long years before the present constitution.

The long, long years between the dates above can be seen very distinctly, with suffering, fighting and starvation before we won our independence. What had the constitution to do with the history of these frightful years? Nothing.

"OUR FIRST PRESIDENT"—PROVEN FOR THE FIRST TIME

"THE GREAT SEAL" of the United States of America is the only way to prove conclusively who our first President was and after many years of technical research in history, I am now able to place before unbiased people, the absolute proof.

Other authors of our time have pointed out who the first President of the U. S. A. was, but every one of them were unable to prove it to millions of waiting and anxious people seeking the truth on this question. To teach our children deliberate lies in history or in any other way is absolutely criminal and cowardly.

I am the first man in modern times to gather together the documentary evidence, that will be acceptable in any court of equity on earth. Even the courts of China and Japan must accept my proof. There is no appeal from my findings, they are absolutely conclusive and incontestable.

TO PROVE WHO WAS THE FIRST PRESIDENT OF THE U. S. A., it is absolutely necessary to:

First: Go to the Supreme Court of the United States and find the authority of the Presidents, and the "GREAT SEAL" in the year 1803. Thos. Jefferson was President at the time.

Second: Find out who the first President was that used the "GREAT SEAL" quoted by the Supreme Court for the first time. The "SEAL" is the President's kit of tools; weighs 67 lbs., costs \$1,250 and consists of the Base, upright, Crown and Dies. They were used for the first time by John Hanson, the first President of the United States of America on September 16th, 1782; there never was any other seal and there never will be any other. Every President was compelled to use the First President's tools and every President down into the ages will be forced to use the same tools. There will absolutely never be any other.

Third: Now find the first U. S. Government document ever signed by a President of the U. S. A.:—(that is, U. S. Government document number one) with the "GREAT SEAL" affixed to it on the very first occasion that the Seal was ever used. It is U. S. Government Document No. 1.

This document you will find is a COMMISSION, dated September 16, 1782, giving George Washington, Commander of the United States Army, full and absolute authority to exchange the English prisoners of War, taken at Yorktown, October 19th, 1781 and other places, and some seventeen thousand Germans and Hessians besides. Washington had to get authority from his superior, the first President of the U. S. A., John Hanson, before he could make the exchange.

Fourth:—Now, get the resolution passed by the Emergency session of Congress called by Geo. Washington, President, on June 27th, 1789, (George Washington was President just two months.)

Fifth: Now, find Washington's letter dated July 24th, 1789, three months after he was inaugurated President on April 30th, 1789, asking the Secretary of the old Federal Union, Charles Thompson, for the books, papers and the "Great Seal of the Federal Union." Washington was unable to sign any official papers of the U. S. Government because the new or second Constitution had not provided him with tools to work with. The framers of the Constitution knew better.

Sixth: Then find in the Congressional records that on July 24th, the emergency session of Congress called by President Washington for the purpose, created the DEPARTMENT OF STATE and also a Secretary of State, (Thos. Jefferson). Then and there Congress accepted the first Presidents tools ("THE GREAT SEAL") of the old U. S. Government, and first Constitution as the "GREAT SEAL" to be used by the first President, George Washington, under the new, but absolutely the second Constitution. The authority of the First President, JOHN HANSON, under the GREAT SEAL, was the one and only authority and has ruled the United States of America and every President down to this very day. Without the least shadow of a doubt, we find now that the First President that used the "GREAT SEAL", for

the first time, was John Hanson and we thus prove that he was absolutely the first President of the United States of America, and that George Washington did not come upon the scene as President until eight (8) years later in 1789.

THE SUPREME COURT IN 1803

Chief Justice John Marshall in 1803 said; "The signature (of the President) is a warrant upon the Secretary of State to affix the Great Seal to the Commission, and the Great Seal is only to be affixed to an instrument when complete. It attests, by an act supposed to be of public notariety, the verity of the Presidential Signature.

It is never to be affixed till the commission is signed, because the signature which gives force and effect to the commission, is conclusive evidence that the appointment is made.

The appointment being signed, the subsequent duty of the Secretary of State is prescribed by law, and not to be guided by the will of the President. He is to affix the Seal of the United States to the commission and is to record it."



THE FIRST SEAL (1782)

The "Great Seal" was made for John Hanson of the State of Maryland, the first President of the United States. It must be affixed to every U. S. Government document to make the paper legal and complete.

“WHEREAS JUSTICE AND HUMANITY AND THE PRACTICE OF CIVILIZED NATIONS, REQUIRE THAT THE CALAMITIES AND ASPERITIES OF WAR SHOULD AS FAR AS POSSIBLE BE MITIGATED; AND WE BEING DISPOSED FOR THAT BENEVOLENT PURPOSE TO ACCEDE TO A GENERAL CARTEL BETWEEN THE UNITED STATES OF AMERICA AND THE BRITISH NATION, FOR THE EXCHANGE, SUBSISTANCE AND BETTER TREATMENT OF ALL PRISONERS OF WAR: NOW THEREFORE KNOW YE, THAT REPOSING HIGH CONFIDENCE IN THE WISDOM, PRUDENCE AND INTEGRITY OF OUR TRUSTY AND WELL BELOVED GEORGE WASHINGTON, ESQ., OUR COMMANDER-IN-CHIEF OF ALL OUR ARMIES, RAISED AND TO BE RAISED FOR THE DEFENCE OF THE UNITED STATES OF AMERICA, WE HAVE AUTHORIZED AND EMPOWERED, and by these present do authorize and empower, our said Commander-in-Chief, for us and in our name, to negotiate, accede to and establish, in the proper forms and with the usual solemnities, such general cartel between the United States in Congress Assembled, and the King of Great Britain, for the exchange, subsistence and better treatment of all prisoners of war, as well and as naval prisoners; hereby giving and granting to our said Commander--in-Chief full power and authority, ultimately and on all points, to adjust and conclude the principals, terms and conditions of said cartel, and in general to do and perform every matter and thing which shall in any way be necessary for the final and perfect accomplishment thereof. And the better to enable our said Commander-in-Chief to execute the trust reposed in him by these presents, we do hereby further authorize and empower him, from time to time, by commission under his hand and

seal, to nominate and constitute such and so many commissioners as he shall judge necessary, to meet, treat, confess and agree with commissioners to be appointed and completely authorized on the part of the KING of Great Britain, touching the terms, conditions and stipulations, for subsisting, better treating and exchanging of all prisoners of war as aforesaid, as well as for liquidating and settling all accounts and claims whatsoever, respecting the maintenance and subsistence of prisoners of war on either side. We do hereby declare that the engagements concluded upon by your said Commander-in-Chief in the premises, being mutually interchanged with the party contracting on behalf of the crown and nation of Great Britain, shall be binding and conclusive on the UNITED STATES of AMERICA.

"IN TESTIMONY THEREOF WE HAVE CAUSED OUR LETTERS TO BE MADE PATENT, AND THE GREAT SEAL OF THE UNITED STATES OF AMERICA to be thereto affixed.

"Witness his Excellency JOHN HANSON, PRESIDENT OF THE UNITED STATES IN CONGRESS ASSEMBLED, the 16th day of September, in the year of our Lord, one thousand seven hundred and eighty-two, and of our sovereignty and independence the seventh."

**PRESIDENT
GEORGE WASHINGTON
writes
FOR THE "GREAT SEAL"**

On July 24th, 1789, Washington, President for just three months past, wrote to Charles Thompson, Secretary of the Old Federal Union, for "The Great Seal," of the United States as follows:

"You will be pleased, Sir, to deliver the Books, Records and Papers of the late Congress—the Great Seal of the federal Union—and the Seal of the Admiralty, to Mr. Roger Alden, the late Deputy Secretary of Congress, who is requested to take charge of them until further directions shall be given."

This letter and the call for an emergency session of Congress by President Geo. Washington himself, proves conclusively, that

Washington knew absolutely that he was not the first President when he wrote for the books, papers and tools ("The Great Seal") of the first President before he could go on with his work as President.

In the further enactment in the resolution before the emergency session of Congress (drawn by Thos. Jefferson, who was elected first Secretary of State under Washington) I prove that the proposed perfect government under Washington, accepts every condition, law, rule and authority, under the "Great Seal", and the first President of the United States, John Hanson. Here we see without any question the first President under the second Constitution, George Washington, asking for the tools of the first President under our first Constitution before he, Washington, can go to work.

THE CONSTITUTION

In speaking of the Constitution one must first know that our people had other constitutions long before the present one was ever dreamed of.

The previous Constitution led up to the one we now know, (sort of an evolutionary process) and which most people think was the first and only one; but as a matter of fact our people had four and for that reason I have attempted to show this in a very simple way, and in language that the ordinary man or woman can understand. It is often said that many judges of our courts can not understand the "CONSTITUTION."

How can we expect citizens to respect our laws and be good citizens when they can neither read or understand our Constitutions. (Read Abraham Lincoln.)

If you don't like what I write jump on Lincoln. He was a much bigger man than I. When you wish to fight with any one pick out a big man as you will not get any credit for licking a small fellow.

The FIRST CONSTITUTION, or form of government or laws of our people, was enacted through authority granted by the King of England before there were any states (although they had a UNION) on Thursday, October 20th, 1774, under the title, "THE

UNITED COLONIES", and was called the "Articles of Association" (See Abraham Lincoln).

The Second CONSTITUTION was called the DECLARATION OF INDEPENDENCE ordered signed July 4th, 1776, but signed July 8th. This document embodies practically all of the features of the third and fourth constitutions and is the only one that was never changed and can never be changed. It is the TEN COMMANDMENTS OF OUR NATIONAL GOVERNMENT, and if altered in any way, our nation will crumble into dust.

When the Colonies became States each of them adopted separate Constitutions first, and then the UNITED STATES of AMERICA was created, and took its place among the Nations of the world for the first time.

THE THIRD CONSTITUTION was "THE ARTICLES OF CONFEDERATION" and was adopted JULY 8th, 1778, but all the states did not sign, on account of the rebellion, until March 1st, 1781.

Article (No. 1) of this constitution reads: "and the style of this Confederation Shall be, THE UNITED STATES OF AMERICA" and proves without any doubt just when the United States took its place among the Nations of the world for the first time. This is a recorded and historical fact. (see Abraham Lincoln).

The FOURTH,—or present Constitution, was adopted March 4, 1789.

The Declaration of Independence and the Articles of Confederation were not discarded and thrown into a waste basket simply because we were going to try and make. "A More Perfect Union." We did not discard the Articles of Confederation and the Union, because the Union can never be discarded or its name changed under any condition.

You can't take anything away from the Constitution, but you can add to it in the form of an amendment providing it is to give the people more liberty and happiness. Only when an amendment gives the people more liberty and life and happiness is it constitutional. If you take away any liberty it is against the Declaration of the people who are duty bound to disregard it as is being

done with the 18th Amendment. This was the only amendment that ever took away any of the people's liberty and the people are in rebellion, and another American Revolution is on against it.

Seventeen amendments in succession were adopted to give the people more rights and liberty, which was according to the Declaration of Independence and the first Constitution, and then when the whole country was wild over the World War, and millions of our best men were on the battle fields of Europe, desperate enemies of our Declaration had the 18th Amendment put over on our people. The vast majority of our people know that the 18th Amendment has no place in our Constitution and eighty millions of them are in open bloodless revolution against it, and will fight it openly and in defiance until amendments are adopted to restore to the people their rights so criminally stolen from them. The people will always refuse to obey such a law and every day brings more prostitution upon our Christian Churches because they are the tools of, and playing right into the hands of the criminal class in our country.

The very first thing that Congress demanded when the English surrendered at Yorktown was the election of our first President according to the first Constitution, but the country had to wait until the new Congress could meet on November 5th, 1781. The first President so elected was John Hanson, a member of Congress from Maryland, the catholic State. He was elected by a unanimous vote of the thirteen states as every one refused to run against him because of his wonderful work in subduing the rebellion of the twelve states that had withdrawn from the Union, and having the first Constitution of the United States of America adopted: "The Articles of Confederation." The country owed Hanson a tremendous debt for having saved the Union, as Abraham Lincoln did in his day, and they paid their debt with the greatest honor in the gift of the American People, and made him the First President of the United States of America.

There were twelve candidates against Geo. Washington for President and he did not receive a majority. There were no candidates against Hanson, as an honor to him.

All the wonderful ideas of government, every branch as we know them today, the foundations, were all laid under the first

Constitution. Try and find one that was given us under the second constitution under which Geo. Washington was chosen President.

It is admitted by everyone that John Hanson was not elected as Washington was and neither was Jefferson, Lincoln, Wilson, or Franklin D. Roosevelt elected the way Washington was. Changes take place every few years as was done in 1932, when Congress in one way called upon the States to amend the Constitution and change the date of inauguration of the President from March 4th, to Jan. 20th, and do away with the Lame Duck (short session) and Inaugurate the Congressmen on Jan. 5th, instead of Dec. 14th.

The method of electing a president has absolutely nothing to do with who was first President. We must get our historical facts and dates right first, and then stick to facts as we find them.

The name of the UNION, the Great Seal and the Declaration are very much older than the Constitution and are the three and only authorities we can go by. Constitutions will come and go and change and be changed, but they will stand, as they are, forever down into the ages.

On Nov. 5th, 1781, Congress ordered the Great Seal cut at once for the first President of the United States of America. John Hanson. He was first to use it and every President after him has and must use the one and only Seal made for the U. S. A. and there will never be any other. This is an incontestable fact and only in ignorance of these facts will any one ever question them.

To be an 100% American, it is absolutely necessary to first know the four Constitutions of your country to enable you to know where you are at. You must know or you will never understand what your duties are to your country. Without knowing the four Constitutions you are ignorant of your rights and duties as a citizen.

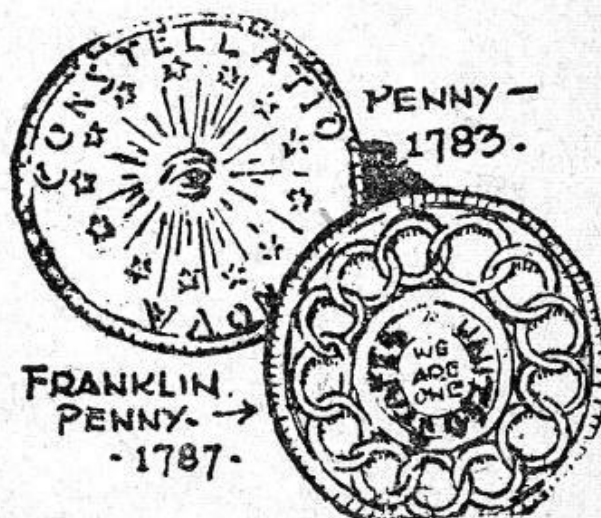

WHAT IS A CONSTITUTION?

The Declaration of Independence is a deed to all that our forefathers took from the Kingdom of Great Britain. It carries the individual signatures of the men delegated to deed it over to the American people, but it needed the "Great Seal" of the U. S. A. to give it authority. The Seal was ordered on the same day the

sacred document was ordered signed, July 4th, 1776, but was really signed July 8th. The Liberty Bell rang on the 8th.

Again on the same historic day, the first Constitution of the U. S. A. was ordered drawn up to go with the Declaration, and Thomas Jefferson, was delegated to write the first Constitution of the U. S. A., known as the "Articles of Confederation". On the same day, July 4th, 1776 he was also ordered by Congress to get out a "Great Seal".

The First Constitution was a guarantee that the blessings in the Declaration of Independence would be carried out as written, to prove to us, that the title to the marvelous gift our forefathers gave us was good, and beyond any question, and it is just as good today if we will only use it. They gave us every thing, and held out nothing for themselves.

Because the American people have been foolish in allowing a lot of political, and financial crooks, and religious fanatics to steal our rights away from us, and rob us besides, does not prove that the fault is in the "Declaration", or in our first Constitution. The fault is absolutely with the American people themselves because of their indifference and a criminal lack of interest.

OUR FOUR CONSTITUTIONS

Nine out of every ten people think, our people had only one Constitution. As a matter of fact they had four. (Read President Lincoln's first inaugural speech).

President Lincoln said in 1861; "The Union is Perpetual, confirmed by the history of the Union itself. The Union is much older than the Constitution. It was formed in fact, by the Articles of Association in 1774. It was matured and continued by the Declaration of Independence in 1776. It was further matured, and the faith of all the thirteen states expressly plighted and engaged that it should be perpetual by the "Articles of Confederation" in 1778, and finally, in 1789 one of the declared objects for ordaining and establishing the constitution, was to form a more perfect Union."

Lincoln did not say to form a new Union, or make a new Union, because he knew, that could never be done under any circum-

stances.

Every reader of this book should have copies of the four constitutions as outlined by Abraham Lincoln, as they are inspiring, fascinating and romantic to the extreme. HAMILTON'S WORK IN THE CONSTITUTION

How the American people ever let Hamilton dominate them in the framing of the constitution after his questionable work in trying to make George Washington King of America, is a thing many people could never understand.

The cardinal reason advanced by him to the people for a more perfect Constitution, was to make a more perfect Union, and a better system of taxation to enable the United States to get the necessary money to carry on a more workable government. This claim was repudiated, and proven to be fictitious by the United States Congress 130 years later in 1909, when Congress called upon the States to amend that part of the Constitution, and go back to the tax system of the first Constitution. In 1913 under Woodrow Wilson the amendment was adopted. This also vindicated Thomas Jefferson for his fight against Hamilton and the banking influence in our government at the time. Jefferson openly charged the Federalist Party with trying to rob the people who fought the war, of their just rights. The Federalists were always bent upon some scheme to take away the governing power from the common people who won the war, and were determined to put the government into the hands of the rich men of the country. The common people were good enough to fight, bleed, cry, freeze, starve and suffer, but were not good enough to run the government. For that reason Jefferson organized the Republican Party to drive Washington's and Hamilton's party into the ditch and keep it there, and he certainly did it in a great style. Jefferson was the first Republican ever elected to public office in the U. S. A., although our people have been educated to believe Lincoln was the first Republican. He was the first Democrat ever elected. Jefferson took his ideas direct from the Republican Revolution in France and brought

over the red, white and blue, (the Republican colors.) and they are the colors of France to this day, and are our national colors.

The amendment to change our systems of taxation, was ratified by forty-two states by Feb. 25, 1913. President Wilson was president at the time. It only took thirty words to go back to the tax system of our first president and constitution. "The Articles of Confederation," from which it had been taken out so deliberately and questionably, nearly 130 years before.

The banking interests are our governments and peoples' absolute enemy as was proven in the great capatilistic system crash in 1931-32. Many intrenched themselves in 1789. People thought it a sin in olden days to call a banker a crook, but today the people are awake and crying out crooks from the house tops. It took a long time for them to wake up to this clever bunch, but 1932 did the trick and opened the peoples' eyes.

THE DIFFERENCE

The only difference in the first constitution of the United States known as the "Articles of Confederation," under which John Hanson was elected President of the "United States of America in 1781, and the more perfect constitution of 1789, under which Geo. Washington was elected President, is that the States delegated to congress under the first constitution the power to rule, govern and make certain laws for the whole nation, but reserved the right to refuse to obey any laws they did not like. Therefore congress could not enforce its will.

Under the intended more perfect Union of 1789, the people delegated to congress the additional power to enforce its laws, and the states had to accept its authority. Congress was simply made master over the states. This caused a great political fight and political parties were born for the first time. George Washington belonged to the Federal or rich man's party, and Thomas Jefferson belonged to the Republican or common people's party. The Federal party was for **Federal Power** over the states, the Republican Party was for state rights against Federal control.

The fight has been raging ever since, and the 18th, Amendment is a continuation of that fight.

Thos. Jefferson's party because its name was too red or Communist and radical changed its name from Republican to "Republican Democratic Party," and then again because its name was too long to the Democratic Party" and it is to this day one of the present dominant political parties, while the party of George Washington, the Federal Party," was driven out of existence by Jefferson and never had enough public confidence to bring it back.

A very good example of the trouble in the power of Congress to rule over the states arose in the dispute between Congress and the States over the division among the States over the land that was taken away from England and now known as Ohio, Indiana, Illinois, Michigan and Wisconsin.

John Hanson's proposition to make five new states out of the land in question was viciously attacked and came very near breaking up the Union for ever.

As the delegates names were called in congress, they voted **NO**, walked out and left the Union. Twelve states withdrew in Rebellion, and the only one that remained in the United States of America, was Maryland, the Roman Catholic States—the lone state that saved the Union.

As the members of congress from each state withdrew from the union and left the halls of Congress, John Hanson called to them and told them he would drive them back into the Union.

Abraham Lincoln had the same kind of a fight as Hanson had exactly; but instead of all but one State leaving the Union against Lincoln as they did against John Hanson, only the Southern states withdrew from the Union, under Lincoln.

The war for the Union of 1861-65 was President Lincoln's method of driving the rebellious States back in the Union; and it cost millions of lives to do it.

In John Hanson's fight it looked as if the United States of America was done for, and done for for good but, thanks to the guiding hand of Providence, John Hanson won his fight, the

fight of all fights for law in the entire history of the world. With the Congress, when the dollar sign came in the door, patriotism jumped out of the window, as is many times the case today.

Abraham Lincoln had at least half of his country with him, and a big army to back him up, while John Hanson stood all alone fighting as no man ever fought before. Can you see him all alone in defence of the whole Congress fighting for what he knew was right. He was fighting for "The Union" against a more powerful enemy than the fight going on, outside, with the English. What England could not do to the American people, the people's own Congress was doing. John Hanson saw the whole situation at a glance and fought to preserve the "Union" as Lincoln did in 1861-65.

While the battle of battles was furious in the halls of Congress, General George Washington and his army were having a fight of their whole existence on the battle fields. Very little success, with no Congress or government to encourage them. The days were very dark indeed for every body; except the General at the head of the Army, fighting for his life, and the Lone Congressman in the halls of Congress, fighting to hold the United States of America from destruction. Two Brave Men: one on the outside and one on the inside, with hearts and minds working exactly alike. What American can ever forget these two great fighters? Only a contemptable cur would try to separate them.

The arrival of the French fleet off the Jersey Coast gave a new hope to George Washington, John Hanson, and the loyal people throughout the country and on the strength of this good news a big sum of money \$147,000. was obtained by Haym Solomon from the Jewish people in Philadelphia to finance the battle of Yorktown which was only a few days off.

One state after another came back into the Union amid great rejoicing when they saw their terrible mistake. When the twelve states had signed over all their rights to all land, in favor of the Federal Government, and signed the first Constitution of the U. S. A. under the name the "Articles of Confederation," John Hanson then signed for the state of Maryland, the last state

to sign, and the United States took its place among the nations of the world officially for the first time, on March 1, 1781.

While the land fight in Congress was on in full force, General Washington was busy staging the battle of Yorktown. There was no Union and no Congress. Therefore the whole fight fell upon the back of John Hanson who had been thoroughly trained, able and aggressive, to fight to a finish, what seemed to every years for his country had taught him much and prepared him body except himself, a hopeless task. Fighting for twenty seven for the greatest legal battle in all history and with what seems years fitted him for the greaest legal battle in all history and with what seems Divine guidance, he won. For his great fight, he was elected he first president of the U.S.A. by a unanimous vote. His enemies became his best friends when they realized that they were wrong and he was right.

In such an impossible fight and against such overwhelming odds, it took a heart of iron to even think of fight, let alone plunging right into it, knowing full well what failure meant.

John Hanson knew the constitution of his country, "The Articles of Confederation," and the "Declaration of Independence" by heart and laid down his life to carry out their Divine ideals and he won. His only argument was, "The Union must be preserved," only five words. One hundred years later Lincoln used the same slogan.

How can really true Americans ever forget Hanson, when they read his fight of all fights. There he stood all alone fighting to preserve the Union; his beloved country, and with congress and nearly every friend against him. There seemed to be no hope for him still he fought on. Can any one calculate the power of such a brain as his? Can you imagine how fast he had to think in that crisis. He must be absolutely right every time he made a move or spoke a word. One mistake and all would be lost and the destiny of a great people cast into the past, and perhaps for all time. But every move he made was perfect. He did not make one error, as if guided by some invisible power, a Super Intelligence.

The attempt to make our first constitution more perfect caused

almost as big a fight as did the fight over the distribution of the land, and some big men like Thos. Jefferson, Patrick Henry, Governor Clinton, of New York, and many others were opposed to it because it gave too much power to the Federal Government. Geo. Washington as President had to adjourn the convention time and time again because he could not get a quorum. It took several years before the convention made any progress on account of the big opposition. The doors of the convention hall were locked for two years.

The convention finally agreed to let the Southern states sell slaves for twenty years, and that was what saved the constitution. It was not the personality and honesty of Washington, and the faith the delegates had in him that saved the day, it was the right given the Southern States to sell slaves that did the trick.

The delegates, suspicious more or less of the money power of the country, had not forgotten how the big bankers had attempted to make Geo. Washington King of America, and were all set to crown him at what was supposed to be a farewell dinner to his generals in New York City, but Washington thank God was a man that could not be bought. How the lowly Nazarene had refused to be crowned a King, Washington learned when a little boy. He never forgot the story, and he followed in the lowly Nazarine's footsteps. Many delegates saw the scheme to steal away the victory from the people won on the battle-fields, by making Washington King. Very few people today really know how near we were to losing everything we had won in The Revolution.

Even after the first Constitution had been improved and was ready to be voted on, many virtues embodied in, and the very life of the "Declaration of Independence," was deliberately left out. Such things as religious liberty, freedom of the press, free speech, and others, were not put into the new Constitution and another revolution was threatened. When this treachery was seen, another fight started hot and heavy. Several states refused to sign, refused to obey the new constitution, threatened to withdraw from the union, and left the convention hall full of fight.

New York, North Carolina and Rhode Island never did go back until more than one year after Geo. Washington was in-

augurated President. These states came back in 1790 and 1791, so you see there was only 10 states that really voted for Washington. How he was elected in a gigantic story too big for an ordinary mind, and not fifty people in the whole U. S. A. know of it.

As soon as the fighting states were on victorious ground, the Convention was forced to put back in the form of ten amendments the things so brutally and criminally taken out of Our First Constitution which latter act caused the dissention. Most all our liberty is in the ten amendments and not in the Constitution as may be seen by the reading.

A GREAT QUESTION

Without the United States, which came first, there never would have been any need of a Constitution.

George H. Ryden Ph. D. Prof. of Historical and Political science of the University of Delaware says; "ever boy in school should know that the "Articles of Confederation" was the first form of government or Constitution of the United States of America."

Every little child does know that Geo. Washington was elected the first President under the Constitution, but every child should know also that the constitution was not the first constitution of the United States of America.

What had the Constitution to do with the war for Independence? Nothing.

What had the Constitution to do with the birth of the American Flag, with its stripes of red and white? It was carried over the seas to every country on earth, even Japan and China years before any one even dreamed of the Constitution.

A successful United States Government was in full force and operating with the respect and admiration of every Christian Nation on earth for years and years before the Constitution was adopted.

The American Revolution was fought and won at Yorktown

Oct. 19, 1781 and the Constitution was not adopted until March 4th, 1789, eight years later.

Don't be silly and think that the United States of America with its marvelous work and government had died and was buried in some historical burial ground. Our great fighters and the signers of the "Declaration of Independence" were very much alive and moving merrily along without any aid or assistance from the Constitution.

The "Declaration of Independence" is our greatest human document. The one that we love; the one that the world loves. It is worshiped in every country on earth on **JULY 4th**, of every year. Don't let any one tell you the Constitution is better; because it is not, and never will be. You can change the constitution at any time but the "Declaration" can never be changed by any moral power. It is the one rock upon which our government and constitution stands. If it fails, everything else will fall and crumble into dust.

What had the constitution to do with the appointment of Washington as commander of the U. S. army, or Paul Jones as commander of the U. S. Navy? Not one thing.

What had the Constitution to do with the treaty signed between the King of England and John Hanson, whereby the United States of America was recognized as a free and independent nation? Absolutely nothing.

What had the Constitution to do with the discharges issued by President John Hanson to Generals Lafayette, Rochambeau and many other foreign generals after the war was over, so they might return to their homes in Europe? What had Gen. Washington to do with it? Nothing that was the President's job.

Was our present Constitution our first or second constitution?

Our first Constitution was ratified March 1-1781.

Our Second Constitution was ratified March 4, 1789.

What one thing did the Constitution have to do with the origin framing, management, government, and success of the U. S. Army

or the victory won in the Revolution, or War for Independence? Not one thing.

What did King Louis XVI, Generals Lafayette, Rochambeau from foreign powers and other sources amounting to over \$157,000,000, to run the Government and pay the cost of the U. S. Army in the field under Gen. George Washington? Who would dare say these loans were not legal?

What had the constitution to do with all the treaties signed with foreign nations throughout the christian world, by which they recognized the United States of America as a free and independent nation? Not one thing. Were these treaties legal, was there lawful authority for signing these treaties? There was and every thing was done without the present Constitution, (No. 2). All was done under Constitution (No. 1)

The ordering out of the U. S. A. of all foreign troops after the Revolution, and the exchange of prisoners of war, was by the authority of the President of the U. S. A., granted to him under the first constitution.

All British and foreign flags were ordered taken down and American flags raised in their place by order of the Pres., John Hanson.

All the British battle flags captured at Yorktown was given to the king of France Louis the XVI., for his marvelous help given the American forces. President John Hanson gave the flags, without any authority from the constitution under which Washington was chosen President. They are valued at \$5,000,000.

Eighteen thousand English, and some seventeen thousand Germans and Hessians, war prisoners, were ordered exchanged, and sent back to their homes in Europe by President John Hanson, through authority given to Gen. Washington on Sept. 16th, 1782, read this commission in this book and be convinced.

What had the Constitution to do with the cash loaned to us and the other foreign generals know about any new Constitution to be adopted eight years after the war was over? Not one thing. They all knew they were fighting under the first Constitution and first President of the United States of America and that was sufficient. They were never interested in any

new constitutions. There is one thing certain and that is these great generals were not fools, even though there may be some people who might think so.

THE WORK OF SUPER-MEN

The government and methods used under the first Constitution of the United States of America seem strange and is said to have been imperfect to those who do not understand the difference in conditions at that time and up to 1789. Our forefathers had just emerged out of a condition equal to slavery, but more brutal. Under English rule, they were compelled to make a super sacrifice to break the chains of serfdom, and they did not dare take any chances in failure. It's all very well to listen to people who think themselves smart, talking today of what they would have done in, (1774 to 1789,) but any one knows perfectly well, that such people never have done anything but talk and criticize every success. Some strange birds can talk, but the poor things do not know what they are talking about. What these people would have done is plain gush; because such minds can not calculate at all in any emergency or a crisis. If they could think, they would find, that the only thing to do in a crisis is to do something. When a ship is sinking, or a house is burning under you, the first thing that comes into your mind, is the thing you would do.

Our patriots got together in fast time at the battle of Concord and the Minute Men's work, to me, was marvelous. No time to talk. Every intelligent person here today, and the great thinkers of the old world at the time, thought the work of the Americans before the present Constitution was adopted, could only be called the work of super-men, who paved the way and made everything safe for the better things that would surely come. My advice is, to not let people hear you criticize the great work done by our forefathers on the way up from 1774 to 1789, because you will only show ignorance and a lack of the spirit that brought the American people success in the days of the revolution. Yes we had very dark days and many of them and pulled out wonderfully.

To an intelligent true American, everything was perfect at that time, because our forefathers certainly did put it over on

the English power in grand style, and chased them out of the country. That is what they started out to do; that was a plenty. Only a fool will talk when knowing the work done, for no people in history have ever done better. The Victory at Yorktown on October 19, 1781, was enough for all time; it could not have been improved upon. It was plenty as it was.

Not until eight long years after success under the guidance of our Super-men, in our infant Federal Union Government, and its army upon the fields of battle, had brought home victory for us, did any body ever think of "a more perfect Union," or an improved Constitution. The idea for an improved constitution was absolutely political, and was not a child of patriotism. It was a move for political and financial power directed by the rich men of the country to get control for themselves.

Great work; why that is the only trouble. The work done by the greatest of all our great men, was too marvelous for floppy brains to digest. Don't ever criticize the work done by these super--men; for all they did, from 1774 to 1789, was simply marvelous. New, why that is the trouble; surely their work was new. All that the Russians, French, Germans, Mexicans and Spanish people learned of revolution, they learned from our fathers under our first constitution. Every nation of the first class, has adopted it, but Not one have ever adopted our silly method of electing a President by an electoral college.

The present constitution at best contains all the good that preceded it in the first constitution. If you laugh at the first constitution, you laugh at our present constitution. There are twenty reasons why we can laugh at our present constitution, if we wish to laugh. We had to make ten new amendments just as our present constitution started. Then we had to make amendment number eleven as our court methods proved a failure. Then number twelve, because of the failure in our method of electing a President. It also gave us a very questionable tax system, that was repudiated 130 years later, and amendment numberXVI was approved and adopted in 1913 under President Woodrow Wilson. You see the new constitution was not one bit more wonderful than our first, even with all the excitement over its adoption. Many more failures could be cited, but I only call attention to these few, to show, "That people who live in

glass houses, should never throw stones."

To just simply make the first constitution more perfect was the cardinal object of the second constitution, its advocates told us, but it only went as far as the election of a President in 1803 when Thos. Jefferson and Aaron Burr ran a dead heat, when the new constitution failed to work for the first time, and Congress had to elect the President and elected Thomas Jefferson, as they did John Hanson. So as far as perfection figured, the new constitution was not one bit better than the first, and in addition, the new one threatened the destruction of the Union by the Rebellion in 1861-1865; by permitting the institution of slavery, in direct and open defiance of the Declaration of Independence, and our first constitution, that prohibited slavery under any and all circumstances. Pres. Lincoln had to suffer for the sins of those who did know better, but the scheming bankers and politicians had it their way through absolute deception, just the same as they do today. The methods have not changed one bit. When the dishonest, wish to get things their way, they succeed in their villainous ways, simply because the American people seem too dumb to combat them. The old cry of "reds," and "communists" is the dope that puts the silly citizens to sleep while the real "big reds" rob them. Some day our people will have better sense. I hope, but many times when I make observations, I feel as if there is no hope for them. They are the victims of their own ignorance, and neglect, in their duty to their flag and country. Remember, it does not need any brains to be a Republican or Democrat, but our creator knowing we did need brains to be a good moral American, gave us plenty to use, but most of our people are too indifferent and do not use them.

THE BATTLE TO PRESERVE THE UNION

In Independence Hall, Philadelphia, where the Declaration of Independence was signed, and where General George Washington was named commander of the U. S. Army in 1775, is where the greatest legal Battle in all our History was fought to a finish and won by One Man—John Hanson, a member of Congress from the Catholic State of Maryland.

It was beyond any question of doubt, the greatest legal battle

the History of America and started in the United States Congress in 1778 ending in 1781. The fight was over the distribution of the land known at the time as the North West Country. This land had belonged to England and was later known as Ohio, Indiana, Michigan Wisconsin and Illinois.

Every State but Maryland demanded their proportion of that land in payment for the money they had advanced to the Revolutionary Forces and they threatened Congress they would withdraw from the Union if they did not get it.

Maryland, the Catholic State, was the only one that did not demand any land. Her remarkable stand saved the Union when on October 15, 1779, Virginia, Connecticut, New York and Massachusetts forced an amendment to "The Constitution" providing that no State should be deprived of territory for the benefit of the United States of America. Rhode Island, New Jersey and Delaware signed at once and all the others signed as called, except, Maryland. She refused to sign under any circumstances and then the Big Battle started. Twelve states left the Union. Only one remained, Maryland.

John Hanson, Member of Congress from Maryland took the floor and protested against the demands of the twelve States. He told them that no State had any rights to any land, and that New Jersey, New York or any other State did not win the War. He said that the United efforts of all the States on the battlefields won the war; therefore, all the land belonged to all the people under the Federal Government. The United States of America.

He proposed that five new States be created out of the land in question; namely, Ohio, Indiana, Illinois, Michigan and Wisconsin and then they could join the Union if they wished.

Each State protested against any such scheme and again demanded their share of the land or they would at once withdraw from the Union and walk out of the Halls of Congress, which they finally did.

John Hanson stood his ground and refused to make any compromise. He demanded that the roll be called to determine just how many States wished to be recorded on the proposition.

There he stood all alone facing a great rebellion and every delegate his enemy. This dreadful combat continued for three years. Enough to kill any ordinary man but still Hanson kept fighting until he finally subdued the twelve rebellious states and drove them back into the Union, and compelled them to sign back any claims they had in land to the United States or Federal Union. When the twelve signed, Maryland signed as the thirteenth State on March 1, 1781.

Just at the darkest hour, the King of France came to the rescue of the Union and threatened congress, that if they did not get behind John Hanson at once, he would withdraw his army, navy, financial, and moral support. He charged congress with doing to the American people what the English could not do with a big army, and just at a moment when every-thing apparently lost, fishermen off the coast of New Jersey sighted the scout ships of the French Navy, of 28 war ships, and 20,000 French troops going to the aid of Generals Lafayette and Geo. Washington at Yorktown. A fisherman was sent with the glad news to John Hanson as fast as a horse could run. The news that the French are here caused great rejoicing among the people and extensive arrangements were made for a great celebration to which the French generals and navy officers were invited.

One can only imagine how terrible conditions were in the fight when we realize that the State of Connecticut had gone so far to beat John Hanson, that she urged twelve States to form a new Union and keep the state of Maryland out for all time. The South under Lincoln did the same thing. They had their own President, congress, flags, army and a complete government, with a constitution of their own. Lincoln drove them all back into the Union, but at the cost of millions of men killed on the battle fields, while John Hanson did not loose one.

*Virginia was among the first States to return to the Union through the pleading and advice of James Madison. New York quickly followed and when the twelve rebellious States returned into the union, John Hanson signed for the State of Maryland, the thirteenth and last state and the United States of America took its place among the first class nations of the world for the first time on March 1-1781.

HOW WASHINGTON WAS ELECTED PRESIDENT IN 1789

Geo. Washington was not elected by a unanimous vote. He did not even receive a majority of the electoral votes cast. There were twelve (12) candidates against him.

The trouble with the vast majority of our people is, they take too much for granted and so are lead astray time and again. The election of George Washington as President is a very impressive example of how ignorant people can be, and how utterly foolish our electoral college system is. No other nation ever adopted it because of its uselessness.

Nearly every one believes that Washington was elected the same way that Abraham Lincoln or Woodrow Wilson was, but they make a great mistake, for not one person out of ten thousand knows just how Washington was elected. In spite of the great ignorance on the subject, you will hear people who should know better say, "John Hanson was President, but he was not elected the same way Geo. Washington was." As a matter of fact these persons are absolutely ignorant of the knowledge concerning Washington's election. About one lawyer among thousands really knows.

In the election for President, when Washington was chosen the State of New York did not vote at all. A quarrel between the Legislature and the Senate over how the electors were to be chosen was so bad that the great Empire State did not vote at all. New York, not voting for the Constitution, was debared from voting in the Presidential election. New Hampshire had a similar quarrel.

North Carolina and Rhode Island did not vote because they also refused to vote for the Constitution and were not members of the New Union. Only ten States voted for President in this election, under the Constitution of 1789, but not under our first Constitution.

Most people seem to think they are smart when they talk on this subject, in doing so they prove their ignorance regarding the true situation. A voter in that election had to have many qualifications before he could vote. A brief study will amaze you. They made it very hard indeed for an ordinary man to

vote at all. Only one man out of every hundred could vote.

The selection of members of Congress was left to the people. Under the Constitution any man who could vote for a member of the lower branch of the State Legislature, voted also for a member of Congress.

Suffrage was very far from universal. The elective franchise belonged only to the rich, and not to the poor man. The voter must own land, or personal property. In one State they had to have a poll tax; in another, a property tax; in another, the voter must be a quiet peaceful man with a freehold, or personal estate.

South Carolina insisted that a white man to vote for President must believe in the Being of GOD, in a future state of reward, and punishment, and have a freehold of forty acres of land.

New York insisted that a voter must be seized of a freehold worth twenty pounds YORK money, or pay a house rent, have his name on the list of taxpyers, and a tax receipt in his pocket.

The effect of restrictions such as these, was to deprive great numbers of deserving men of the right to vote. Young men just starting out in life, sons of honest farmers whose lands and goods had not been divided, wandering teachers of schools, doctors and lawyers just beginning to practice their profession, might count themselves fortunate if at the age of thirty they could comply with conditions imposed by the constitution of many of the states.

Of the mass of unskilled laborers, the men who dug the ditches, carried loads, or in harvest time helped the farmer, it is safe to say that very few, if ever, in the course of their lives, cast a vote.

Massachusetts in the General Court, chose two delegates at large, and eight more from a list of sixteen names sent up from the eighth congressional district.

Pennsylvania allowed the people to vote direct. Two tickets were in the field, one trying to elect Patrick Henry for President.

Maryland allowed her voters to vote directly for a choice.

Virginia did the same. Connecticut, New Jersey, Delaware,

South Carolina and Georgia, left the selection of electors to the State legislatures.

Any man who makes the statement that he knows how George Washington was elected President, must be out of his mind, unless he has the above figures. I present the votes as cast by the states; but not how they were cast.

From Washington to Jackson the electors were all nominated by the hand-picked method. The political leaders did the nominating by the hand-picked method. The political leaders did the nominating.

It was Andrew Jackson who gave us the convention system of nominating candidates for President and Vice President. He also gave us the two-third rule which had caused a great fight in all

the Democratic conventions as it did in 1932. This rule has stood for 100 years. I was adopted because it takes two-thirds of Congress to amend the Constitution, impeach a Congressman or over-rule a President's Veto.

The Republican convention calls for only a majority of delegates to nominate a candidate for President which is very easy.

THE FIRST ELECTORAL COLLEGE

In the Electoral College that selected Washington as President, the Electors did not vote for a President or Vice-President at all. They were warned not to do so. Here was a Presidential election where no votes were cast for a President or Vice-President.

It was the duty of the elector to write down on his ballot, the names of two men selected from a list of thirteen names submitted to them; without any indication of who he favored for President and Vice-President or his ballot would be thrown out. It was agreed that the man who received the greatest number of such votes was to be the President, and the man receiving the next highest number was to be Vice-President. Had every elector that voted for Washington voted for a Vice President neither of them would have been elected and it would have devolved on Congress, to elect a President and Vice President as was done before the Constitution was adopted and just the same as it would be today in case of a tie vote. The authority that Congress assumed in the first election by the electoral college system has been held to this day. It is a very foolish method and should be done away with by the next session of Congress. Just think that the political leaders look upon our citizens as being too dumb to vote for a President and appoint men who are supposed to have more brains, to do the voting for them. The electoral college is an absolute insult to all U. S. Citizens by questioning their intelligence as a voter. No one will vote for Mr. F. D. Roosevelt or any other candidate. You will vote for some wise men and they will do the voting for you. Can you imagine that in 1888 Grover Cleveland (Democrat) received 100,456 popular votes more than Benjamin Harrison, (Republican) yet Harrison was elected President against the will of the American people. Samuel J. Tilden (Democrat) was also

elected President but never took his seat. Andrew Jackson received 50 per cent more popular votes and 15 more electoral votes than John Quincy Adams, but Adams was elected President in 1824. Jefferson, Madison, Monroe and J. Q. Adams were Republicans.

WASHINGTON'S FAREWELL DINNER

The dinner called for the evening of December 4th, 1783, at the old inn in Pearl Street, New York City, where the generals and officers of Washington's Army was to meet and bid farewell to the Commander of the American Army, was not a farewell dinner. That is absolutely not so. It was the greatest and most contemptable conspiracy in all history. It was called by Alexander Hamilton and Aaron Burr. But the real purpose was to make Washington King of America and rob the American people of their victory and independence won upon the battle fields of the American Revolution. Such work has always been left to the big bank rs, and is being done today, as in these early days.

When the generals had all assmbled in the large room on the ground floor, Hamilton and Burr with two others, took Washington upstairs for a private talk, telling him they had a great surprise for him. They told Washington the meeting was to make

him King of America: Washington refused in forceful language jumped out of a back door without saying good bye or farewell to ny one, jumped on his horse and rode up Broadway as fast as the horse could run to West Houston Street; then West down West Houston Sreet to the only ferry on the Hudson River. There being no ferry boat in, to take his horse across, he abandoned his horse, jumped into an open row boat and had men row him over to Jersey. There he got another horse and rode as fast as he could, back to his home in Mount Vernon. He then went before Congress in Philadelphia and resigned the Command of the United Staes Army. A picture in the Ford collection during the Geo. Washington 200th Anniversary celebration in 1932, at the N. Y. Public library, 5th Ave. and 42nd St., shows Wshington crossinag the river without flag or body guard, for the first time (as commander) that Wshington ever traveled alone. I have a very good engraving printed 100 years ago, and a very fine oil painting also of this event.

THE LEGAL STANDING OF PRESIDENTS

Thomas Jefferson was the first custodian of the "Great Seal" under President George Washington in 1789, because of having been the first Secretary of State under Washington but he was not the first Custodian of the Seal. Charles Thompson, Secretary of the Old Congress, was made the first custodian and the appointment of Thos. Jefferson did not take away any of the authority invested in Thompson. All legal powers remained with Thompson, even under Washington, until his successor was appointed.

George Washington was the first President elected under our second Constitution but he did not take away any of the lawful authority vested in John Hanson, who was elected first President under our first Constitution of 1781, any more than could the election of Franklin D. Roosevelt take away any of the powers granted to George Washington because Washington was not elected the way Roosevelt was.

Nohing can take away any of the powers vested in a President of the U.S.A., no matter how, when or why he was elected. A President's signature to a treaty or other U. S. document with the Great Seal affixed to it is final and stands down into the ages.

Treaties with nearly every first class nation has John Hanson's

signature affixed.

The silly arguments advanced by people who think they know something is laughable. How or why or when a President was elected has absolutely nothing to do with who was the first President. We are not interested in how he was elected, we simply wish to know who was the first President of the U. S. A. to use the "GREAT SEAL" that the U. S. SUPREME COURT spoke about in 1803.

How Tammany Hall elects its candidates for Mayor of the City of New York, has nothing to do with how the Mayors of the early days of New York 150 years ago were elected. It would be just as silly to say tha women voted for Franklin D. Roosevelt and because women did not vote for Abraham Lincoln. Lincoln was not a President of the U. S. A. It makes no difference how he obtained his election as long as he was recognized as President, and was in full power and authority at the time in question and held a certifice of election. A Federation or any other form of Government has nothing to do with who was the first President. Please remember that our governments are never outlawed. They are only made more perfect from time to time; a sort of evolutionary process for the better: always changing from one period to another for the better, upward and onward "E PLURIBUS UNUM."

NOVEMBER 5th, 1781

It is positively foolish and all rot, for any person to try to belittle the authority invested in the first President of the United States of America inaugurated on November 5th, 1781. He would be laughed at by people who have their historical dates and facts at hand.

The United States was legally created, organized and became very famous among the nations of the world on November 5th, 1781. It had its President, Congress, Army, Navy, Courts, finance department, Post Office Dept., and functioned through and by the laws of that time, but surely not the laws of today, and not until eight long years after our liberty was won, and we were working as a government of the people, by the people and for the people, was George Washington inaugurated President, on April 30th,

1789, under laws and ways that had simply been improved, to fit his time, just as Congress improves the laws of today to fit our time.

Washington we all know very well was not elected President the way that Thos. Jefferson, Abraham Lincoln, Woodrow Wilson, or Franklin D. Roosevelt was; but what difference does that make from a point of law? Each President was elected under the law of his time. The laws guided all in their time. Congress has always held authority in the election of Presidents. In case of a contest or a dead heat, Congress selects the president as with John Hanson, Thos. Jefferson and in the Samuel J. Tilden election.

Only a short ime ago Congress voted three times in practically one day to amend the Constitution to inaugurate the President on January 20th, instead of March 4th. Congressmen to be inaugurated on January 5th, instead of waiting thirteen months to take their seat as was formerly done in December. It was lawful for a President to be sworn in on March 4th because it was the law at that time. So it was with the first President of the United States. It was the law of his time and the papers he signed with the Great Seal affixed at that time, binds every President down into the ages.

While the President in 1781, did not function under the same laws as did Lincoln or Wilson, there was enough law to enable him to do what he had to do and what was needed in his time, and not one thing was left undone as could be seen. As new conditions came up, just the same as they do now, new laws were needed from time to time. That was all that happened in Washington's time. They had to improve the Constitutions as they went along. A sort of evolutionary process to hedp make "A more perfect Uuion."

November 5th, 1781, is a great day in our history. It is the day the United States of America took its place among the nations of the world officially.

October 19th, 1781, was the day upon which the English Army at Yorktown surrendered unconditionally to the will of the American people represented by General Geo. Washington, Commander

of the U. S. Army.

Seventeen days later, November 5th, 1781, the United States of America, took its place in the family of the great nations, in a lawful and legal manner, and the legality has never once been questioned by any nation on earth.

Holland and Sweden were the first nations to sign treaties and offer financial assistance to the new-born nation. This all happened under our first constitution.

Eight years after all this had been accomplished on April 30th, 1789, George Washington was simply inaugurated first President under the second Constitution or more perfect "Union"; but absolutely not a new Union.

The United States of America obtained everything it possesses under our first Constitution, known as "The Articles of Confederation." (See Abraham Lincoln). There was hardly one thing in it that was not transferred bodily over into the second Constitution, although great but questionable efforts were made to keep out a great part. After a long fight lasting nearly three years, they had to submit to the rebellious Southern States in the Constitutional Convention, through absolute bribery, by allowing the south to continue their great racket of trading in slaves. One thousand to five thousand dollars for a human being was a great racket. Washington was the President of the convention, but his personality failed to carry. For two years the convention hall doors were padlocked and the delegates never could have adopted the present constitution without what seems, common bribery to the south, and in absolute open defiance of the Declaration of Independence, and the first constitution, which insisted that there shall not be any slavery; that all men were born equal and alike.

Eighty-odd years later President Abraham Lincoln had to carry this cross, suffer and die for this dreadful sin. He had to kill millions of men upon the battle fields to preserve the "Union," and carry out the Declaration of Independence and the First Constitution against slavery. Lincolns' only argument consisted of but five words. "The Union must be Preserved."

He refused to take any salary as President of the U. S. A., and also refused to take the Presidency the third time when it was offered to him, saying, "no man is worthy of the great trust for more than two terms."

If he had accepted to be made KING OF AMERICA, we would not be here to day to tell about it. So we can see at a glance the great things he did not do.

When ever the head of a great nation wishes to know who the President of United States was, on any certain date, one hundred or more years back in our history, he goes into the secret vaults, gets the papers of the time in question, and looks for the "Great Seal of the United States" first, the Seal at once proves

to him, without any question of doubt, that the man who signed the paper in question, as President, was the President of the United States of America at the particular time written on the document. There can be no appeal from his fact.

"E Pluribus Unum," is latin, and means, "One out of Many." In our case it means: "Out of many governments we have one." Of thirteen separate States, with thirteen separate constitutions and governments, we finally acquired one to rule over all.

"E Pluribus Unum," in the beak of the eagle in the "Great Seal of the United States," was not the original motto for the seal as composed by Thos. Jefferson. The original motto was "Rebellion to Tyrants is obedience to God," and means; that the only obligation we owe to our God is to smash upon the head, with a club, any man or woman, who dares to take away any of our rights given to us in the Declaration of Independence, and our first constitution. Benj. Franklin thought it too strong, and prevailed upon Jefferson to use "E Pluribus Unum," instead, but Jefferson thought so much of Rebellion to Tyrants," that he adopted it for his own family seal and, it can be found as such in any library in the world today. Jefferson might have had in mind people like the advocates of Prohibition, and the

18th Amendment and Herbert Hoover's treatment of the Bonus Veterans in Washington, D. C. July 28th, 1932 when he coined the motto "Rebellion to Tyrants is obedience to God." They had better watch their step, because the American people have demonstrated on the question of Slavery in 1861, that they will stand, just so much and no more. Slavery went down and out and everything and every man and woman that attempts to take away the peoples rights in any form must go down sooner or later.

"The Great Seal" was adopted by Congress on June 20th, 1782, and was ordered disigned on July 4th 1776, the same day the "Declaration of Independence" was ordered signed.

The first President to affix the Great seal to any governmental document for the first time was positively the first President of the United States of America. This is an incontestable fact, and must be accepted by every authority on earth. The "Seal" proves to every international authority that the first President that signed, the first U. S. paper was the President of the United States at the time he signed. The Secretary attests to that fact by dating and affixing his signature to the documents after he affixed the "Great Seal." (See Supreme Court of U. S. A. 1803).

The Great Seal includes the American Eagle, holding an olive branch, with thirteen olives, meaning the power of the U. S. A. in peace, and a bundle of thirteen arrows (representing the power of the thirteen states in war) and in his beak a scroll, inscribed this motto, "E Pluribus Unum," meaning, "One out of many."

THE FIRST UNITED STATES SENATE

The first United States Senate met in New York City, the first capital of the U. S. A. under Geo. Washington April 5-1789 and found a quorum in the senate as the twelfth Senator had arrived. Ten States only were represented. Two Senators from each state made twenty. One **half** of these and one more eleven constitutes the quorum.

The House of Representatives were more fortunate—they had secured a quorum and had chosen a speaker, and were hard at work on a tariff act, when a messenger entered from the Senate and informed the speaker that the Senate was ready

to count the electoral votes cast for president and Vice President.

The part of their work finished, the Houses adjourned, and Charles Thompson, Secretary of Congress, was sent to carry a Certificate of Election as president of the United States, to George Washington at Mount Vernon, Va., while Sylvanus Bourne went on a like mission to John Adams, at Braintree. The journey of these two men from their homes to the seat of Congress to be inaugurated was one long ovation. Adams was notified first and got on the road within a few hours, and was accompanied from town by troops, and soldiers and long lines of men on horseback and was met at Kingsbridge, N. Y., just outside of the new York City line, by a Committee of members and the chief citizens of New York City and conducted to the home of John Jay. He was inaugurated April 22nd, one week before Washington, because a vice president had to be provided first in case the President should die, there would be a Vice President, to take his place.

Charles Thompson was a native of Ireland, a school teacher in Philadelphia, a great friend of Benjamin Franklin and fifty nine years of age at this time. He died at the age of ninety four. In 1774, he was elected Secretary of the Continental Congress,—which office he held for fifteen consecutive years, until Thos. Jefferson became Secretary.

JUNE 20th

June 20th, was a national holiday for seventy five years after the constitution of 1789 was adopted. It was the anniversary of the adoption of the "Great Seal of the United States," and was celebrated with great patriotism and looked upon as just as important an event as the 4th, of July, "Independence Day."

Why the day has been cast aside and forgotten is I am of the belief, of sinister design. Therefore, I feel it is the duty of every real American who loves his country to see to it that the day be restored to its place among the great days in our history.

It is no wonder that the people are growing indifferent to our country's romance and wonderful traditions to such an extent, that our country has come under the evil power of racketeers, bootleggers, crooked police, crooked district attorneys, crooked judges, crooked politicians, and crooked organizations with political names. Just think how true this is when we miss all admit that twelve judges in the city of New York were thrown out recently and the women judges were worse than the men. The spirit of 1776, has vanished from our land and allowed to be forgotten and deliberately eliminated with a most criminal

intent. Therefore, the Bicentennial Celebration of George Washington has come at a very opportune time. This year is also the 150th, anniversary of the election of John Hanson as the First President of the United States, under our first constitution, and is also the 150th, anniversary of the adoption of the "Great Seal" of the United States. How strange that all five anniversaries should come in this year as if to give force to awaken the people in bringing back the spirit of 1776, that we might restore our beautiful land to where our forefathers intended it should be: A land of the brave and free: A land of happiness and a land of plenty. Puritanical laws, Blue laws, Prohibition and interference by religious fanatics with our rights, and liberty given us in the Declaration of Independence has forced many of our people to willingly accept a government under gunmen and crooks, rather than be governed by religious fools. Religious interference with the laws of the states has caused great suffering to all people down through the ages, and the people of the whole world have decided to stop it and at once. Mexico, France, Italy, Russia and Spain have thrown off the curse of the religious dictators and America will do the same if she must. The 18th amendment alone has caused twenty million people to leave the Christian Churches and they will never go back, because these people are disgusted with the Church people interfering at all times with their rights to life, liberty and the pursuit of happiness. Instead of a land of liberty and happiness, the religiously insane has made it an actual hell on earth for many.

OUR TWO FIRST PRESIDENTS

JOHN HANSON OF MARYLAND — GEO. WASHINGTON OF VIRGINIA

Born April 3, 1715.

Born Feb. 22, 1732

How strange is destiny to have guided these two lovable characters from boyhood to become our two first Presidents.

One a great fighter on the inside, (in Congress) fighting the enemies of the UNION, and the other fighting on the outside

against the BRITISH enemies. Both fighting for the same cause from two opposite directions, If either of them had fallen in their fight, our UNION would have fallen; but thanks to some guiding force neither of these great fighters made any mistakes, and both won a marvelous victory for all humanity.

John Hanson was old enough to be Washington's father. His oldest son was Washington's secretary for eight years and Washington would not think of doing anything of importance without first consulting his trusted friend. They lived opposite each other on the banks of the Potomac River. One in Virginia, the other in Maryland. They were always going into the homes of each other. They were like two women; when they met, they would put their arms around each other in a fond embrace. In boyhood they were close to each other, and the greatest friendship continued to the last.

The faces of both men show a strong Nordic type, small bones in their faces, like women, although they were large physically. This shows the strange feminine characteristics which all the really great international characters took from their wonderful mothers, proving beyond doubt, that all really great characters, come into the world through great mothers and not great fathers, for no great man has ever produced a really great son. It's the great mothers we must look to. Solomon proved this; try he would, he could not produce a great son. Abraham Lincoln, and Marconi prove this.

It was the influence of Washington that made Congress appoint John Hanson the Chief, in the manufacturing of munitions of war, and with the absolute distribution of same in 1775. Hanson was the only man Washington would trust with this most important post, and Hanson never failed him once.

No two men ever loved one another more than did John Hanson and George Washington. Theirs was a super-friendship like that of the lowly Nazerene and the apostle John.

Both men had very strong feminine characters, but not observable to the ordinary person. Men with these rare feminine traits (not sex) have always proven very exceptional guardians over the Human family, and are the men upon whom trust can be placed to carry out great feats, or movements, in the cause

of mankind.

Washington's strange face figures very forceful in this theory. It was almost impossible for the great artists and painters of his time to get two expressions on his face alike. He was a most difficult subject to paint. His face was heavily pox marked, distorted by false teeth that never did fit, making it almost impossible to get a natural expression deserving of the him. His lower jaw as is seen in most paintings, is very unnatural. He was a typical subject of the Swedes from whom he decended, as did John Hanson also. His hair was red, and mixed with iron grey which was hidden by the wig he wore. His feet and hands were exceptionally large. He was given to outbursts of profanity, and anger. He manufactured liquors, and could drink his share with any of his friends. All the big men of that day drank and made their own liquors. Washington manufactured whiskey, brandy and rum for the trade. I have in my possession a good picture of his distillery. The New York American published the same picture in all its papers in 1932, during the Bi-centennial celebration. They have dug out the old foundations, and will rebuild the distillery complete, and preserve it as a national shrine for all the ages. What a rebuke to the advocates of Prohibition, and the 18th amendment.

Washington wrote a complete history of the life of John Hanson, as a record for himself, but some sinister influence destroyed the pages torn from Washington's private book after his death. Why?

To separate these two immortal men in death was a calamity to the American people.

ONE OF THE first things done in Lincoln's first term as president, was the casting in bronze of the immortal men, John Hanson and George Washington that they might stand face inside the capital at Washington, D. C., down into the ages. Inseparable in death, as they had been in life. John Hanson was inaugurated as first president under the first constitution of the United States of America, known as the "Articles of Confederation." on Nov. 5th, 1781. Washington was inaugurated first president of the United States of America, under our second constitution, April 30th, 1789, eight long years after the

revolution ended on Oct. 19, 1781.

THE FIRST VICE PRESIDENT OF THE UNITED STATES

No provisions were made in our first Constitution for a Vice President and when the First President John Hanson was taken sick and confined to bed for a long time from the terrible strain in his long fight for liberty, Congress, was asked to have Daniel Carroll of the Catholic family of Maryland, the family of the Signer of the "Declaration of Independence," chosen to set over Congress in the President's absence and carry all congressional papers to the President for his approval and signature. Congress would not accept his resignation, because of their great esteem for him. No one could fill his place until he had passed over. He selected Carroll who was his associate member of Congress from Maryland. So the Catholic State had the first President and Vice President of the U. S. A., at the one and the same time. No other state ever held that honor.

Washington D. C. the land upon which the city was laid out, was given to the U. S. by the Catholic Family of Carrolls. It was their farm and they lived on it for many years. Daniel Carroll was born on it.

The first money to build the capital of Washington, was advanced by the Catholic State of Maryland.

The most valuable thing the United States owns in connection with Geo. Washington's life, is the Masonic Apron he wore at the laying of the corner stone of the United States Capital. Catholic citizens of Maryland demanded the finest work to be had for this apron, so they sent a committee to France to a Catholic convent who's inmates (Nuns) were famous all over the world for their embroideries. They designed, and embroidered with different colored silks, pure gold and silver threads, the flags of France and the United States on cream colored satin. It is said to have been the most beautiful work of its kind in America at the time. General Lafayette was the only one ever allowed to wear it outside of Washington.

CAMBRIDGE, MASS.

A great many people are under the impression that the war for Independence was a sort of a joke as far as war is understood. This is wrong, because the facts show very clearly that at the time, many of the greatest military authorities living in the world were amazed at some of the things done by the army under Gen. George Washington.

One of the most remarkable feats ever accomplished by any body of troops in active warfare in the entire history of the world was done when Gen. Washington and his army were faced with a crisis at CAMBRIDGE, MASS. Washington needed help badly and needed it at once. There was no telegraph, mail or telephone service those days, so men were dispatched to different sections to get help immediately.

Maryland, JOHN HANSON'S State (the Catholic state.) was the first to reach Washington before any others from the South country.

When Washington's crisis-call, reached MARYLAND, military companies were quickly dispatched to his aid. Each man had to be an expert marksman and a fighter, strong and brave for what was to be a record work for all time in the history of warfare throughout the whole world.

Under great difficulties and obstacles, these men were made ready and gotten under way to save the Commander who made an exceptional emergency call for help. These men were under call in their own state, but when JOHN HANSON received Washington's call, Maryland forgot about themselves and rushed their expert men to Cambridge with all speed.

Cambridge was 550 miles away. Some distance those days and with British troops on all sides covering every road to capture them. The British generals knew that Washington had sent out the emergency call from a messenger captured on the road, and it became necessary for these troops to abandon every road and cross the country under cover and darkness. No bridges for them to cross streams and rivers. With supplies and food for their own men they carried supplies for Washing-

ton's army which was in bad shape.

Large supplies of food and clothing and thousands of dollars in gold money was carried for the relief of the people who were seiged and starving. This would have been a very valuable prize for the British if they could have captured this army which they were looking to capture.

Unbelievable as it seems, this march of 550 miles was made in 22 days without the loss of one man, or a horse and no sickness, showing what sturdy men the state of Maryland had dispatched to the relief of the commander of the American army in one of the darkest hours of the revolution. These Catholic people knew that if Washington fell, they might just pack up and get out for the part they had taken in the fight. The greatest military authorities of Europe would not believe that such a march had been possible, until they had an investigation made for their own information. The great military authorities of Germany and France, pronounced the feat of 550 miles overland in 22 days as absolutely impossible. When they did finally get the facts they at once pronounced it the most marvelous work in all military history and the record has never been surpassed up to the present time by any modern army. So it is ridiculous for people to think there was no real war in the fight for American Independence. It cost \$157,000,000.

Not alone was this forced march a big success, but it enabled Gen. Washington to make a successful retreat that saved the American army from what was one of the most dangerous situation in the entire revolution.

This is only one of many wonderful exploits during the war, and only in technical history can we read of them.

In closing my book, let me warn every evil power that thinks themselves above the "Declaration of Independence" and our first Constitution, that they can not win, because both documents were inspired. "Rebellion to Tyrants is Obedience to God," was the first motto coined for "The Great Seal of the United States of America," by the Immortal Thos. Jefferson. Translated by himself, for the U. S. Congress, it means, that the only obligation we are under to our God is; to hit on top of the head with a club, any man or woman who attempts to take away any of our rights and liberty, guaranteed to us in the "Declaration of Independence," and our first Constitution as was done in the 18th Amendment.

Governments, Patriotism, Finance, Big Business, Religion and Churches, become brutal Tyrants over us through neglect, and indifference on the part of the citizens.

After our forefathers won our rights to life, liberty and happiness upon the battlefield at Yorktown, Va., in 1781, Thomas Jefferson at once warned the people that the war just won, was child's play to the war we must now engage in to hold what we had won. The war will be a terrible war, to hold our liberty and rights won in the Revolution."

Jefferson told the American people a terrible truth; because from the very day that we pulled down the Battle Flags of the British enemies, new flags of more criminal enemies, were nailed to the mastheads, over our flags of victory, and they have been flying unmolested to this day. Under these enemy flags, a gigantic and terrible war has been raging against our people, their freedom, and the "Declaration of Independence." We can see this very clearly in the "War for the Union," and in the Civil War against the 18th Amendment and Prohibition in 1932.

Racketeers in Religion, High Finance, Courts, Government and Politics, Grafters in the Subsidised Press, International Bankers, Big Business, and one thousand and one other desperate and heartless enemies are arrayed against the rights and freedom of our people. All power seeking churches and religions are also arrayed against our people and can be seen

in the Puritanical Blue Laws that stand out in open defiance of our "Declaration." Many Cities in this country deny the people, moving picture shows, or ball games on Sunday, because of the orders issued from the church heads. For this, our people would rather be governed by crooks in government, who will give them a little liberty. All big cities in the U. S. Prove this.

Many churches and religions, stand in open defiance against all the authority in the "Declaration," our Flag, and our First Constitution, knowing that in the Revolution, the church was separated from the State, and told to mind its own business or there would be serious consequences.

Mexico, Spain, Italy and Russia gave the above reason, for their drastic treatment of all religions. What can the Churches in this country be thinking of, that they can't see what modern nations are doing to people who interfere in the Government's business. Surely some Churches are getting treated pretty rough; but they, themselves, brought it on. "There are none so blind as those that will not see." Another move by these powers as was done by them in the 18th, Amendment, and I would be afraid to write what I believe will happen to them; because the people are sick, sore, and tired of such interference with their personal and Constitutional rights. What moral right, has any people to tell others, what they can drink, or eat; and if you don't do what they say, they will put you in jail for life, or put you to death. You can plainly see, that such acts, is plain insanity. You can never teach morality by laws. You can drive a horse to the water, but you can't make him drink. Twenty-million members have already quit the Christian Churches, in the U. S. A., because of the dirty work at the bottom of the 18th Amendment, and they will never go back. What has become of the immortal words of our fathers; "Give Me Liberty, or Give Me Death."

THE FIRST U. S. SAFE DEPOSIT

When the Declaration of Independence was signed a safe place to hide it was sought for a Safe Deposit. The English had offered \$100,000 in gold for its capture. Mary Catherine Goddard, 21

years old, employed in a war munitions factory in the back woods of Maryland, and who was built like the Venus de Milo, was chosen. She hid the document on her body for five years and only John Hanson knew where it was.

EMERGENCY SESSION OF CONGRESS

Thompson refused to surrender the Seal and papers until an emergency session of Congress provided a safe place for them.

Thus terminated Thompson's Connection with the Great Seal which he had done so much to design and have adopted. Notice that Alden afterwards described his own appointment as that of **KEEPER OF THE SEALS AND PAPERS OF THE OLD CONGRESS.**

On June 27-1789 the emergency session of Congress passed a bill creating the Department of Foreign Affairs. This was absolutely the **FIRST EXECUTIVE DEPARTMENT PROVIDED FOR UNDER THE SECOND CONSTITUTION**, but the Secretary was not made the keeper of the Great Seal and it remained in Alden's hands until the **DEPARTMENT OF STATE** was created. The act creating this Department was entitled, "An act to provide for the safe keeping of the acts, records, and **SEAL OF THE UNITED STATES** and for other purposes." It enlarged the Department of Foreign Affairs into the **DEPARTMENT OF STATE**, and named as the principal officer the **SECRETARY OF STATE**. The third section of the act read:

And be it further enacted, That the Seal heretofore used by the **UNITED STATES in CONGRESS assembled, SHALL BE, and hereby IS DECLARED TO BE, the SEAL OF THE UNITED STATES.**

INFINITY LESSON FOUR: HISTORY OF THE MOORISH SCIENCE TEMPLE OF AMERICA

The Moorish Science Temple of America in itself is the first Islamic organization in America, being founded in 1913 A.D. In 1913 the Moorish Science Temple of America headquarters' was at the Canaanite Temple building located in Newark New Jersey. The address of that building was: Seven Rutgers Street corner 12th Avenue, and West Market st.

Prophet Noble Drew Ali later moved the headquarters to Chicago Illinois. Prophet Noble Drew Ali informs us that we, the Moorish Science Temple of America, organized as the Moorish Temple of Science in the year of 1925. The Moorish Temple of Science was incorporated November 29th 1926 as a civic organization. In the year of 1927 we, the Moorish Science Temple of America, were unofficially known as the Moorish Holy Temple of Science (*unofficially because that name never appeared on any corporate documents*). The name Moorish Science Temple of America was formally adopted in May of 1928. The Moorish Science Temple of America was changed from a civic to a religious organization July 20th 1928 "officially" making it the first Islamic organization in America, and an affidavit to that effect has been filed in the Cook County's Records office of Illinois. The Headquarters' of the Moorish Science Temple of America in 1928 was 3140 Indiana Ave.

The Moorish Science Temple of America is Religious non-profit Corporation. The Moorish Science Temple of America is a Movement; a divine and national movement. Proof of this fact can be read in Prophet Noble Drew Ali's speech entitled '*A Divine Warning By The Prophet For The Nations;*' Prophet Noble Drew Ali states in this speech, "*There is but one issue for them (unconscious Asiatics of America) to be recognized by this government and of the earth and it comes only through the connection of the Moorish Divine National Movement, which is incorporated in this government and recognized by all other nations of the world.*" There is no such corporation by the name of Moorish Divine National Movement; the corporation that exists is the Moorish Science Temple of America.

By 1928 Prophet Noble Drew set aside 15 Temples in 10 different states.

MOORISH HEAD MAKES PLANS FOR CONCLAVE

Beginning Oct. 15 and continuing through the entire week, the Moorish Science Temple of America which Mr. Drew Ali is founder and president, will hold its first general conference at Unity hall, 3140 Indiana Ave., Chicago, Ill. President Ali began definite plans to this end upon his recent return from Pine Bluff, Ark., where he spent several days lecturing at the local Moorish temple. This organization is playing a useful and definite part in advancing the sacred obligations of American citizenship. Indications a----- that this convention will be one of the most interesting ever held in the city. It will be featured by delegates attending in pilgrimages from 15 different states where local temples have been established. There will be an interesting parade, in which men and women members will wear regalia similar to that worn in eastern countries. A Camel will be used. During the sessions specific reports of the general work and

civic accomplishments of local temples will be made. Reports also of the business enterprises that have been established in connection with these temples, such as two grocery and market stores in Detroit, a laundry in Pittsburgh, Pa., and moving and express business and grocery in Chicago.

The work was represented to its fullest extent. The Temple spiritually and financially was represented by Governor Lomax-Bey. The reports were a credit to the Temple and the Governor, after which Brother Trailer-Bey and others gave short talks.

Speaker said, there was a time once when the Moors saved civilization. I am glad you have relit the lamp. Don’t let anybody turn you around. We will never be a nation until we have all the rights of civilization and someone sitting in Congress. I see that these people have seen the light and walk in the light. Brother Payne-Bey, Attorney of Chicago was presented; he said “I don’t know a moment of my life that I was happier than now.” His speech was of the highest type. Honorable Anderson was introduced and said “The Growth of this movement has been marvelous.” He said many good things for the Moors. Honorable Oscar Depreist of Chicago was presented; he said “I feel encouraged knowing that with your prayers I will succeed. I wish more of my people would join the Temple.” His talk was encouraging.

Honorable George W. Blackburn, Representative of the state of Chicago, IL said, “I am here to serve you. We all are Moorish Americans.” Governor Pilot-Bey of NJ came forward using for his subject ‘Let the Moors lead’ he said. “Someday the Moors will lead the world back to love. One half of the wisdom of Noble Drew Ali has never been told. CONVENTION A BIG SUCCESS

Delegates Assemble From Fifteen States Prominent Men Deliver Address

The first annual convention of the Moorish Science Temple of America was without a doubt the greatest success of any convention that has been held in Chicago in many a day. There were delegates from fifteen different states. All came as was expected by the prophet although many of the Temples did not represent according to the numerical strength of them. The program as was dictated by the prophet was followed in detail and everything went as was expected. The opening of the session was the registration of delegates and visitors at the general headquarters, 3140 Indiana Ave. There were more than three thousand delegates and visitors from out of the city. The main auditorium of the Temple was crowded to its capacity every night. The day sessions were given over largely to the business of the different temples.

The Moroccan costumes worn by the members of the Moorish Science Temple was a very different, but striking scene during the convention and made everyone know that the Prophet had introduced a new feature in the apparel of the organization that distinguished it to the public as nothing else could.

Prominent Men Speak-

On Tuesday night was held the formal opening with many prominent speakers, among whom were Alderman Louis B. Anderson who delivered the welcome address to the delegates and visitors. Dr. C. V. Roman of the Meharry Medical College, Nashville, Tennessee, was a pleasant surprise speaker, who was in the city in the interest of the Congressional Campaign of Oscar DePreist. Hon. Daniel M. Jackson was absent because of business with the government at Springfield, Illinois, but was represented by Atty. Aaron Payne, who delivered a very forceful address, touching on many things of interest to the Moorish Americans.

Notwithstanding the fact Hon. Oscar DePreist as well as Alderman Anderson was very busy with the campaign, they took time to stay throughout the meeting, and the closing address was delivered by Hon. Oscar DePreist. He outlined very simply, but very forcefully the matters evolved in the Congressional Campaign of the first Asiatic Congressman who had entered the halls of Congress for more than a quarter of a century. He reminded the audience that twenty-eight (28) years ago Hon. George F. White in his last address to that law-making body told them that his leave would be only temporary, and that it would be only a matter of time that he would return in the person of one of his brothers. Now, in the course of political events the time presents itself for the return of that Honorable man in the person of Hon. Oscar DePreist. Hon. George W. Blackwell, State Representative, and a strong member of the Temple, explained the economic situation as it relates to the Moorish Americans, his was a very interesting address.

The meeting was extremely enthusiastic. It could be easily seen that the Moorish Americans caught the spirit of the speaker and demonstrated it very dramatically. During the course of the speaker's talk, the Prophet took the occasion to bless his efforts in this great undertaking, all of which was very proper and fitting. Hon. Oscar DePriest thanked him and said, "I feel that with the help of the Moorish Americans in this city, that I have won." The

opening meeting was the example setter for all other meetings that followed. The enthusiasm with which the convention opened, carried on throughout the week. Richard H. Ross Bey, was master of ceremonies.

Moorish Parade-

On Wednesday at 2 o'clock more then three thousand Moorish Americans in Moroccan costumes and each carrying a flag of the Nation of their forefathers, which is the Moorish flag, and an American flag on their right, assembled at 37th and Federal st., ----- made, which was very colorful, formed for the parade.

The Prophet, in securing a permit for the parade also secured a squad of European police to accompany his car in the parade. The line of march was from 37th and Federal streets east to Wabash and north on Wabash to 32nd street then to the Temple at 3140 Indiana Avenue. That it was one of the most beautiful parades that had been held in Chicago for a number of years was stated by all of the leading newspapers of the city.

This parade did much to inform those who were not acquainted with the movement as to the aims and purpose of the Moorish Science Temple of America. Many citizens had never seen so many Moorish Americans dressed in Moroccan costume, therefore voiced their hearty approval.

The Convention was an entire success from all angles. Many people visiting took the occasion to investigate and join. The aim of the Moorish Science Temple of America is to promulgate the Mohammedan religion and give to all Moorish Americans their national free name. In a course of time this movement will become of national scope because already there are Temples in fifteen different states.

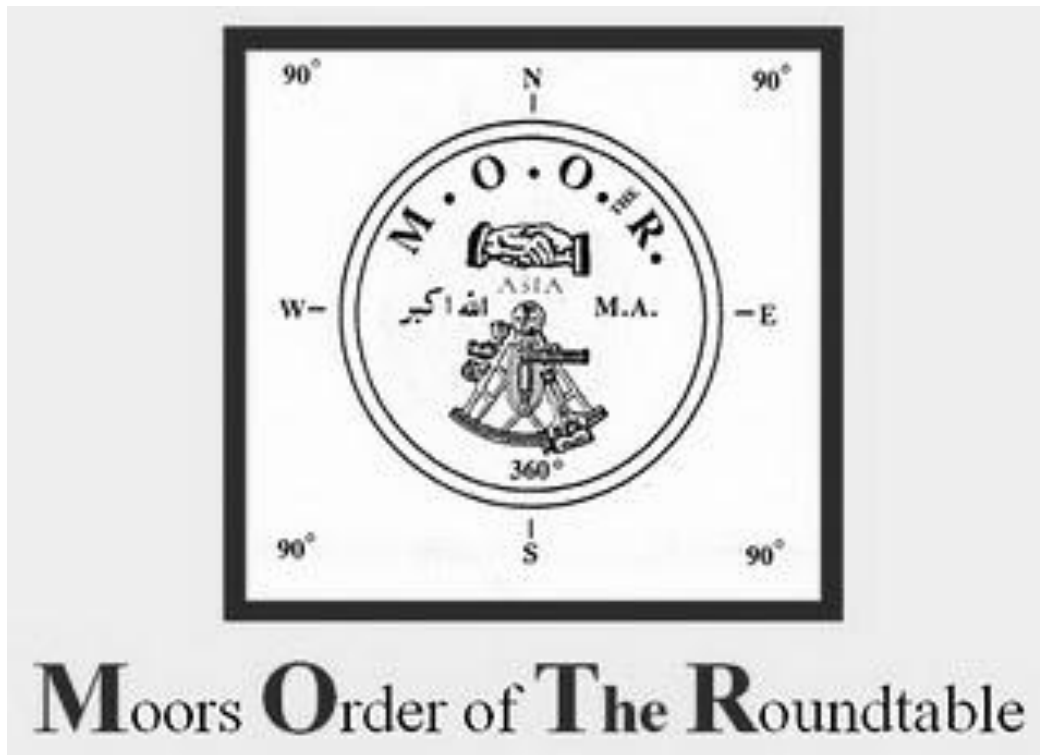
During the stay of the prophet at Temple No. 4 there were more than 70 adepts carried through the chambers. More than a thousand were turned away from the temple, so immense was the crowd

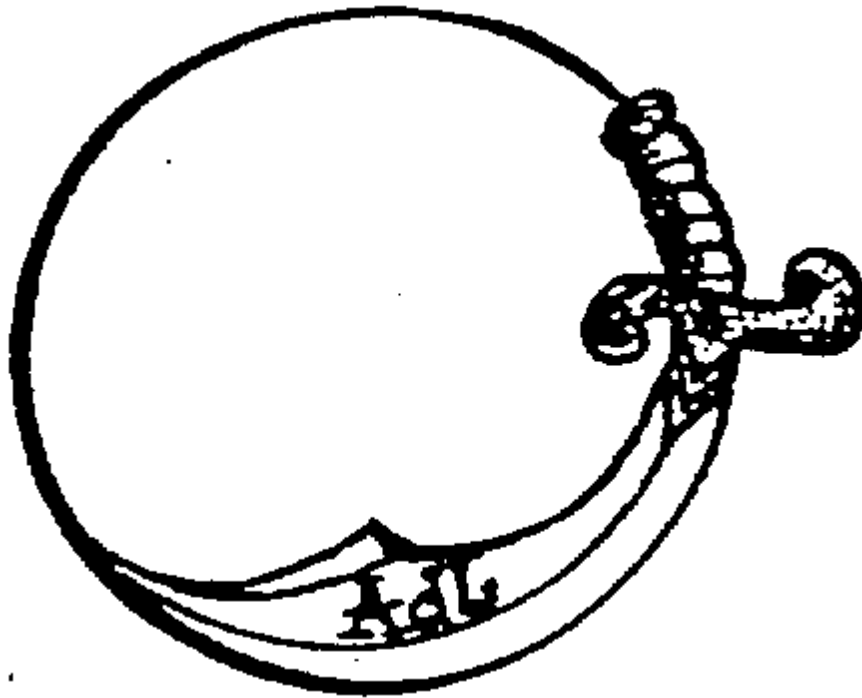

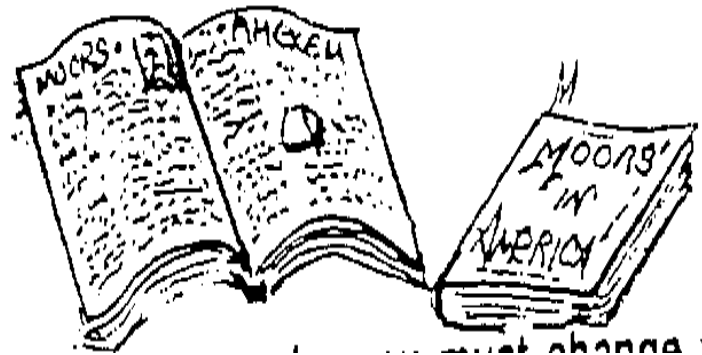

COMMUNICATION

Communication is the act of exchanging ideas and/or conveying information, desires or conversation between two or more entities, willing, able or having the capacity to receive the same. Communications occur with one's environment, between families and family members, communities, people in social or political institutions, nations or through national and/ or international intercourse, etc. Communications are made through or by sensory, oral, nuance, electronic or written methodologies.

Constant psychological, economic and direct physical warfare is waged against the indigenous Moors by the foreign Albion European colonists and their descendants. Therefore, any objective communication between the two peoples has had little valid or uncolored platform for lawful review of issues or of grievances. Due to Colonization, war, usurpation, usury, slavery and massive book burnings, the true story of the Moors in the Northwestern and Southwestern Hemisphere (the Al Morocs), was RECONSTRUCTED was from 1865 to 1877 A.D. = 1285 to 1297 M.C.. A pre-1779 plan was mounted against the Indigenous Moors to bring about an artificially induced DUPLICATION

of the DARK AGES of Europe. This fact is historically verified by the FORCED ILLITERACY of the DEFEATED MOORISH NATION in AMERICA (laws against reading and education of the Moors, in general).

This modern era of politically enforced ignorance (post 1779 A.D.), we shall call, THE DARK PERIOD. The people and their lands have been renamed or branded by Europeans, who also put their names on the enslaved Moors as a curse and a title of ownership. This psychological war tactic worked to confuse the descendants of the Moorish Tribes, in the Al Morocs, of self, (Nationality) Names, Birthrights, Heritage, Sciences and Geography. A whole nation of people, made to be the chattel property of the States (Colonists and their descendants).

Before the modern slave era in the Western Hemisphere, England was called Albion; land of the Albinos. The Moors called them Albinus Gauls. When the Albinus Gauls (Anglis) began to settle in the Moroccan Provinces of Northwest Africa (North America), the Moors called the Peregrines. Peregrinus: the etymology of the word pilgrim; from Moorish Latin.

The infamous discovery of America (usurpation), in 1492 A.D., 912 M.C., in truth, is the literary signal referring to the turn of history. This signal marks the fall of the Imperial Moorish Empire in the West in 1492 A.D., 912 M.C., 1492 is the pivotal year of axis for the division of Ancient and Modern History. This period of history marks the emergence of the New World of Christendom (European Beginnings) forging into world political power. In spite of steadfast opposition by many Moorish Regencies, the Albion's were eventually granted a Charter in 1781. The defeat of the Moors is celebrated today as the Thanksgiving Holiday, of Christendom.

The true geographical location of nations and people have been fraudulently altered and changed. The Albion conquerors altered the old Moorish maps; changing longitudinal line degrees to land and time zones. Today, many mis-educated people actually believe that the Al Morocs (Americas) and the adjoining islands are, INDIA; and that the Moorish Tribes are Indians. The FICTIOUS contemporary history is propagated to steal the BIRTHRIGHTS from the descendants of the conquered and enslaved Moors. Most are unaware of the truth about RECONSTRUCTION (The Reconstruction of History and Geography).

These conquered lands (Americas) are, in truth, the heartland of the MOROCCAN EMPIRE. The Maghrib El Aqsa (Morocco farthest West); native lands of the Moors; Now under European siege (Colonization). Moors are bound to the Continents of the Americas by Heritage and Birthright. The forced dissection and destruction of Moorish families, and relocation of peoples, had its desired DISORIENTATION and INSTABILITY. This **Christian Crusader's** disorientation war strategy is still in force in modern times (1996 A.D. = 1416 M.C.). it effectively brought about the submission and subjugation of the progeny (descendants) of the Moors. These Military manipulations proved to be powerful and useful tools, which include the STROKE OF THE PEN.

The Dark Period of modern history was inspired by the works of Phillip II of the Roman Catholic Church, through the Spanish Inquisition of the **1500's A.D., 920's M.C.** wars and Continuing conflicts up to the War of 1812 on Lake Erie, Michigan, evolved into the acts of the Knights of Columbus – Magna Charta (Charter) Ku Klux Klan Oath of 1854, Philadelphia, Pennsylvania, leading to the altered and misleading contemporary history of modern western civilization, by the Franks and the Dutch Masters of Europe. The **“Dark Period”** conspirators against Moorish history and Geography had massive book burning, with the purpose of destroying or hiding the true history, culture and civilization of the Ancient Moabites/Moorish Asiatic Nation.

THE KU KLUX KLAN

The Ku Klux Klan are the Grand Protectors of the Christian Creed; having a Constitutional Oath. Their devoted mission is to protect the Albion (European) Nation from all alien intrusion into the Union of States Society and to keep the defeated Moors from marrying into the conquering pale skinned nations of Rome; whereby their weak genetic Albinus strain would definitely be lost forever. For further reference, research the Daughters of the American Revolution (D.A.R.).

The secret political, genetic and economic motivating KEY to the K.K.K.'s firmly held position is the unwavering truth that NATURE HOLDS WOMAN as the CENTRAL GENERATING POWER of LIFE and KEY to CIVILIZATION. The natural and political truth prevails ... that genetics and economics are one! If the Albino (European) women are taken as mates by the Moslem Moors, then it would be just a short time (a few generations) before the recessive Albinus genes of the European Tribes would be dominated by the melanin of the Moors. Hence, the dissolution of the Albions: and their mythical teachings of albino superiority. The ensuing disillusionment among the mystified “blacks/negroes” would definitely bring about the exposure of their fictional “Color-of-Law” sovereign authority claim. The final destruction and fall of the occupational Colonial Powers and their false image G.O.D. of the mythical White Supremacy would be inevitable.

The hardened position of The Grand Protectors of the Christian Creed (K.K.K.) is not necessarily personal, but National and for the social, economic and political maintenance and survival of the Roman Empire seated in the “West”. The Grand Protectors are knighted to preserve the Albinus strain and **Christendom's** iron-handed grip on the conquered Moabite/Moorish lands. This is why Klanners have always threatened to neutralize or kill some of their own, who [through any power or political manipulation] do anything which would or could cause or establish any true or permanent political or social improvement, relative to the “negroes/blacks” (enslaved Moors). A Slave, capable of true possession of wealth and sovereign knowledge, can bring about conditions that would change their legal “status”. Know – absolutely – that a tyrannical government's most feared category of knowledge exposure to “slaves and wards” is that of PARENTAGE and BIRTHRIGHT SOVEREIGNTY.

If the above stated civic truth is clearly taught to slaves and wards – it would follow that many “blacks” who did not understand the cold-natured politics of the Europeans in the Americas, would undoubtedly see and know why they (European Colonist) have assassinated many of their own elected politicians, industrial leaders, and some of their “black/negro” agents, who, having a secret oath and benefit – betrayed their allegiance to them. their oath-bound agents are, and were always aware that the Europeans stole the BIRTHRIGHTS of the Moabites/Moors, and had branded the Moors as BLACKS.

This strange social conflict in North America (the North Gate) is “fruit” of the old and continued BATTLE of the Roman Empire against the Moorish (Ottoman) Empire. The reason most “blacks” are confused is that they have forgotten themselves [Moors] and have little knowledge of the true, but “secret” history! The myth of “White Supremacy” is given artificial life in order for the “Colony” to survive. Historically [by OATH] the Christians would quickly lynch a Moor for violating the TABOO laws of the Black Codes – especially a Moor mating with or marrying a European woman. This is called in the mystery code, tubal Cain; the Mix that kills the Dragon! In this instance – Tubal Cain means “TWO TESTICLES and a PENIS” – implying sexual relations between the “Moorish males” and the Albinus European “females”. The “Death of the Dragon” implies the inevitable “genetic” elimination of the “Albinus European males”, by cause of nature taking her course. Albinism has never been supported by nature on a large scale, therefore, as a living and thriving specie, the “Albinus Gauls” (Europeans) can only maintain any large numbers by political force, genetic experimental manipulation and artificial social laws.

Knowledge and understanding solves all mystery! From this hidden truth, comes the motivation for the Union of States’ policy of “WHITE SUPREMACY” Moors! Know the truth and be free of hate and ignorance. Be yourselves – reclaim your Nationality and your Birthrights! Ignorance is the Greatest Sin!

If one would understand the social and economic motivations of a political body, one would know what seeds in history were planted that produced and motivated today’s National and International social and civic policies. The mission of the Ku Klux Klan should not be judged by emotion or hateful opinion, but on merit of the factual history. The empowerment of any people is only through their true BIRTHRIGHT knowledge and the authoritative activities of their national sovereignty. Moors need to know these facts – as it applies to them – and need to discard the multiple slave brands and marks they have learned to cherish.

There is clearly a solemn rule – held prominently among Klanners – and it is undeniably true; that rule is; a dedicated determination to be themselves and not someone else! Klanners honor their Mothers and their Fathers. Klanners do not falsely claim the pedigree/parentage names of another nation of people (ie; Moors). Klanners do not impose themselves on other people’s Creeds and Religions. Klanners love and respect their Albinus Genes, in spite of their weakness to the very Sun ... which gives life. Klanners are not preoccupied with openly trying to mix with Moors. Klanners, as a general rule, do not alter their bodies, hair, eyes, or skin to imitate the Asiatic Moors. Klanners generally care for and strive for the preservation of their specie. Klanner care for and defend the weak and disadvantaged among their own. Question:

Can the above be honestly declared as being mean or evil? Is not self-preservation a divine law of nature? Are Klanners in violation of Nature's law by trying to preserve their Albinus Genetic Strain? Study Nature's laws 0 then you be the judge!

The above statements do not preclude the fact that the Albions originated from the Moors, or even the fact that European Colonists have always sought after, raped, mated and mixed with the Moors whether openly or in secret. Time and history has always exposed the hypocrisy of all people, whether Oriental or Occidental, as nature has no respect for the false "race" positions propagated for political and economic subversion. However, with that being said, the Klanners (Europeans) are the true minority, in numbers, on the Planet Earth! Their fear has much of its origin in this fact!

There are always lessons to be learned in the ongoing Human experience. Although the Europeans have taken a position of enmity with the Moors, it DOES NOT establish as TRUTH that all they may do or say is, therefore, wrong! Thinking and reflection is the responsibility and business of man! No problem [of any magnitude] can be solved in the American (Al Moroccan) experiment and experience, if objectivity is not applied while seeking solutions to a problem. The determined position held by Klanners should be a lesson in survival to all negroes and blacks (branded Moors) who are truly seeking independence from European Oppression.

The Ancient conquered Muurs/Moors have been rewritten in history as Carthaginians, Saracens, Black-a-Moors, Berbers, Arabs, Ethiopians, Puerto Ricans, Indians, West Indians, Africans, African Americans, etc... All of these are Moors, the descendants of the Ancient Moabites. This grand scheme of deception in modern western history is where the strategic war term, **"Divide and conquer"**, has its origin. Understand that there is but one history on this earth, relative to WOMAN and her SONS, and that is HUMAN HISTORY.

The purpose of RECONSTRUCTION is to separate the Indigenous Peoples from their native lands, thus, wresting control of their SOVEREIGNTY and RESOURCES (Heritage). This is the TRUE analysis of the theft of the MATRIX, came the highly cultivated and nurtured NIGGER INDUSTRY; the source of the PAST and PRESENT wealth base for the Union States; their CITIES, TOWNS, MUNICIPALITIES and Color of Law Courts (the Union Citizens). This hidden history exposes the truth and the motives behind the use of CODES, VAGRANCY LAWS, the RACE matrix (false) and ZONING. All of these and other social Programs are used to manipulate the economic residuals generated by using COLOR of Law to benefit the colony CLASS neighborhoods and persons. The STATES are the SLAVE HOLDERS through false law and fraud contracts and are the enforcers of the BLACL CODES of 1724. All the States use the Codes! The highly promoted RACISM argument is a COVER-UP and was contrived to divert attention from civic education or intelligent examination of the facts and issues "AT Law", which is the SOVEREIGNTY of the Moors, Constitutional redress and the unlawful European usurpation (colonization).

Gauls: The Moors were overthrown by the “Frances”, the Franciscans or ... Franciscan Brotherhood of the Roman Catholic Order of Christendom. The Frances are the **“Gauls” (gols)** – the Albinous Gauls.

Ghouls: The European Grand Body Politic of the “Ku Klux Klan” Order are called “Ghouls” (Goals). This is not coincidental. Do you recognize the relationship?

These days (contemporary), the Moors, in their branded status, are legally abused by Color of Law and coerced into fraudulent non-mutual ADHESION CONTRACTS (legalized theft); imprisoned with Color of Law and color of Authority; encouraged or tricked into using the slave holders’ false nation brands and labels (listed above). All this suffering and more, for a lack of knowledge! These psychological and legal war tactics deny them human right, protections and immunities AT law. However, if Nationalized in their true, National Sovereign Names (parentage), and made conscious of their Birthrights; they can learn the truth of LAW and HISTORY and begin to claim their HUMAN RIGHTS, in accord with de jure CONSTITUTIONAL LAW. A written National CONSTITUTION is the civic KEY to National and International rights, immunities and protections afforded a people of a nation. Nationality is the missing KEY element denied to, but needed by BRANDED people to be recognized by the International community of Nations, as Sovereign. This is the Honor of your Mothers, your Fathers, and the return of your MOORISH BIRTHRIGHTS. Moors! Honor your Mothers and your Fathers!!!

Moors are all and any dark and light olive skinned people of Asiatic Origin or African descent. The Creed of their forefathers is the Science of Islam. They are the Mothers and Fathers of the Human Family- founders of Civilization. The most Ancient Moabite Civilization; were Matriarchal.

The Science of Astrology was at the center of all the Ancient Great Civilizations; and is used today by all the powerful leading governments and their officials. All government officials, industrialists and religious leaders are well aware of these facts, although, most of them deny it in the public arena.

The Moabites/Moors have been sailing the old ocean and sea routes for thousands upon thousands of centuries. The Earth is not new to the Moors; nor is its Al chemical makeup. The Moors were metaphysical science, Navigation, Architecture, Agriculture, Geometry, Masonry, Art, Horticulture, The Laws of Nature, Cosmology, etc., etc..

The Moors have no valid reason to insist on being other than themselves in these days ... in spite of the political coercion and abuse. Moors should consider the probability that much of their abuse is due to their living in a false culture and not being themselves. The “Lost-found Nation of Moors” was never an issue of physical distance. The Moors have been mentally displaced from their own lands. The Ancient Moabites (our parentage) have already established Civilization and Science on this Earth. Moors should seek the knowledge and culture of their Mothers and Forefathers – honor them! The principle and lesson, implied, is self – preservation!

One who knows self is certainly better prepared and able to preserve and make progress for the self. Know Thyself! I, Self, Law Am Master. The “SPELL” of the Gauls is broken!

A FEW ACTUAL FACTS FOR MOORS – A PEOPLE IN ADVERSITY

1. Negro and black are synonymous – they mean exactly the same thing. Black is derived from English-Latin and Negro is derived from Latin. Black means Civiler Mortous, unconsciousness, debased social and moral condition and death.
2. The word America does not come from Europeans as it has been assumed, due to RECONSTRUCTED history. America is actually a corruption of the Moorish Latin words, Al Moroc, meaning (Al) descendants of (Moroc) Moroccans.
3. When the word, Christian is used by Europeans in politics, literature and history, it is definitely and only in reference to the Anglo-Saxon political and social economic system; European peoples; and their institutions. Christendom is void of benefit to any Oriental peoples or their political, social and economic conditions or institutions. Do not get emotional, for lack of knowledge, or take these facts personal; they are presented for your objective observation and benefit.
4. The commonly used word “White”, as applied to Europeans is a political CASTE label and not a national pedigree name. The Whigs Party, which was of the RED PEOPLES PARTY in Philadelphus (Philadelphia), with the 1854 to 1863 Emancipation Proclamation. This must be known and understood by all Moors, when making any serious social or political communications. These actual facts must always be considered and factored into all civic activities. They will prove invaluable as Moors address politics, economics, social change, fraudulent voting rights or benefits. Remember – all political activities and benefits are measured by status first (your nationality and legal standing), in all lawful or legal procedures.
5. The commonly used word, “BLACK” as applied to Moors is a political CASTE label and not a pedigree name. The colonizing Dutch Masters coined the “black” label, along with other adjectives, as appellations for their indentured Moors as void of rights “CHATTEL PROPERTY”. Blacks are categorized in government circles and amongst sensitive social engineering policy documents as “IT”.
6. Concerning the Americas, a number one (1) priority political position of all European colonists and their descendants is to speak to Moors only in terms of displacement. Displacement is a cardinal rule when referring to their relationships with or conversing with the Moors; especially those labeled as blacks and Negroes. This is a necessary tool of psychological warfare in the usurpation of the land and the Moors’ sovereignty. They teach agents among the Moors to do the same; issuing letters and degrees to them as political, social and economic incentives - Beware!

7. Notice and analyze the reference to the UNNATURAL ALLIANCE between the NEGROES and the UNION LEAGUES, as traditionally mentioned by Klanners. Examine carefully, the OPERATIONS AND PRICIPLES STATEMENT of 1868, by the order of the KU KLUX KLAN. This is clearly exposing the fact that NEGROES cannot and can never legally or lawfully be citizens of the Colonial Union of the United States and America. Any actions on the part of any government official, officials or citizens of the Union States, which imply to try to make Negroes citizens of their Union – by whatever means – is definitely a violation of the Constitution. The Constitution is the Charter and the Law of the Land from which their government derives any valid or dejure law authority. This position is correct and valid, on the part of the K.K.K., although generally not accepted as valid or Constitutional by naïve, unread or misinformed people. The word NEGRO, as an appellation to people, is a political caste status category. It was coined and designated to label displaced Moors who, by virtue of war, subjugation or mutual agreement, became the corporate chattel property of the Union of States European citizens and not citizens, themselves. Their U.S. of A. Constitution of the six European nations of North America supports this fact. Moors must stop trying to force themselves upon the members of the Union of States Society (U.S. of A.). Moors must also cease the active fraud of using the Albion/European Colonists' family surnames.
8. As NEGROES and BLACKS (synonyms), Moors have no rights AT LAW, that any (quote, unquote) WHITE man needs to or is obligated to honor or respect. Negro and Black etc., are false appellations. Muur/Moor is the true national pedigree of the subjugated people misrepresented as Black, and has standing AT LAW – nationality and internationally. The persistent and insistence of the use of the Black and Negro brands legally imply “acquiescence” At Law. Negro is not of the human family, but is legally categorized as “IT” or a “THING”, and has no human right to review or protect by any Constitution. This is the absolutely legal and valid position of the K.K.K. and the Union of States Society. Moors need to learn the truth about the danger of holding on to, substituting and using the fraudulent slave labels as identities.
9. A most troubling and effective political manipulation tactic has been used against the subjugated Moors in the Americas. That tactic is the placement of quote, unquote, “Blacks and Negroes” in token political positions, with pseudo-government powers, which are designed to trick, oppress, tax and maintain suppression among their own peoples. These range in the areas of Municipal Police, operating in a non-sovereign capacity, judges and politicians operating in a non-sovereign capacity and the sub-government agents and agencies – all with no true sovereign authority derived from the people they govern. This gives the appearance of the existence of mutuality and agreed sovereign relinquishment of rule and authority from the Negroes/Blacks who are unqualified [having no self-authority], to the otherwise, fake, fraudulent, usurpative and de facto Union of States Society corporation governments and Union citizenry. This Color of Law position is deceptively used to govern, steal and claim jurisdiction over indigenous Moorish people's birthrights, sovereignty, affairs and lands.

UNBIASED TEST AND EXERCISE

This test and exercise is suggested to Moors, in order to purge ignorance, emotionalism and stereotypical views. At the same time, it should promote a more serious study of what government is and where government derives its power. Understanding the **true bond between political entities appearing separate, the “Blacks and Negroes”** should be clarifying and correcting their lawful and legal status.

Civics Class – Step One:

To give an objective test or written report for analyzation and study – have an Instructor, Wazir, Facilitator or Supervisor remove the identifying titles from the Creed, Organization and Principles Statement of the Ku Klux Klan. Present the edited version of the same Creed, Organization and Principles Statement to the Civics Class or scholar body, purely on merit of its content. Be sure to remove all and any references to the K.K.K. from the text. The facilitator may choose to test more than once.

Civics Class – Step Two

Upon completion, let the entire Civics Class review, analyze and critique all the individual tests and written reports; one may or may not be surprised at the results. The content of the first tests – more often than not – center on anger and emotionalism, and are usually void of facts or problem solving resolutions. That would not be unusual. If objective approaches are used, the tests should reveal that sound reasoning prevails. Objective analysis produces more useable information, and harbors less prejudice and biased opinion. Such a test may quickly displace many false ideas and assumptions which are presently held by many oppressed people. They may also show the practical need of serious self-assessment, with more sound and reasonable opinions than are presently held by many mis-educated Moors. The first order of business in solving any social problems [in relating to others] is self-assessment. Unbiased thinking is the first step to truly changing social disorder.

RESOLUTION OF THE UNION OF STATES' SLAVE AND WARD PROBLEMS

The obvious answer to the political, economic and social problems in the Union of States (U.S. of A.) colorable jurisdictions is the return of the Moorish Nation's national names, birthrights and sovereign rights to self-government. This must include national land rights, with supports and protections of the international body politic of the extended nations.

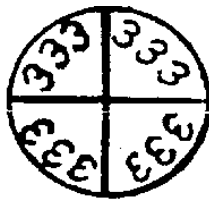

WHAT ABOUT THE KU KLUX KLAN?

Operations and Principles

1868

The Ku Klux Klan (kyoo' kluks' klan') is one of the two largest of the secret organizations of Christendom that flourished in the Southern territories of North America during the period of "RECONSTRUCTION". The Ku Klux Klan was founded in Pulaski, Tennessee, and is noted for its sincere and unmoved dedication and honor to the Christian Creed and to the Constitution of the Union of States. Tennessee entered the Union of States Society in the moon (month) of June 1, 1796 A.D. = 1216 M.C., and takes the honors of first home of the Klanners!

The K.K.K. order grew very rapidly in 1867 and 1868 A.D. = 1287 and 1288 M.C. The general organization of the Klan was perfected in May of the year 1867, at which time a "CONSTITUTION" was adopted. The second, and modern society of the Ku Klux Klan was founded in 1915 A.D. = 1335 M.C., in Atlanta, Georgia. The major aim of the Ku Klux Klan Order is the arbitrary regulation of life by "White Christian Protestant". Ku Klux Klan is also spelled with a hyphen, as Ku-Klux Klan.

A few of the other Christian secret Orders that merit study and review are:

1. The Knights of Columbus
2. The Knights of the White Camellia
3. The Society of the White Rose
4. The White League



KLANNERS

Klanner is the designation used to identify a member of either one of the secret societies. Ku Klux Klan is derived from the Greek word, "Kyklos" which means a "circle". The founders of the Ku Klux Klan were clearly using high cultured cosmological science in its structural constitution. The secret order was not founded by ignorant men, therefore, should not be viewed of dismissed as merely an outlaw organization of unreasonable people gone wild with hate and unconstitutional violence. This would be a very inaccurate assessment! Klanners have traditionally honored their Union of States Constitution with more orthodox respect than others who have criticized the Klan. Most critics have never read the U.S. Constitution!

GENERAL NATHAN BEDFORD FORREST

A union of States Confederate General Nathan Bedford Forrest was the first GRAND WIZARD of the Ku Klux Klan. The K.K.K. Order was effective in frightening the NEGRO out

of his UNNATURAL ALLIANCE with the UNION LEAGUES, but was also used as a cloak for lawlessness, land theft, and other forms of violence. The Ku Klux Klan often did the clandestine work which the Union of States' government officials would not openly declare or do in the public arena. In effect, the Ku Klux Klan was and is used as a willing scapegoat and partner of the Union Society for executing is derived from and/or supported by the States' Christian Black Codes; the Negro Acts; and other laws and ordinances governing free Blacks.

The Black Codes and Negro Acts could and would be animated and enforced, whether in the public or the private sector of the Union. The K.K.K. originated within the Union of States government circles, having the mission of preserving and protecting Christendom at large. If this fact is not known or understood; then one cannot objectively analyze United States of America's history, development and the reason of the non-ending so-called "race problem". The K.K.K. was and is part and partial and a non-official branch of their Union of States government, using the power of that government and pervading all levels of the Union government agencies to actualize their mission.

A lack of knowledge of the purpose and origin of the Ku Klux Klan, by Negroes and Blacks, has traditionally allowed U.S. of A. government officials to appear naïve and feign disassociation to the Ku Klux Klan Order. The mutual relationship of the Union of States and the K.K.K. Orders is as sound, as mutual and as natural as water being wet. Non-objective and angry truths mixed with frustration and inaccurate rhetoric, from the subjugated Black/Negro (branded Moors) communities, blinds them to the fact that they are not and cannot be citizens of the Union of States Society.

The "people who insist that they are Negro and Black" have yet to act or recognize the fact, the need and the necessity to form their own government; honoring their own Mothers and Fathers; and to cease and desist trying to force themselves into a sealed, "contract" Constitutional Union of which they can never be a part. This is one of the true root causes of the hostilities directed towards Blacks from the "Secret Orders" of the Ku Klux Klan (Kyklos/circle) and similar secret societies of Christendom. For the sake of truth, it must be said again that the position and purpose of the K.K.K. Orders is firm, dedicated and for the Empire. The Klans' focus is for the preservation of the Albionic minority and not as personal as it may sometimes appear to blacks. The K.K.K. is the in-house, work-horse arm of the Union of States Government and is serving well, as the Grand Protectors of the Christian Creed and Holy Roman Empire, establish in the Western Hemisphere on Moorish soils. Review the signatories of the Union of States' Constitution.

THE UNION OF STATES CONGRESS AND THE KLAN

The Union of States Congress took cognizance of the public opinions, reactions and recognition that the K.K.K. was confident and blatant in their hostile activities against "Blacks" and/or their "White" sympathizers. An obvious policy of connection and protection was

suspected. There was political need to feign separation between elected government officials, the Ku Klux Klan and other similar “Orders” and secret societies.

The bold and open activities of the K.K.K. Orders and others – such as the Knights of the White Camellia – was often exposing the Union States governments’ unlawful and ex post facto position with the issuance of the 13th, 14th and 15th Amendments. This caused rebellion and confusion among the citizenry and also cause many of the States’ “chattel” Negroes to catch on to the hoax. Their Congress passed the Force Act on May 31st, 1870 A.D. = 1290 M.C. and the Ku Klux Klan Act on April 20th, 1871 A.D. = 1291 M.C.

The Klan Acts were designed to discourage the open use of force and violence directed towards Blacks and Negroes who were trying to assimilate onto the contractually sealed political/economic Christian Union. The assimilation; activities by Negroes and Blacks were and is one of the great motivating factors of the Ku Klux Klan and similar Christian organizations. The passage of the Klan Acts, by the Union of States Congress, however, caused some of the complaining and festering distrust among the illiterate slaves (Blacks) to wane. Public “faith” in the “system” was tentative, but largely restored.

With hope and “faith” somewhat restored, (not that there was any choice) the hopeful Blacks/Negroes would willingly and happily fight in wars against their own people, falsely believing that they were Christian citizens of the Union; free and able to own property. Though clearly false – by any measure of law – the promise of cherished dream and would remain just that – a dream. The false citizenship promise and civil rights propaganda effectively buried the true solution oriented issues implying sovereignty discussions among the feigned-as-free “Blacks and Negroes”.

Reacting to rising social unrest, a Union of States Congressional Committee sat during the summer of 1871 A.D. = 1291 M.C., recording thirteen volumes of testimony on social, economic and political conditions in the South. The Unions’ Congress was caught in a political “conflict of interest” position. They were, having to pacify the displaced “Blacks” and at the same time avoid Constitutional confrontation with their own Union of States Citizenry, to whom they were obligated. For further references, see the “Report of the Joint Select Committee” ... United States of America, 42nd Congress, 2nd Session. Senate Report Number 41 on the Ku Klux Klan. The strategy conceived to calm the “Negroes” and continue to use them as an “economic base” and “cannon fodder” was highly successful and is still effective today (1990’s +).



ORGANIZATION AND PRINCIPLES OF THE KU KLUX KLAN



Appellation

This Organization shall be styled and denominated, the Order of the
Ku Klux Klan

CREED

We, the Order of the Ku Klux Klan, reverentially acknowledge the Majesty and supremacy of Divine Being, and recognize the goodness and providence of the same. And we recognize our relation to the Union States Government, the supremacy of the Constitution, the Constitutional Laws thereof, and the Union of States there under.

CHARACTER AND OBJECTS OF THE ORDER

This is an institution of Chivalry, Humanity, Mercy and Patriotism; embodying in its genius and its principles all that is chivalric and patriotic is purpose; its peculiar objects being:

First: To protect the weal, the innocent, and the defenseless, from the indignities, wrongs, and outrages of the lawless, the violent, and the brutal; to relieve the injured and oppressed; to succor the suffering and unfortunate, and especially the widows and orphans of Confederate soldiers.

Second: to protect and defend the Constitution of the United States, and all laws passed in conformity thereto, and to protect the States and the people thereof from and invasion from any source whatever.

Third: To aid and assist in the execution of all Constitutional laws, and to protect the people from unlawful seizure, and from trial except by their peers in conformity to the laws of the land.

TITLES

Section 1:

The officers of this Order shall consist of a Grand Wizard of the Empire, and his ten Genii; a Grand Dragon of the Realm, and his eight Hydras; a Grand Titan of the Dominion, and

his six Furies; a Grand Giant of the Province, and his four Goblins; a Grand Cyclops of the Den, and his two Night Hawks; a Grand Magi, a Grand Monk, a Grand Scribe, a Grand Exchequer, a Grand Turk, and a Grand Sentinel.

Section 2:

The body politic of this Order shall be known as “Ghouls”.

TERRITORY AND DIVISIONS

Section 1:

The territory embraced within the jurisdiction of this Order shall be coterminous with the States of Maryland, Virginia, North Carolina, South Carolina, Georgia, Florida, Alabama, Mississippi, Louisiana, Texas, Arkansas, Missouri, Kentucky and Tennessee; all combined consisting the Empire.

Section 2:

The Empire shall be divided onto four departments, the first to be styled the realm, and coterminous with the boundaries of the several States; the second to be styled the Dominion and to be coterminous with such counties as the Grand Dragons of the several Realms may assign to the charge of the Grand Titan. The third to be styled the Province, and to be coterminous with the several counties; provided the Grand Titan may, when he deems it necessary, assign two Grand Giants to one Province, prescribing, at the same time, jurisdiction of each. The fourth department to be styled as the Den, and shall embrace such part of a Province as the Grand Giant shall assign to charge of a Grand Cyclopes.

INTERROGATIONS TO BE ASKED

1st – Have you ever been rejected, upon application for membership in the Ku Klux Klan or have you ever been expelled from the same?

2nd – Are you now, or have you ever been a member of the Radical Republican Party, or either of the organizations known as the “Loyal League” and the “Grand Army of the Republic”?

3rd – Are you opposed to the principles and policy of the Radical Party, and to the Loyal League, and Grand Army of the Republic, so far as you are informed of the character and purposes of these organizations?

4th – Did you belong to the federal army during the late war, to fight against the South during the existence of the same?

5th – Are you opposed to Negro equality, both social and political?

6th – Are you in favor of a white man’s government in this country?

7th – Are you in favor of Constitutional liberty and a government of equitable laws instead of a government of violence and oppression?

8th – Are you in favor of maintaining the Constitutional rights of the South?

9th – Are you in favor of the re-enfranchisement and emancipation of the white men of the South, and the restitution of the Southern people to all their rights, alike proprietary, civil and political?

10th - Do you believe in the inalienable right of self-preservation of the people against the exercise of arbitrary and unlicensed power? ...

... 9. The most profound and rigid secrecy concerning any and everything that relates to the Order, shall at all times be maintained,

10. Any member who shall reveal or betray the secrets of this Order shall suffer the extreme penalty of the law.

ANCILLARY

1. **Coterminous:** Derived from the ancient Moorish Latin word, *conterminous*. < *com* – *together* + *terminus* – *limit*.
2. **Emancipation:** The act of emancipating. The state of being emancipated. Liberation from bondage, disability or bondage. Liberation from any injurious or undue restraint or influence. In ROMAN law, the enfranchisement of a MINOR from his father.
3. **Enumerate:** Derived from the old Moorish Latin word, *enumerate/enumerates*. < *ex* – *out* + *numerate* – *count*. To count or ascertain the number of: to name one by one; list.
4. **Exchequer:** The administrative department of the British government having the management of the public revenue. In England, an ancient common law court taking cognizance of matters connected with the public revenue. In 1873, this Court of Exchequer was made a division of high court of justice, and in 1881, this division was merged in the Queen's Bench division. In modern government structure, Exchequer is relative to Consular posts.
5. **Franchisement:** The result of a franchise. Franchise means to extend a special privilege to do certain things conferred by government on individual of corporation, which does not belong to the citizens generally by common right. A granted or sold privilege such as the use of a name or sell chattel, products or services.
6. **Inalienable:** Not subject to alienation; the characteristic of those things which cannot be bought, sold or transferred, such as one's rights at birth or birthrights – from which the agreed civil law of government arises.
7. **Interrogation:** The act of interrogating; questioning or query.
8. **Naïve:** Not consciously logical; artless; lacking sophistication; unthinking character; questionable reasoning ability; ingenuous.
9. **Proprietary:** Pertaining to a proprietor; subject to exclusive ownership. Designating an article, a thing; a device; a mechanism or medicine protected as a name, composition or process, by copyright patent, secrecy or other means.
10. **Province:** A considerable country relative to and/or a part of a kingdom or Empire and subject to a central administration without having itself a voice in that administration.
11. **Self-preservation:** The naturally ingrained urge to protect oneself from destruction. This is a common trait in all living things – nature's commonly granted self defense mechanism.

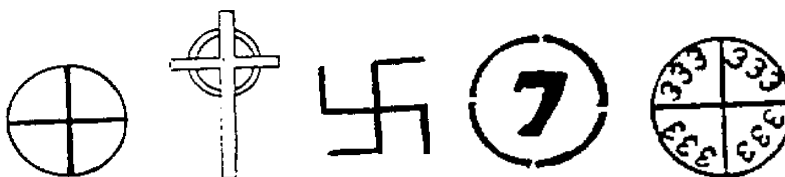
12. Supremacy: The state of being supreme power and/or authority.

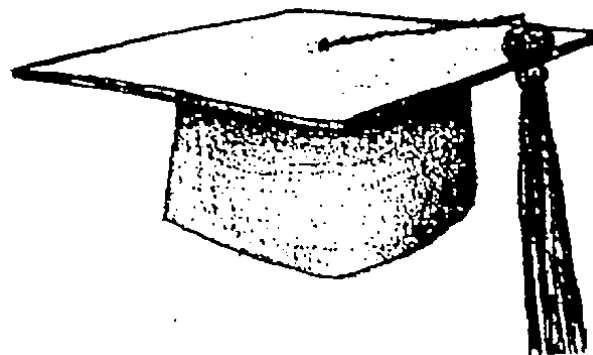

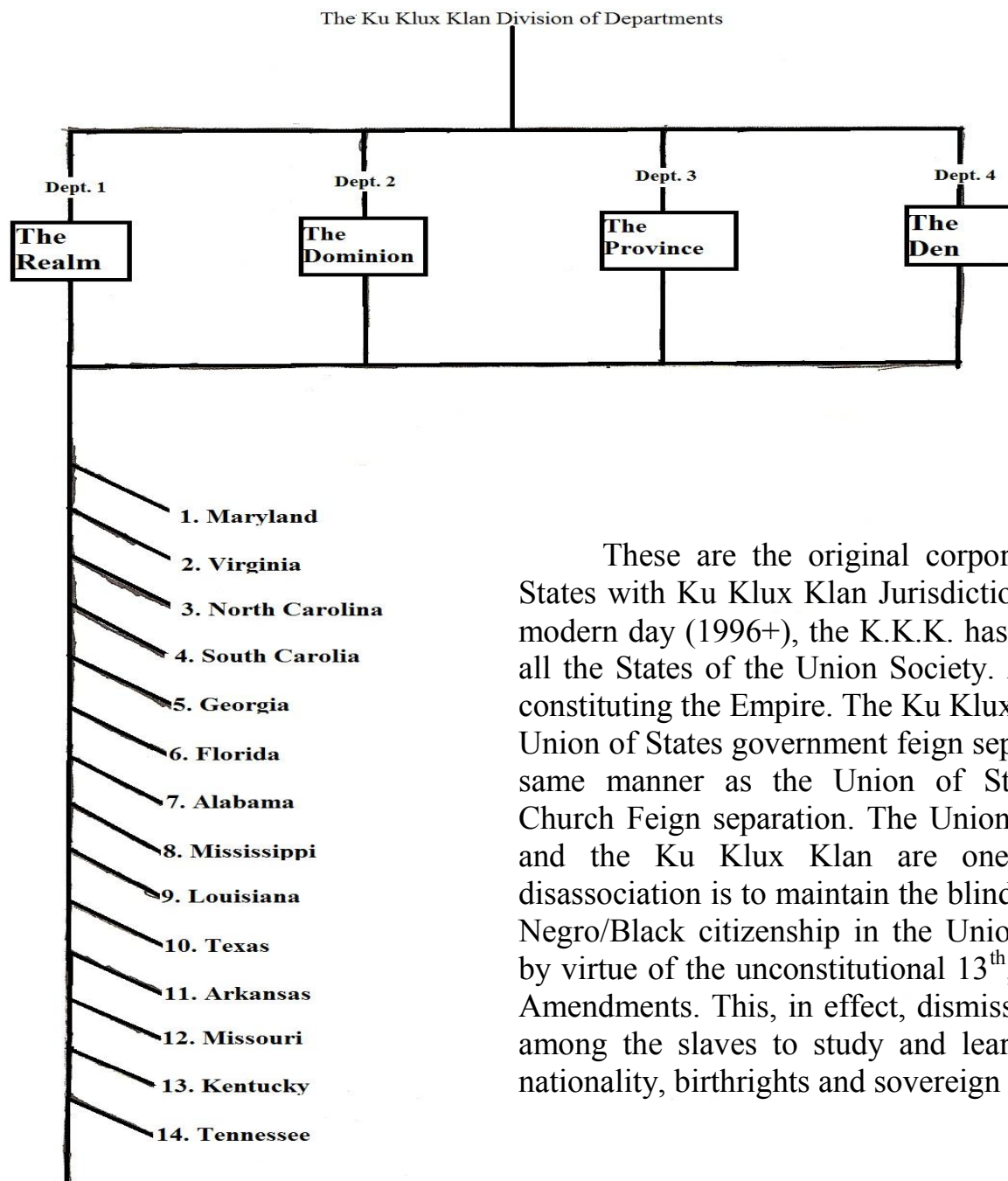

FEZ

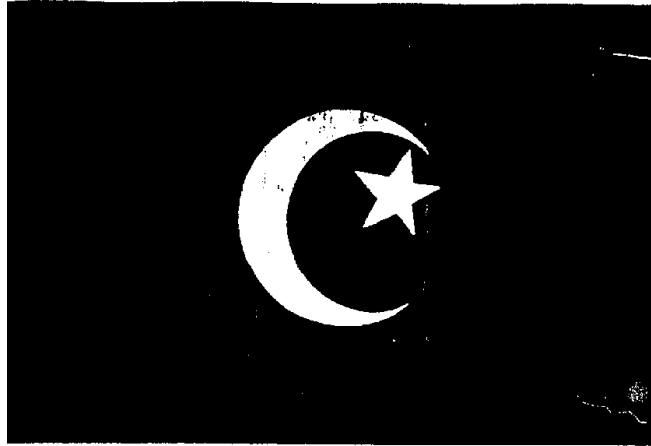

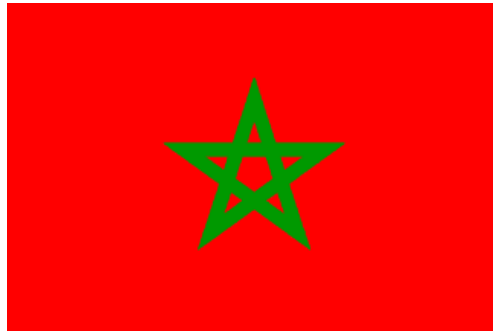

The Old Canaanite Temple emerged as the Moorish Holy Temple of Science. Since 1928, the M.H.T. of S. has adopted, as its corporate name, The Moorish Science Temple of America. To use the word profound would be an understatement, when referencing Prophet Ali’s Teachings and instructions. We as conscious Moors have been remiss in our responsibilities and
