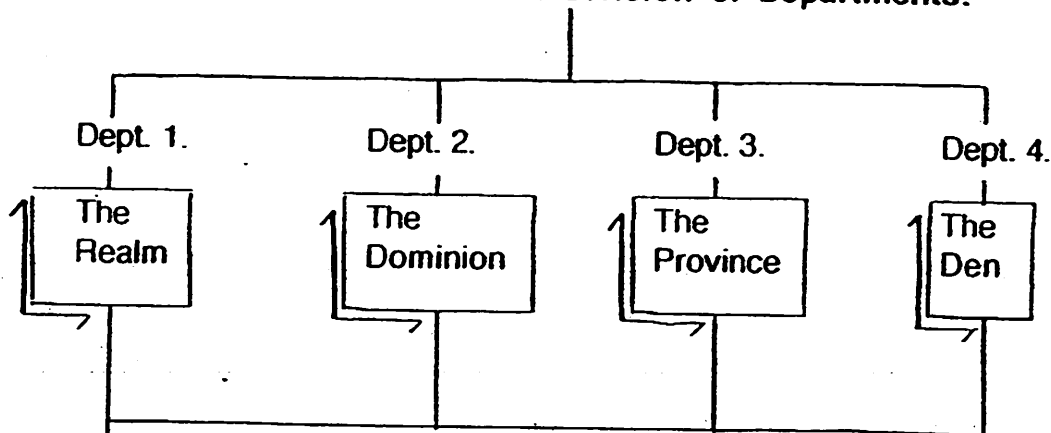


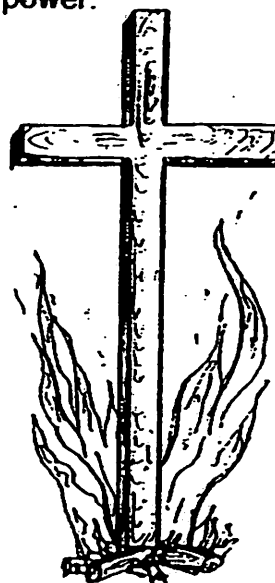
## The Ku Klux Klan Division of Departments:

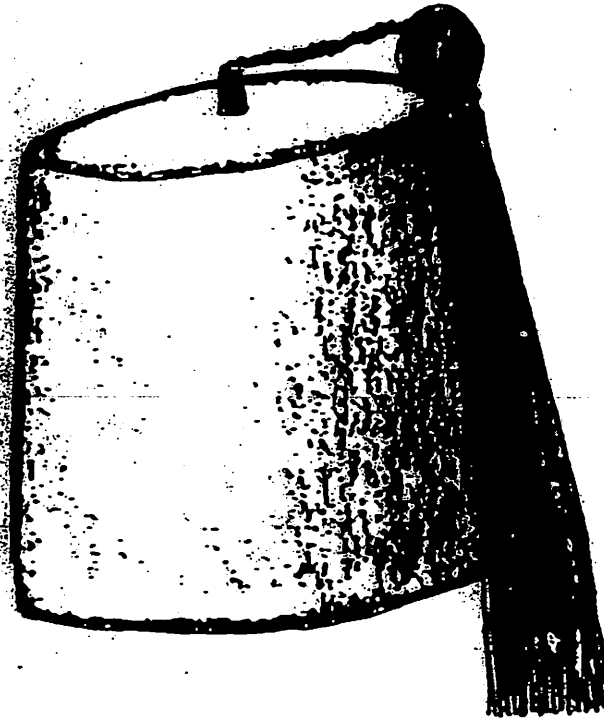

**The Fez is red felt, with an indigo black tassel.**

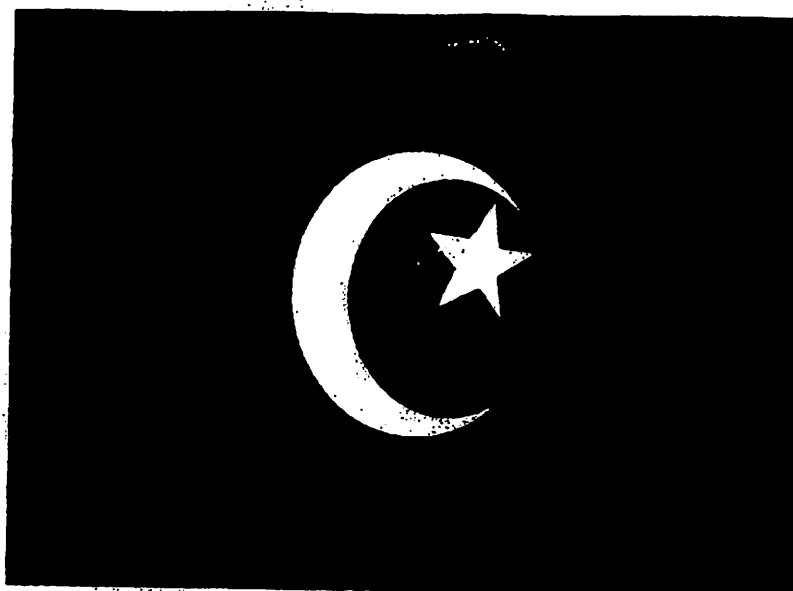

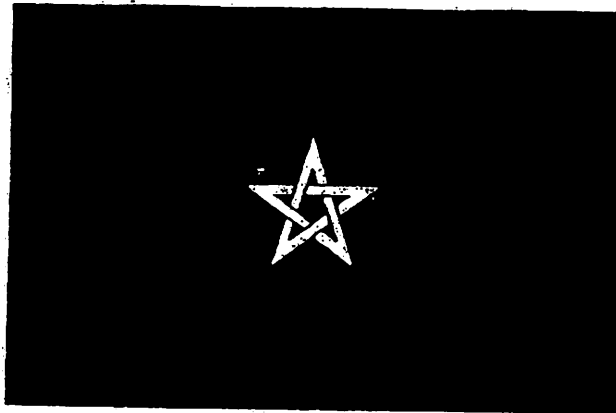

## The National Flag of the Moabite Moorish Nation of North America (North Gate)

### **Opening Statement**

Blunt truth is not a popular or respected entity amongst those who love, promote and benefit from the lie. This state of MINOR MIND (minority) exists for lack of knowledge of self and the true and suppressed history. The KEYS to the mysteries of the WEST have been released! Use them to grow and regain your rightful place within the Family of Nations.

Herein are many bits and pieces of facts and information which are exposed to clear away the haze, confusion and misconceptions of the human experience in the Americas (Al Morocs). They will reveal the SOCIAL CASTE structure! Freedom can never exist for a people who will not face Truth and befriend Her!

To aid and prepare the reader for some of the discomfort which will be and needs be, is unavoidable. The suggestion is made that the reader do further research into national war records and international world history. The Union of STATES' institutions will never teach or reveal those truths necessary for the indigenous people (Moors) to be free.

One more helper to the people. The word STATE was substituted for the word COLONY. The Albion peoples have usurped the LANDS of the indigenous MOABITE/MOORISH tribes in the WEST! When State governments issue laws or decrees for the citizens' benefit, they refer to and represent the Colonists and their descendants only!

THE READER MUST BE COGNIZANT AT ALL TIMES OF THE TRUE HISTORICAL PROCESS OF THE DEVELOPMENT OF THE DESCENT NAMES OF AMEXEM. THE FOLLOWING ARE THE ACTUAL NAMES WHICH HAVE BEEN APPLIED TO THESE 2 CONTINENTS. NORTHWEST AND SOUTHWEST AMEXEM was later called NORTHWEST AND SOUTHWEST AFRICA. NORTHWEST AND SOUTHWEST AFRICA was later called NORTHWEST AND SOUTHWEST AL MOROC (America). AMERICA is a corruption of the Moorish Latin words, Al MOROC. Al MOROC means (Al) DESCENDANTS of (Moroc) MOROCCANS.

## **INTRODUCTION**

The foundation information of the Church and State connection (the Inquisition and the Black Codes) in the enslavement of the Moors (labeled negroes, blacks, coloreds, Latinos, etc.) as described in this lesson book, is based on fact and research. This civic lesson book is not being presented to attack anyone's beliefs or areas of mental security. This text serves the purpose of exposing true knowledge and history to my people (Moors), who have been deceived by those who have, and are presently abusing, mis-teaching and misdirecting them due to their lack of knowledge. Truth needs no apology! Law is issued from the birthright! Birthright is reclaimed!

A most mis-analyzed and devastating social and economic condition exists in the United States of America Corporation and pervades all territories and jurisdictions under her political control. In this instance, the issue is in relationship to the forced **CIVIC DEATH** (civiliter mortuus) experienced in all areas of society by Asiatics with melanated skin. All people branded with negro, black, colored, indian, west indian, African, latino, hispanic, puerto rican, etc., who are subjected under European Colonial Government, are regulated by the hidden, yet **INSTITUTIONALIZED CHRISTIAN BLACK CODES** of 1724. The existence and operation of the CODES remain unknown to the majority of its victims.

The democratic **CHRISTIAN BLACK CODE SYSTEM OF CHURCH, STATE AND MUNICIPAL GOVERNMENT** was developed by the occupational FRANCISCANS and the occupational COMPANY/GUILD forces of European Albion Nations in the Americas. The **BLACK CODES** were structured and adopted in the early 1700's, to govern the Moorish tribes, defeated in the ongoing wars in the Moroccan Provinces, popularly known as the Americas. The **CHRISTIAN BLACK CODES** will sometimes be referred to in this Lesson in abbreviated form. This will appear as **C.B.Cs.**

Though **"THE BLACK CODES"** pervade all levels of the Union States' governments, the **HEART AND SOUL ENFORCERS** of the **C.B.Cs.** are the Union of States - At - Large. All State Governments, quasi-government agencies, States' courts, Municipal, City and Borough courts and de facto, maritime and admiralty Traffic Tribunals are European Colonial **C.B.C.** enforcing corporations. They use coercion to force licensing, permits, State (Colonists') certifications, etc., on the Indigenous Moors.

These tentacles of the Colony/State governments are few of many. Blois (blwa) government backed slave and theft systems are fraudulently forced on and presented to indigenous (non-citizen) people, as law. This massive and sophisticated legal slave caste system is incorporated and works through cooperative networking. The **C.B.Cs.** are enforced by the States' own private corporate court systems, posing as Sovereigns over the indigenous people, their land and affairs. The originator and hidden buffer and placation balancer to the **C.B.C.** system is the organized Church - the secret and **SILENT UNION**.

Administrators of educational systems, religious institutions, industrial and financial institutions, with all the sub-divisional support systems under Colonial corporate rule, have always used the **"BLACK CODES"** as a policy guide. This (the **C.B.Cs.**) is the underlying truth, disguised in the so-called race relations (false) argument. Government officials, institutional officers and false CIVIL RIGHTS hustlers and promoters will never admit publicly that the **C.B.Cs.** are the KEYS to the modern CASTE SYSTEM economy - pretending to be unaware of them. The reason these people never solve the so-called race problems is because they are the source of them and the beneficiaries of the PROFIT coming out of this fraud and the people's misery!

The most successfully misrepresented body of thought, held dear, by the subjugated Moors of North America, is the fiction of their claimed citizenship within the Union States Society. Actions made on the part of ignorance and assumptions have created problems of compound proportions in the **BRANDED** people's communities and within the family structure. They are not and can never be citizens of the United States of America Corporation. They are, in such status, corporate property regulated by the States. The main persistent problem that persists among the subjugated people of the Al Morocs is that they do not know who the **ENEMY IS!**

## **The Race Game**

To continuously distort and hide the true history and nature of institutionalized Chattel and Contract Slavery in the Al Morocs (Americas), the RACE GAME was introduced as a distractive social argument. The RACE, COLOR and CREED moral arguments, including the institutions established for their support are propagated by proponents of the unconstitutional 13th, 14th and 15th Amendments, which have no operative value AT LAW. The RACE GAME has been, however, a highly successful RELIGIOUS AND POLITICAL "SOCIAL ORDER" CONTROL SYSTEM. It is used to promote NAIVE passivity and is often disguised as LAW!

The RACE, COLOR and freedom of CREED claims of equal JUSTICE and the people using them have never been truly protected by Colonial/State officials with Constitutional law in the United States of America, or in any province or territory under their U.S. CORPORATE jurisdiction. The reason this can be said is that the 13th, 14th and 15th Amendments are attached to the Bill of Rights and not to the Constitution or any De Jure law. Any laws made, or which may be proposed to be made, using the above Amendments as a foundation are not and can never be the LAW of the land. Any laws made relative to the 13th 14th and 15th Amendments are negative law.

The 13th, 14th and 15th Amendments are unconstitutional due to their ex post facto nature. No law made from them can be valid AT LAW. All SUPREME laws within this Country's jurisdiction must have the power of the Sovereign Authority of the Organic 7 Articles of the Constitution of the Republic of the United States of America to back them up. Granted that the masses have been fooled by the maneuvering and passionate arguments made over CIVIL RIGHTS issues; however, skillful arguments and activities centered around sensitive social issues and problems do not mean Constitutional law exists to support them.

A people who are not free in the mind, can never be free in the body. Is it any wonder that the people accepting the labels, negro, black colored, indian, west indian, latino, etc., are not free in their own lands (Al Morocs/Americas)! Question: If the people had been educated and taught the TRUTH about themselves and how laws are made, why then, are they not free? Why do the people debase themselves and hide behind deceitful COLOR OF LAW and opportunist BLIND FAITH STATE APPOINTED LEADERS who are claiming RIGHTS and FREEDOMS that do not exist for displaced people under the Constitution of the United States of America? Is HYPOCRISY a fair word to use? Maybe hypocrisy is an understatement!

The truth about Sovereignty and the basic origin of law must be taught back to the people. The Colonists and their descendants have deceived the indigenous Moors with the false beliefs that they, the Colonists, are the Sovereign Authority in the Americas. This is not true - this is not their land. The States (Colonists) have made claim to a sovereignty that is not their own. This is why they use the color code system against the indigenous peoples. This political subversion distorts the true fact that sovereignty comes from and through Nationality alone: When the Nationality of a person or people is publicly declared, the law of that nation becomes obvious to all who may be concerned. In turn, this civic knowledge exposes, who, what, when, why and where anyone's claim of authority resides.

An example of Sovereign Authority of any nation of people arises civically from their Constitution.

For example:

- A. The sovereign power of a Frenchman resides only in France and is expressed in French law through the written Constitution of France.
- B. The sovereign power of an Irishman resides only in Ireland and is expressed in Irish law through the written Constitution of Ireland.
- C. The sovereign power of a Kenian resides only in Kenya and is expressed in Kenian law through the written Constitution of Kenya.

- D. The sovereign power of a German resides only in Germany and is expressed in German law through the written Constitution of Germany.
- E. The sovereign power of a Chinese resides only in China and is expressed in Chinese law through the written Constitution of China.
- F. The sovereign power of a Saudi Arabian resides only in Saudi Arabia and is expressed in Saudi Arabian law through the written Constitution of Saudi Arabia.
- G. The sovereign power of an Englishman resides only in England and is expressed in English law through the written Constitution of England.
- H. The sovereign power of a Russian resides only in Russia and is expressed in Russian law through the written Constitution of Russia.
- I. The sovereign power of a Moor rightfully resides only in Al Moroc (America) and is expressed in Moorish law through the written Constitution of Al Moroccans (Americans).

Trusting that the reader can reason and has examined the examples above, recognizes the negative purpose of the politically propagated use of the words, negro, black, colored, white, etc. The deletion of names of nationality removes the knowledge of the origin and limit of sovereign power and/or right to make laws to govern one's own or others affairs. The lack of this knowledge is the basis and origin of the political ignorance that hinders the quest for rights and freedom that evades the people labeled "black!" Declare your Nationality and be yourselves! You are Moorish Al Moroccan (American).

When a Colonist (European) attempts to deceive you by such claims as: "We're all Americans - it doesn't matter what color you are!" Know that they are consciously playing on words with the confidence that you are ignorant of the truth of nationality, birthrights and the history of the WEST! This causes one to forget that those who have been governing and abusing your people are Colonists and alien to the land and to the lawful jurisdiction over the land and the people of the land!

When the RACE GAME is played against you, never fail to take the opportunity to ask any person who claims authority over you or attachment to any land what their nationality is. The person's answer or their avoidance of answering to a national name will reveal all you need to know AT LAW. The National name reveals a person's law and who and what that person is politically all about! If that person is an Englishman, his sovereign authority resides in England and he has no jurisdiction over you unless you are English too. He definitely has no lawful authority over the Moors or over the land (AMERICA)! If you understand the above, you can easily understand what COLOR OF LAW is!

The word, America is a corruption of the Moorish Latin words Al Moroc. The Americas are the ancient lands of the Moors, the descendants of Moroccans, who are indigenous to the land. Moors are the only true sovereigns of the Americas and the only true and de jure holders of the titles of Nobility in America (Al Moroc)! The colonists' claims as the sovereign people of the land (Americas) are false. The Colonists and their descendants cannot lawfully take on the Moorish titles of Nobility. This is further confirmed in their Constitution, which was derived from the indigenous Moabite Nation's Law. The titles of Nobility are ALI, EL, BEY, DEY and AL Moors, be yourselves!

**Civiller Mortuus (Civil Death)**

CIVIC IGNORANCE and CIVIC DEATH must be honestly and seriously addressed in the Moorish communities in the Americas (Al Morocs). If the Civil Death - long existing among the unconscious Moors - is not addressed with intelligence and progressive action, the consequences will destroy the Nation. The natural law of RECIPROCITY is activated and is not asleep. Nature will no longer tolerate the imbalance.

Civil Death is the social state of a people or person, who, though possessing natural life, have lost, or been denied by force, threat, duress or coercion and slavery, the natural birthright power of self - government. In this political state, there exists no civil social law benefit which is supported or backed by power of a National Written Constitution. No one, in a state of CIVIL DEATH, possesses any politically existing rights, immunities or protections which must or may be respected by those in power in a society, who themselves, are not CIVILLY DEAD. Civil Death is the basic ingredient for most social programs.

The forced and coerced Civil Death among the Moors is a ROOT CAUSE of the economic, social destruction and problems in the branded Moors - black, negro and colored communities and families. The enforcement of active and operative Civil Death of the Moors is a Colony/State priority made under the guise of STATES' SOVEREIGN RIGHTS. The STATES' RIGHTS arguments are and have always have been their argument to the claimed rights to their CHATTEL property - the defeated MOORS- branded and labeled negro, black, colored, indian, etc., and their usurped LANDS. See Article 22 of the Black Codes.

A "Bull" (edict) issued by the church, through Phillip II, in the year 1511 A.D. to remove and steal the Nationality, Heritage/Property, National Titles/Names from the Moors. The "Bull" of 1511 is cherished and honored by all Christian European Nations. The U.S. of A. is the head of the Holy Roman Empire in these days. The Bull also decreed that Moors would no longer be called Moors, but would be called Spaniards. This is why the Spanish - American wars are referred to in early United States of America History.

**The Colonizing Companies/Guilds**

The colonizing European Colony/States established Companies/Guilds, that are collectively Chartered and styled as the United States of America Corporation. These European/Albion nations number six (6) - they are:

The citizen members of the Union of States Corporation collectively use the political party CASTE WORD "WHITE". The social CASTE word, WHITE, as used in the Union States Society is a substitute for the true national names, and implies a political union only. The use of the caste word, WHITE, as a national name substitute serves to encourage the unconscious Moors to use the Union States' CASTE word, BLACK.

The BLACK CASTE - WHITE CASTE economic and social ranking system has amassed fortunes, unheralded in world history. The political WHITE caste represents the conquering Europeans and their descendants. The political BLACK caste represents the Indigenous defeated Moors and their descendants, who have been taught through schools and religion that they came from another land as slaves.

The inspiration for the democratic CHRISTIAN BLACK CODE system of government, without doubt, came from the Church INQUISITION. The Inquisition is often referred to in history as THE SPANISH INQUISITION. The so - called Spanish Inquisition is actually the INQUISITION AGAINST THE MOORS.

To tell the average branded person in society that slavery in the STATES never ended but was bureaucratized, supported and ordained by the CHURCH would be like waiting for snow in summer on the YUCATAN peninsula. The forced illiteracy policy of the CHURCH and STATE COMMUNION in Colonial State history has proven remarkably successful to a fault. The slaves are under the Romantic SPELL and love it! The Ordinances of the Union of States' governments are designed and used as instruments of economic and physical war against the indigenous Moors (labeled black).

### Moorish Latin

Due to a lack of knowledge of self, history, geography and records of war, many enslaved descendants of the Moors falsely believe that the only language of the Moors was Arabic. The Ancient Moabites/Moors developed and spoke LATIN. Hence MOORISH LATIN. Arabic was also later developed and spoken by the Ancient AL MOROCCANS. Contrary to popular belief, the European colonists did not bring Latin to the western shores of the Al Morocs. The LATIN language and the AL MOROCCAN PEOPLE were already and always here!

After the defeat of the Imperial Moorish Empire of the West, the conquering Franciscan Brotherhood officially adopted Moorish Latin as their own. They dropped or wrote out of the records the word Moorish and kept the word Latin. Moorish Latin was often referred to as the "DEAD LANGUAGE". The words BLACK and NEGRO mean stagnant and death and were applied to the defeated Moors. All upper level educational institutions in the West require the mandatory study of Latin.

The Romans (Franciscans) used and use the word Ordinance to project their CANON laws. CANON is an ecclesiastical rule or law enacted by a Council or other religious Church authority. The books of the Bible which are officially accepted by the Church are also called CANONS. In this context, ORDINANCE means or is related to CANON or ordained rule or law.

The direct descendants of the Romans in the Al Morocs (Americas) are the European Peregrinus (Pilgrim) Colonists. The word COLONY was later substituted with the word, STATE. Oppressed Indigenous Moors must never forget that the words COLONY and STATE are synonymous (the same) in the Social Politics of the Union States Society, U.S. of A.

Oppression, coercion and theft through de facto government fostered adhesion contracts and inveigled law is the lifeblood of the Colonial States' power. Therefore, in truth, there is no separation of CHURCH and STATE. They are ONE! Thus, from the Churches' CANON laws and ordinances of the FRANCISCAN BROTHERHOOD (The Roman Catholic Church) came the deceptive and coercive ORDINANCE laws of the slave holding STATES, towns, cities, municipalities and courts of the Union States Society of America.

### Romance

Moors should be well aware that the word, Romance is not, by origin, relative to love. Romance is a subversive tactical military maneuvering system of intrigue. Romance is also exaggeration, misinformation or falsehood. Romance, as a military strategy, was one of the psychological war tools used against the Moorish Empire of the Western Hemisphere (Al Moroc). Romance is in reference to things or acts initiated by or through the Roman rulers, Roman citizenry, Roman influence, the "Church" Inquisition, etc..

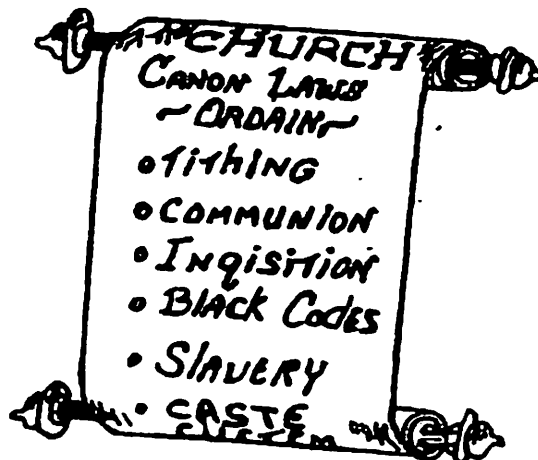
## Blind Faith

**BLIND** means the inability to see or perceive a thing, thought or principle. **FAITH** is believing without proof, trusting without tangible assurance. Blind faith mind control systems have demonstrated the willingness of the masses to assist in their own abuse and subjugation by well trained charlatans and religious god-sellers! Blind faith and ignorance as social engineering and caste system controls is vital to any tyrannical State. This necessitates the institutionalization of naive thinking in the minds of the people.

One of the commonly used cliches to inspire the **BLIND FAITH** masses into unjust wars, self destructive activities and unfair abuses of others is: **DO IT FOR GOD AND COUNTRY!** The Word, **GOD**, symbolizes the Divine Creator for the masses. The word, **COUNTRY**, symbolizes the **SOVEREIGN STATE** for the masses. The truth is that the masses have never been told the truth of what qualifies the word **GOD** or the political process and qualification for a **SOVEREIGN STATE** or its limit of authority. Neither the **CHURCH** or the **STATE** is true to what they profess or what the masses believe or perceive them to be. This is called **BLIND FAITH**.

## The Other **ORDINANCE** - spelled, **ORDNANCE**

Ordinance played a major role in the New World of European beginnings in the Western Hemisphere, and continues to play the same role today. When the Franciscan Brotherhood (Roman Catholic Church) overthrew the Moorish Empire of the West, they used what is Militarily called, **ORDNANCE**. The difference in spelling between the word **ORDINANCE** and **ORDNANCE** is that the letter "I" is dropped from the latter. The word, ordinance, spelled without the letter "I" still sounds the same, yet the meaning has changed drastically. The letter "I" is the 9th letter in the Alphabet. In Masonry, the Number Nine (9) represents the Moabite/Moorish Woman. The number 9 also means the geometric Great Seal.



Some of the things which have been ordained by the Romans.

The Great Seal is the Great Pyramid and Emblem of the Ancient Moabite/Moorish Nation. The number nine (9) is three (3) squared of three (3). This constitutes the Equilateral Pyramid, having three (3) angles and (3) planes, each of the three (3) planes representing one - hundred twenty degrees (120) .

Some of the Cannon laws, contributions and Ordinances from the Conquerors of Civilization, include direct and indirect culling methods against all indigenous peoples.

Observe the spelling of the two (2) words - **ordinance** and **ordnance**:

**OR • DI • NANCE** and **ORD • NANCE**. The letter "I" is dropped.

## **ORDNANCE**

Now let us review and define the word, **ORDNANCE**. **ORDNANCE** means military weapons of all kinds - cannons, guns, bullets, artillery, swords, military vehicles, germ warfare weapons, viral warfare weapons, enemy birth control systems and equipment, arms, armament, etc. **Ordinance** means machines, technologies and systems designed and used for killing, maiming, infecting, controlling or destroying a rival or enemy.

**ORDNANCE** is denotative of weapons used for destruction, war, genocide and death, yet is a subtle **REDUCTION OF THE canon WORD, ORDINANCE!**

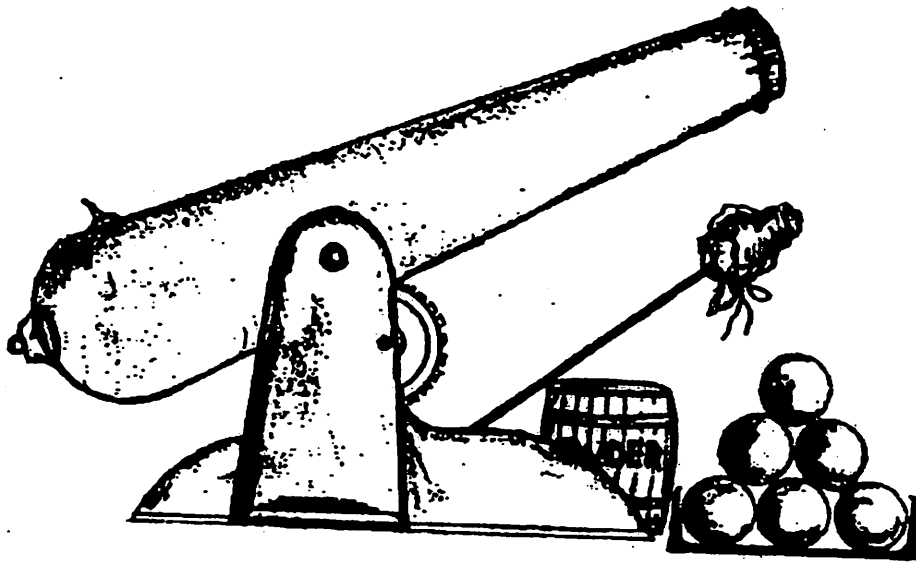
In the politics of the Church, the word, **ORDINANCE** means **CANON** rules and laws ordained by the hierarchy of the Franciscan Brotherhood. The **CANON** is **CHURCH LAW**.

In the politics of the States, the word, **ORDINANCE** means **ORDNANCE** rule and law by war. **ORDNANCE** is **CANNON** law, ordained by the Franciscan Brotherhood and enforced by the States. The war **CANNON** is **STATES' LAW**. They rule only by force of arms, not by any moral code of law. Never forget this fact! Colonists have no moral mode of operation!

The Church uses its **Ordinances** or **Canon Laws** to rule the oppressed Moors and the States use de facto **Ordinances (Ordnance)** or **Cannon Laws** to rob and rule the oppressed Moors labeled **NEGRO, BLACK, COLORED, PUERTO RICAN, LATINO, HISPANIC**, etc. There is no separation of Church and State, and there never has been...they are ONE! Observe the relationship of the words and break the "spell".

1. THE CHURCH ISSUES ORDINANCES ..... **CANON** (religious) **LAW**.
2. THE STATES ISSUE ORDINANCES ..... ( **ORDNANCE** ) **CANNON** (gun) **LAW**.
3. THE CHURCH AND STATE COOPERATIVE UNION FOR GOING TO AND FRO THE EARTH, DESTROYING AND DEVOURING NATIONS. THEY RULE THE CONQUERED MOORS BY **ORDINANCE** and **ORDNANCE** = THE CHURCH and STATE POWERS = **ORDAINED LAW BY THE GUN (CANNON)**.
4. **CANON** and **CANNON** = **CHURCH** and **STATE**: Both claiming Sovereign rights by **GOD** and **COUNTRY** - acting as the peace makers, yet are in actuality, the peace breakers! THE AVOWED ENEMY AND OPPRESSORS OF ALL INDIGENOUS PEOPLES, THE CHURCH AND STATE FALSELY CLAIM TO BE SEPARATE, WHILE FRAUDULENTLY PROCLAIMING TO BE OPERATING IN THE PEOPLES' BEST INTERESTS. WITH FEIGNED LOVE AND DECEPTIVE CONCERN, THIS HIGHLY ORGANIZED AND UNHOLY UNION ROBS THE PEOPLES' SOVEREIGN BIRTHRIGHTS BY FORCE OF ARMS (CANNONS).





The Cannon law and Ordinance of the Union States Society, U.S. of A. (ROMANS)

### Feigned Sovereign Voting Rights

The Union States' ORDINANCES are designed and used to maintain the economic and social oppression, servitude and control over THE DESCENDANTS OF THE DEFEATED MOORS, through FRAUDULENT ACTS, RULES, REGULATIONS, LAWS, AND COMPELLED TAXATION. All this without lawful representation!

The defeated and branded Moors have never been allowed to exercise their Sovereign Rights or have mutual participation in the Union States' governments! WHY? Because the Moors are not and can not be citizens in the Union States and the UNION STATES' (colonists) SOVEREIGN claim is a FICTION! The STATES are foreign Corporation Appendages- NOT THE LAND! The only true and DE JURE NATURAL CITIZENS ARE THE INDIGENOUS MOORS!

THE MOORS ARE... WE, THE PEOPLE OF THE LAND! The STATES/COLONISTS are ALIEN USURPERS and should never be viewed as anyone or anything other than JUST THAT - FOREIGN THIEVES! They unlawfully occupy the Moorish Provinces, commonly known as the Americas (Al Morocs)! The passage of time will never change this fact!

The Natural Law and Sovereign Power of the defeated Moors, branded, negro, black, colored, etc., has always been suppressed through and by the Colonies/States, using coercion and force. Even with the blindly respected Voting Rights Act, FRAUD IS THE FACT.

There is no such thing as voting rights for any non-Union citizens. Voting in the Union States Society for anyone other than the European Albion male is only by limited privilege. The Voting Rights Acts can never be law in the United States of America and can not be backed by Constitutional Law. Voting rights imply sovereign participation on the part of the subjugated Moors. This is fraud!

Even when the States' Slaves/Wards vote, they vote by privilege, not by right, using the European colony family surnames. This too, is an act of fraud on the SLAVES' part and is NEUTRAL of any true benefit AT LAW. This is why there is and has never been any profound or lasting progress in the WARD communities... irregardless of the number of voting participants! There is no firm or violent challenge coming from the European citizenry of the States, concerning the fake VOTING RIGHTS ACT, because they are well aware that the State Wards have no Sovereign power due to their STATUS as CORPORATE STATE PROPERTY - ARTIFICIAL PERSONS!

### **Lawful Plebiscite**

A **Plebiscite** is the lawful and direct vote by qualified voters of a Nation or State. Plebiscite is from the ancient Moorish Latin, PLEBISCITUM. PLEBEI is genitive of PLEBS - meaning COMMON PEOPLE. SCITUM means decree and to know. Thus, PLEBISCITE means, the People have spoken and/or decreed by Sovereign vote, that which they, THE PEOPLE, know that they decree as law or rule by their DE JURE VOTE in the public CIVIC arena by RIGHT.

The Corporate States, along with their Municipal lawyers and officers, are very confident that their incorporated and well compensated BLACK / NEGRO appointed LEADERS will maintain the FRAUDULENT STATE OF MIND AMONG THEIR TRUSTING AND WILLING WARD BELIEVERS! For among their constituents to seek KNOWLEDGE IS A SIN!

QUESTION: How can any intelligent Being register themselves and CAST A VOTE in the parentage name of a people, alien to themselves, and expect LAWFUL SOVEREIGN RECOGNITION AND BENEFIT! To VOTE IN SOMEONE ELSE'S NAME IS FRAUD! Can a person who willingly commit FRAUD charge someone else with human rights violations, which have been falsely labeled as RACISM?

THERE IS NO SUCH THING AS LAWFUL OR LEGAL FREEDOM FOR ANY PEOPLE WHO ARE HELD TO SERVICE OR SERVITUDE, WHO, CLAIMING TO BE FREE, HAVE NOT DIVORCED THEMSELVES OF THE SLAVE HOLDERS' NATIONAL AND PARENTAGE NAMES! THERE CAN BE NO LAWFUL OR LEGAL PLEBISCITE WHERE SUCH FRAUD IS PRESENT! WHY HAVE THE HONOR-LADEN SO-CALLED BLACK/NEGRO LEADERS NOT INFORMED THE STATE WARDS (SO-CALLED BLACK PEOPLE) OF THE FACT OF THEIR OWN VIOLATION OF LAW? YOU BE THE JUDGE! WHO STANDS TO BENEFIT FROM THIS CONTINUED IGNORANCE? WHY IS THERE NO CIVIC INSTRUCTION AND QUALIFIED DISSEMINATED INFORMATION OF WHAT A PLEBISCITE IS AND WHAT BEING IN ONE'S "PROPER PERSON" (IN PROPRIA PERSONA) MEANS?

### **Slave Politics and the Church**

The resulting POWER and BENEFIT of the COLOR OF LAW voting process perpetrated in the United States of America Corporation remains with the European-American colonists. The branded people's fraudulent use of the European national and family surnames seal their fate as CORPORATE STATE WARD PROPERTY. Therefore, all political and civic activities initiated by such (branded) persons becomes purely the acts of a THING as opposed to the rightful acts of a member of the human family. The WARDS (branded people) are legally the vested property of those who own the European surnames. The commerce relating to this CHATTEL activity, in all aspects, comes under the jurisdiction and enforcement powers of the States.

The Voting Rights Act is nothing more than a blind faith social pacifier, encouraged and propagated among the oppressed by the Church and States' ordained leaders. These Church and State ordained leaders are overseers and solicit unconscionable amounts of money and service from the poor in the process.

In order to control the political and economic activities of the subjugated Moors, the States would not allow any political gathering or activities among the Wards/Slaves, except under Church authority. The several States (using the Black Codes) have and do monitor all civic activity amongst State WARDS, using what they call MINORITY LEADERS or HELPERS. These agents are used as go-betweens, who drain resources from subjugated people's civic and religious organizations and groups.

Civic activities among slaves were only allowed under a Christian overseer (the Church). The overseers were usually a Priest, if European, or a Preacher or Reverend, if an enslaved Moor, branded black or negro. This is the States' past and present Black Code policy. Overseers are obligated to report any questionable or progressive actions or intents the wards and slaves make to a Church or State official. The overseers are usually given token political jobs by factions within the two (2) party political monopoly. The information gathered is then channeled through the Good Old Boy's Network to State agencies, who in turn use the force of regulation, taxation and Police Powers to neutralize the progress of the slaves. The Black Codes are enforced through Color of Law and ordinances, accordingly.

The tradition of all civic and political activities of the State Wards, labeled negro, black, colored, etc., being ordained, regulated and centered in the Church, has its origin in the Black Codes. The BLACK CODES ORIGINATED WITH THE CHURCH. The feigned "right to vote" among the "black" labeled people was definitely not a free sovereign activity. The same pattern still exists and is operating today! Church (Silent Orchestrator)- Overseer Agent (The open active enforcers) - State (The Directors). There never was a separation because the CHURCH and STATE are ONE! The end result for branded people is blind faith, unfulfilled high hopes, extraordinary monetary costs, loss of lives, packed jails, naïve and patient suffering, more blind hope, no rights, police brutality, abusive and arrogant judges (magistrates) and non-mutual, non-representative government officials, no lawful regress and recourse and no sovereignty or progress!

The long standing mystery and moral farce of the separation of Church and State is exposed. The days of superstition, guilt, fear, poverty, hatred, jealousy and competing idol-god worship, forced on the descendants of the defeated Moors, is coming to an expeditious and shameful end. The TRUTH shall make the people FREE! The SPELL - ing is broken. Mission accomplished!

### **The Moabite/Moors**

The Ancient Moabites are the founders of the first civilization on the planet called Earth. They are the Mothers and the Fathers of the Human Family - Asiatics and Moslems. The direct descendants of these dark olive skinned, thick lipped, kinky haired people are the Moors. Moors in the Americas are commonly called Moorish Americans. American translates from its origin, Al Moroccan. Al Moroccan translates as Al (descendant or down from). Hence, Moorish American mean Moors - descendants of Moroccans.

The first Ancient Civilization established on the Earth Planet was in Central Amexem on the Yucatan Peninsula - land of Mu. Today, Central Amexem is known as Central West Africa or in contemporary times,

Central America. The Tropic of Cancer runs through the Gulf of Mexico at approximately 23.4 degrees latitude - the Yucatan Peninsula lies on the south side of the Gulf. Civilization spread out over the Earth from this area. CENTRAL AMEXEM (AMERICA) is the true CRADLE OF CIVILIZATION. The powerful energy vibrations of our Ancient Mothers and Fathers permeate this entire area. It can be felt as if electricity and peace are one with the air.

For thousands of millenniums, civilizations were established all over North, Central and South Amexem - home of the Ancient Moabites - the Ancient Ones.

The direct progeny of the Moabites are the Moors. The Moors are the center of the human drama of the Western Hemisphere today. Moors are in ECONOMIC AND SOCIAL subjugation and conflict with the Albions/Europeans, who now occupy the Moorish lands by force of arms and Color of Law. The Albions have labeled the MOORS with the slave brands, NEGRO, BLACK, COLORED, INDIAN, LATINO, etc.

The ALBIONS are the last strain of the Human family or Modern Man. The Albions/Europeans are the result of the mixing of human and animal forms. The principal animal used in the ancient experiments of MEXICO and "PATAGONIA" is of the primate family known as NEGRO YAVIRA ARABO - the black Chimpanzee monkey family. This is referred to in Charles Darwin's archeological theory of man as the "Missing Link". An unknown primate is not the missing link. The MISSING LINK is actually the exposure of the covered up and true ancient knowledge and history of the mixing of the HUMAN and ANIMAL FORMS. These experiments were carried out by the Ancient Moabites and took place in Central and South Amexem (Southwest America).

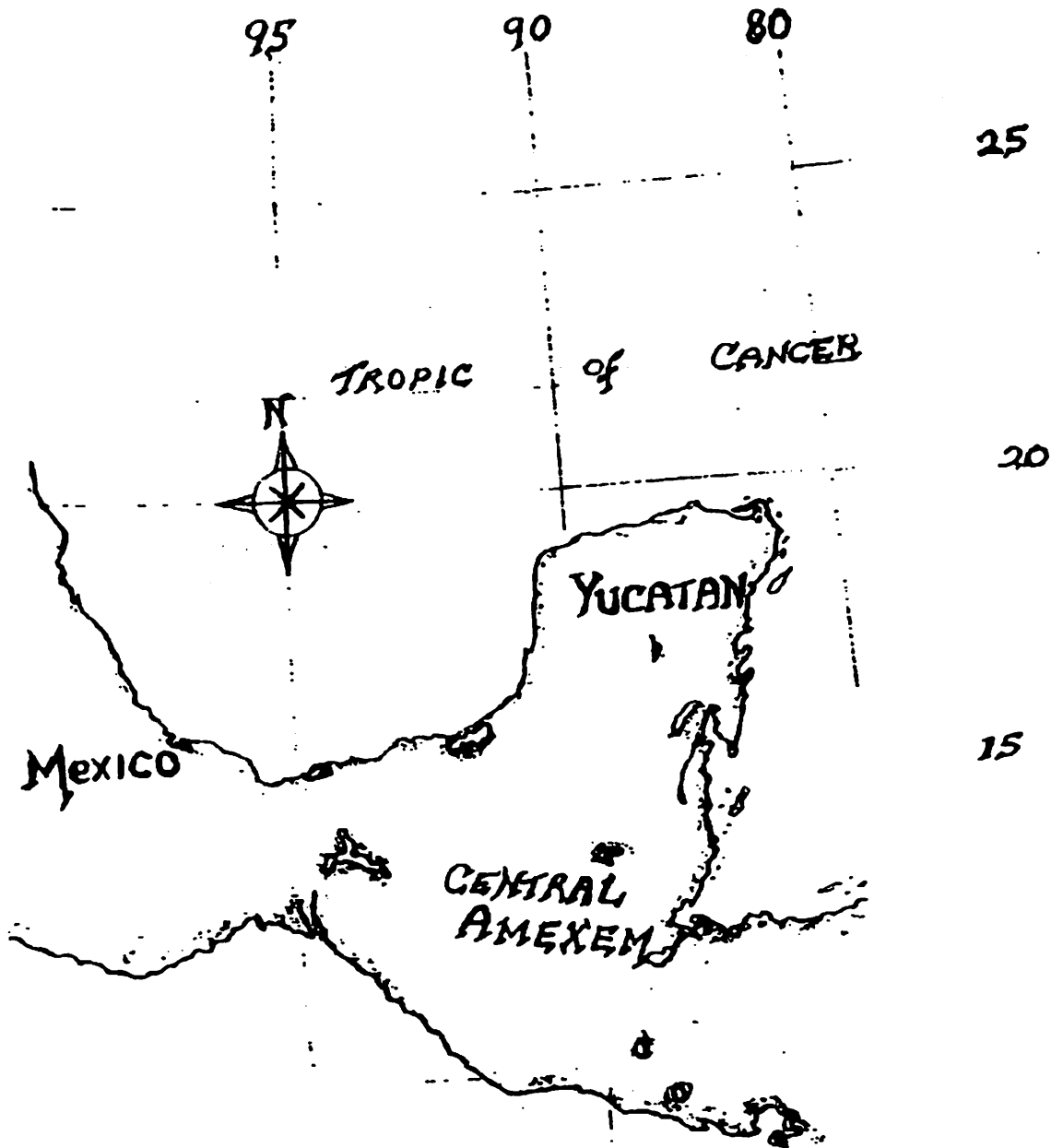
Since introduction into the civilizations of the Asiatic Nation, the Albions/Europeans have been going to and fro the Earth, devouring the Nations. The Albions' present (1982-3) center of operations is in the conquered land of the Moors - North America. The drama continues and is in the process of resolution. Some of the truths and "Secrets" of the Western Hemisphere must be exposed to take the "North Gate" and the indigenous Peoples out of darkness and ignorance!

Granted, the masses have been taught that the cradle of civilization was in the Continent known today as Africa in the east. However, Africa of the east side is not the archeological cradle of civilization, and the name Africa was applied to that continent in modern historical reconstruction, by European sociologists. The true historical cradle of Civilization is Central Amexem (America). The great and legendary ancient African Amazon river is in the area called Brazil in Southwest Amexem/Africa/America, not in the east African continent.

The Yucatan peninsula is located in Central Africa/Amexem, below the Tropic of Cancer, 20.45 degrees Latitude and 89.0 degrees Longitude. Today, Central Amexem is known as Central Africa/America. The Yucatan Peninsula is the true Cradle of Civilization of the Human race, and the Ancient Moabites are the founders of that Civilization. The oldest University in the world is the University of Yucatan, Mexico. Mexico means "the mixing". One of the oldest pyramids in the world is the Pyramid of the Sun, which is in the Yucatan.

To address the concerns of those who may have been misled by the Albion Conquerors of Civilization and those who accept their teachings...the following brief of information is forwarded.

The Masses of Humanity have been mis-taught and disoriented as to the true "Cradle of Civilization" by the European Archeological and Sociological engineers of mental warfare. This was done to remove (mentally) the original and indigenous Peoples from the land, creating disassociation and offsetting their consciousness of time. In order to achieve this, maps and calendars and history were changed. The three Great Pyramids at El Giza, Egypt have been presented as the oldest. They, to, are our pyramids, however, they are not the oldest. The word, Egypt is modern and is as fictional as the word, negro and black, when used to identify these Asiatic peoples. These names were also coined to separate. The word, Egypt is of European sociology, and means gypsy. The Moabites who are called Egyptians are of Mizraim. Do not be deceived.



The Yucatan Peninsula of Central Al Moroc (Amexem/Africa/America), is the true Cradle of Civilization. This great Masonic secret has been known for ages by the "Reconstructionists". Now it is time for the suppressed peoples of the world to "know the truth!"



### The Amazon River (Amazonas)

Southwest Amexem/Africa, showing the Amazon river in what is now called South America. The Amazon (Amazonas) river is in the territory known today as Brazil. The ancient Rio Negro enters into the Amazonas at the old city of Manaus. Rio Negro means the Black River. The Amazon (amazing) valley river area has a wealth of true history to be revealed to the descendants of the Ancient Ones. Study.

## The Fall of Tears

The Christian Peregrinus (Pilgrims) devised one of the most effective and demoralizing war tactics ever used. They launched a dedicated assault on the Moorish women and children whenever and wherever they came in contact with any of the indigenous Peoples. This wholesale slaughter system was also applied to animals, birds and anything which could support the reciprocal life-blood of organized civilizations in Canaan (Canada) the Northwest territory.

The infamous Christian "motto" IN HOC SIGNO VINCES, Latin, meaning BY THIS SIGN THOU SHALT CONQUER. This cherished "motto" is derived from CONSTANTINE THE GREAT - FATHER OF CHRISTIANITY. Thousands of unarmed Moabite/Moorish women were slaughtered at and around the Great Lakes of North Al Moroc. Literally thousands of Moorish women were beheaded at Niagara Falls.

The Moabite/Moorish Matriarchs have gathered and meditated at the Great Lakes for thousands of years. Now the conquering European Christians use Niagara Falls as a tourist attraction- blood for profit. Calling the Great Falls, "Nigger Falls", in jest and mockery of the slain unarmed Moabite/Moorish Matriarchs was common. This slaughter by the Great Lakes is also called, Niagara's Fall of Tears.

## Nationality and Birthrights Taken Away From the Moors

By the year 1774 A. D., 1194 Moorish Calendar year, most of the Moorish armies were defeated or in disarray in the Al Morocs (Americas). The European settlers did very little at first, they just studied the Moors/Muurs: the way they ate, the way they lived and acted, and their highly cultivated Nature Sciences.

Due to the long and arduous wars with the Albion colonists and the unchecked divisions among the indigenous Moors, the long lived Imperial Moorish Empire of the Western Hemisphere began to fall into disarray. The European Christian Peregrines seized every opportunity to promote those divisions.

By virtue of default, the Moorish Empire of the West was falling into the hands of the conquering Christian Inquisitionists. The Muurs/Moors in many of the conquered territories and provinces (Al Moroc/America) were put into slavery (involuntary servitude). All Public record, history, writings, literature, science books, art, etc., of the Moors and their teachings which could be found by the occupational forces were collected by the Europeans and burned- the great book burnings. Some of the surviving literature is preserved in private and public rare book libraries.

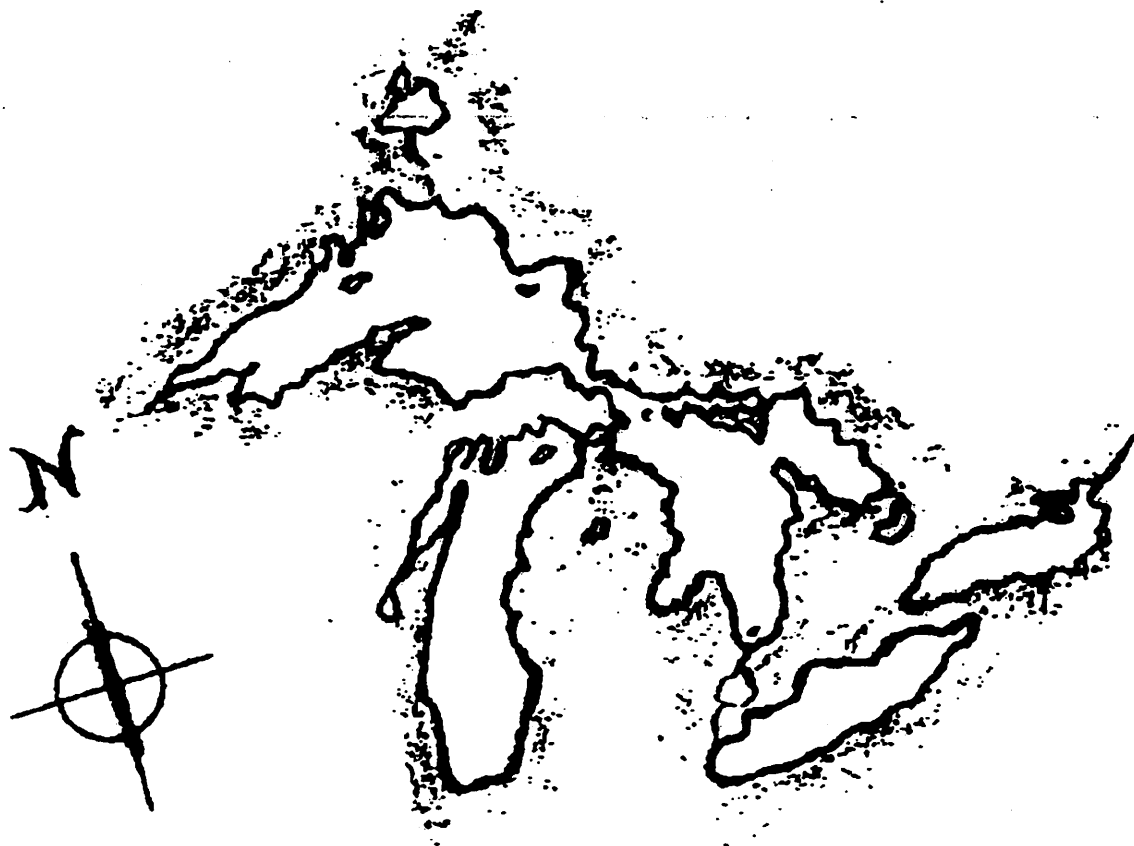
In the same year (1774 A.D. = 1194 M.C.), at 6th and Chestnut Streets, Philadelphia (Philadelphus), Pennsylvania, the defeated Moors were stripped of their parentage names, nationality and birthrights by the pervading Albions. The words negro, colored, black, and Ethiopian were placed on them instead. These words, when applied to people, are the infamous chattel brands. The national descent names of Noble Title, stripped from the Moors are Ali, El, Bey, Dey and Al. Most of the Moors in the Northwest Amexem Territories are Els and Beys; (dating back in ancient times to Abraham and Hagar, who were really Abraham El and Hagar Bey). Most Muurs/Moors in the Southwest Amexem Territories are Deys and Als.

## **The Five Great Lakes of Northwest Amexem**

The five ancient GREAT LAKES of the Imperial Moabite/Moorish Empire of Northwest Amexem are LAKE SUPERIOR, LAKE MICHIGAN, LAKE HURON, LAKE ERIE and LAKE ONTARIO. These Ancient Lakes have a combined surface area of approximately 95,000 square miles. They have supplied fresh water for the civilizations in the Western Hemisphere for compound thousands of years. The Ancient Ones (Moabites) called them the Atomic Lakes ( Lacus Atomus) of Mu - the Ancient Moabites. The conjoining of the mind and hands of Man and the Forces of Nature - in mathematical union- parted the Earth, and the **LACUS ATOMUS** came to be. The contemporary word lake is derived from the old Moabite/Moorish Latin word, **Lacu**.

The Great Lakes are located in Northwest Amexem. This ancient territory is known today as Northwest Africa and/or North America. The great lakes prominently rest approximately beginning 42 degrés north latitude at the south ends of Lake Michigan and Lake Erie and ending at approximately 48 degrees north latitude at the top of Lake Superior. Their Great Lakes longitudinal locations are approximately 93 degrees west longitude at Lake Superior and about 76.5 degrees east at Lake Ontario.

The Ancient Ones (Moabites) called the northern part of this area of Northwest Amexem - The Land of **Canaan**. Today, this territory is called **Canada** and the Great Lakes region of the United States of America.

On October 14th of 1774 A.D., the First Continental Congress met at Independence Hall at 6th and Chestnut Streets in Philadelphia, Pennsylvania- then the Capital of the defeated Continental United States Confederation Republic of the Moorish Nation. A result of that meeting was the preliminary enforcement of the first seven (7) Articles of the present day Constitution, known then as the Articles of Confederation - 1781 A. D. to 1789 A. D.

The enforcement of the Articles of Confederation law put the Moors, who clung to the chattel brands of negro, colored and black, outside of the Constitutional fold. This rendered them as undesirables, "At Law", thus, unable to receive the rights, immunities and protections as Citizens as provided by the Free National Constitution.

With the Moors being denationalized and classified as displaced persons, CHATTEL and undesirables, the slave advocates could openly use them to supply the lucrative slave labor, which was in great demand in the new de facto Colonial nation. This otherwise unlawful act could now be done without fearing reproach of the National and International Laws (Constitutions and Treaties). With no national name there cannot exist a national sovereign law (Constitution) for the law protection of such displaced persons or for other civilized nations to recognize.

### **Perpetual Slavery**

In 1774 A.D., the newly formed occupational Albion Colonial Nation was not recognized as lawfully having its own independence; therefore, the brand words negro, colored, blacks, etc., were not officially put on the records of the Moors but used extensively in actual practice. After the Unanimous Declaration of Independence of the newly formed Albion Union (1776), the altering of existing official records and documents began. This was the beginning of the contemporary PERPETUAL SLAVERY through bureaucratic organized de facto government! The words (brands and labels) negro, black, colored, etc., were coined by the Dutch Master colonists to describe enslaved Moors. This CODE WORD system created an avenue for maintaining social order with CHATTEL and FREE PEOPLE living and interacting within the broader social structure.

This CASTE CODE system is basically simple. To know who is a SLAVE and who is FREE, the slave catchers or Masters or State officer would need only to ask or demand NATIONAL NAME and TITLE. A free person/people would quickly make verbal and/or documented NATIONAL SELF-CLAIM. A slave would use the CODE WORDS negro, black, colored, etc., and/or a EUROPEAN ALBION NATION SURNAME. This would SEAL THEIR FATE and they would be seized, clearly a SLAVE, having no rights that a European Colonist would or need respect!

In these days (1982-3 A. D.), the Union States and their Agencies enforce and use the CASTE CODE SYSTEM using FORCE OF ARMS, STATE POLICE POWERS and deceptive FORCED ORDINANCES (ordnance). Fraud law, open political and court oppression are used when and as needed or necessary to MAINTAIN STOLEN STATE SOVEREIGN POWER over the unconscious and labeled indigenous Moors.

The present SOCIAL DISORDER and the COLONIAL ALBION UNION of 1776- Union States Society of America- are ONE related matter. This fact should never be forgotten by indigenous Moors or ever dismissed with time! History is a compiled record of relative human interaction. Always look at history from the perspective of CAUSE and EFFECT. Analyze history from an open OVERVIEW position - all things in the human experience are relative.

## Philadelphus, the Old Moorish Capitolum

Philadelphus (Philadelphia) is the name of the Old Moorish/Phonetic Capitolum of the Imperial Moorish Empire in the Western Hemisphere - Al Moroc (America). As the late Moorish government was being systematically dismantled, the Colonial powers were structuring a changed form of government - The United States of America (The Union of States Society), but, by Charter, remaining compatible with Moorish governmental principles. This was done with the instruction, teaching and assistance of the Moorish Prince called Big Ben Bey. In the reconstructed history, Ben Bey is referred to in Union States History as Benjamin Banneker.

## Moorish Zodiac in Philadelphia City Hall Courtyard

The spot where Philadelphia's City Hall sits was an old battle ground. The Cosmological Law of the defeated Moorish Nation - The Zodiac - is displayed in the Center of the building's open Courtyard. The courtyard has Four (4) Gates. The 4 Gates represent the four Cardinal points of the Zodiac. One Gate to the North, over which, William Penn is placed. One Gate to the South. One Gate to the East and one Gate to the West.

In the year 1776 A.D. = 1196 M.C., with the signing of the Unanimous Declaration of Independence, the Moors were divided as a nation, and the flag of the Moors was taken down by George Washington. This historical act is known as the proverbial "cutting down the cherry tree". The Flag of the Moors is widely known because of its bright red field with a five pointed green star in the center. The Al Moroccan (American) Continental Flag was also taken down by the year 1777 A.D.

## Moorish Slave Holders

It must be further noted that contrary to popular reconstructed history many Free Moors were SLAVE HOLDERS and were never slaves, themselves. Europeans were not the only slave holders. Many Europeans came in possession of slaves by virtue of taking over existing Moorish Estates. Many of the Old Moorish Estates were later called "PLANTATIONS". Slavery in the Al Morocs (Americas) was not a one-sided or new affair! EUROPEANS WERE SOLD AS SLAVES, AS WERE MOORS IN THE AMERICAS (AL MOROCS). This is why so many so-called blacks (branded Moors) fought in all the early wars. Because of the unknown history, many are led to believe that the labeled Moors (blacks) were unwilling soldiers. This is not the case!

The Moors who were slave holders were also strong supporters of the old Moorish Caste System. This was a major source of social strife and upheaval. The conquering Albion/Europeans adopted the old Moorish Caste System and added the Christian Black Codes and Color Caste Code System. This compounded an already corrupt social structure, increasing social strife. With many nations trading with and consorting with the Union States Society (U. S. of A.), the negative Caste and Color Code Systems debased and influenced many of their governments. It would not be unjust to say that nearly the whole world has been made corrupt by association. The past and the present are relative.

Wars and skirmishes continued even after the Constitution was adopted. The weakened Free Moors were eventually overthrown and many of them were put into slavery. Most of the Moorish Troops and Scouts who fought along with the Europeans were later disarmed, murdered, jailed and/or forced into slavery too. Many Moors thought the newly crafted colonial governments' debased BLACK CODE bureaucratic form of slavery would not be applied to them.

1779 A.D. = 1199 M.C., marks the time of the accelerated organized activity to put the Moors into perpetual slavery. The brand words negro, colored and black were put on their territory and state records. Many titles, documents and historical official public records were removed or destroyed, while others were altered to effect property theft by the stroke of the pen and assist in the economic overthrow of the Moors. At this juncture, it needs to be noted and clarified that perpetual slavery did not exist in America (Al Moroc) until 1779 A.D. = 1199 M.C. There is no argument that there are a number of writers placing the beginning of the institution of perpetual slavery at earlier dates, however, these writers have no valid records to prove such speculations and presumptions. All authoritative documented records fix the date at 1779 A.D. = 1199 M.C.

Reconstructed (Reconstruction) history is designed to separate the indigenous Moors from the Al Morocs (Americas) and imply that they are not indigenous but originate from what is now called the Continent of Africa. This "theft history" is promoted by lettered colonialist writers and their compromised black/negro/colored proteges.

With the winning of the American Revolution (Al Moroccan), the Founding Fathers, in 1787 A.D. = 1220 M.C., merely "adopted" and ratified the "Articles of Confederation" into law as the Free National Constitution of the United States of America Republic (1788-1789) - a new appendage and de facto United States. This law has never been changed, as well as declaring all men free and equal. Had the Moors not accepted the brands of negro, black and colored, etc., but had honored their Mothers and Fathers, they would have been recognized as Sovereigns, by name, nationality and principles.

If the Moors had answered up to the Constitutional standard of law in 1774 A.D., 1194 M.C., they would have received all the protections, rights and immunities of free National Citizens. They would not have been subjected to the disgustingly inhumane institution of perpetual slavery. Nations put their trust in Constitutions, Treaties and Law when dealing with other Nations.

On the contrary, the Moors adopted the false names and titles and strayed after the strange Gods of Europe (idol god worship)- a direct sin and act of disobedience. As a result, they were ensnared into being "willing victims" in a great conspiracy to keep themselves, the Moors in America (Al Moroc), totally ignorant of the truth about themselves, geography, their parentage names, nationality and birthrights.

The United States of America's Constitution excludes negro, black and colored people from Sovereign protection, and denies them citizenship, distinctly. A written Constitution is the key instrument for any organized sovereign government. This is vital to all national, social and civic order, law, and international interchange. The defeated Moors have been kept out of the Constitutional fold and unlawfully denied the "birthright" formation of self government, by force of arms.

To reinforce the theft of the birthrights of the defeated Moors, the Albion colonial Congress, operating contrary to the Constitution upon which they take their oaths, passed the 13th, 14th and 15th Amendments to the Bill of rights - pretending that the Constitution had been changed. The Constitution of the United States of America has never been changed - any scholar, professor, teacher or politician who says the Constitution has been changed is a liar! Research the facts for yourself!

Slavery is sealed and protected within the Constitution of the United States of America! Read for yourself! These 7 slave clauses are the basis for the "great" and continued argument of "STATES"

**RIGHTS!** No intelligent being needs a magnifying glass to read and see who the real and true slave holders are. The slave holders are indeed and without a doubt, the Union States Society jurisdictions and their agencies, at large!

### **The Seven Slave Clauses In The Constitution Of The United States Of America**

**ONE ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE I, SECTION 9, CLAUSE 1.**

"The migration or importation of such persons as any of the states now existing shall think proper to admit, shall not be prohibited by the Congress prior to the year one thousand eight hundred and eight, but a tax or duty may be imposed on such importation, not exceeding ten dollars for each person".

**TWO ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE IV, SECTION 4.**

"The United States shall protect ..., and on application of the Legislature, or of the Executive against violence".

**THREE ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE IV, SECTION 2, CLAUSE 3.**

"No person held to service or labour in one state, under the laws thereof, escaping into another, shall, in consequence of any law or regulation therein, be discharged from service or labour, but shall be delivered up on claim of the party to whom such service or labour may be due".

**FOUR ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE I, SECTION 8, CLAUSE 15.**

"To provide for calling forth the militia to execute the laws of the Union, suppress insurrections and repel invasions".

**FIVE ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE V**

"... Provided that no amendment which may be made prior to the year one thousand eight hundred and eight shall in any manner affect the first and fourth clauses in the ninth section of the first article".

**SIX ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE I SECTION 9, CLAUSE 4.**

"No capitation, or other direct tax, shall be laid, unless in proportion to the census of enumeration herein before directed to be taken".

**SEVEN ..... SLAVE CLAUSE: CONSTITUTION, ARTICLE I, SECTION 2 CLAUSE 3.**

( As three - fifths of a person is how all slaves are legally counted) "Representative and direct taxes shall be apportioned among the several states which may be included within this union, according to their respective number, which shall be determined by adding to the whole number of free persons, included those bound to service for a term of years, and excluding Indians not taxed, three - fifths of all other persons".

**No Bill of Attainer or Ex Post Facto law shall be passed.**

With the examination of the organic Constitution, it is very clear that no government official, nor the Congress can make a law or use the limited power allocated to them through the Sovereign Authority of the Constitution of the Republic of the United States of America, to make or pass any law contrary to, or not in harmony with the Constitution. See Article one (1), Section nine (9), Clause three (3). No Bill of Attainer or Ex Post Facto law shall be passed.

**Moorish Scientists Fall to Religion**

The Ancient Moabites/Moors were master scientists: Astrologers, Mathematicians, etc., building civilizations, governments and religious philosophy on the divine principles and laws found in Nature, Herself. Now, the unconscious Moors think that nations are "shades" and "colors," and have lost their sovereignty to the European Colonial Company Guilds- thinking that they, the Guilds, are the National government. This is the pitiful state of mind in the people and the unknown truth that is at the root of what the subjugated people in this society call racism and prejudice. If they only knew!

The Ancient Moabites/Moors knew the Astrological and Metaphysical makeup of themselves, knew the planet Earth and Her functions, knew the Solar System, knew Universal Natural Laws, knew the functional power of the Womb, etc. Now the blinded and branded descendants of this great People are merely believers in anything and any opportunist who seeks to use them or sell them an idol god. Slavery!

**The Franciscan Brotherhood and the Blois (blwa)**

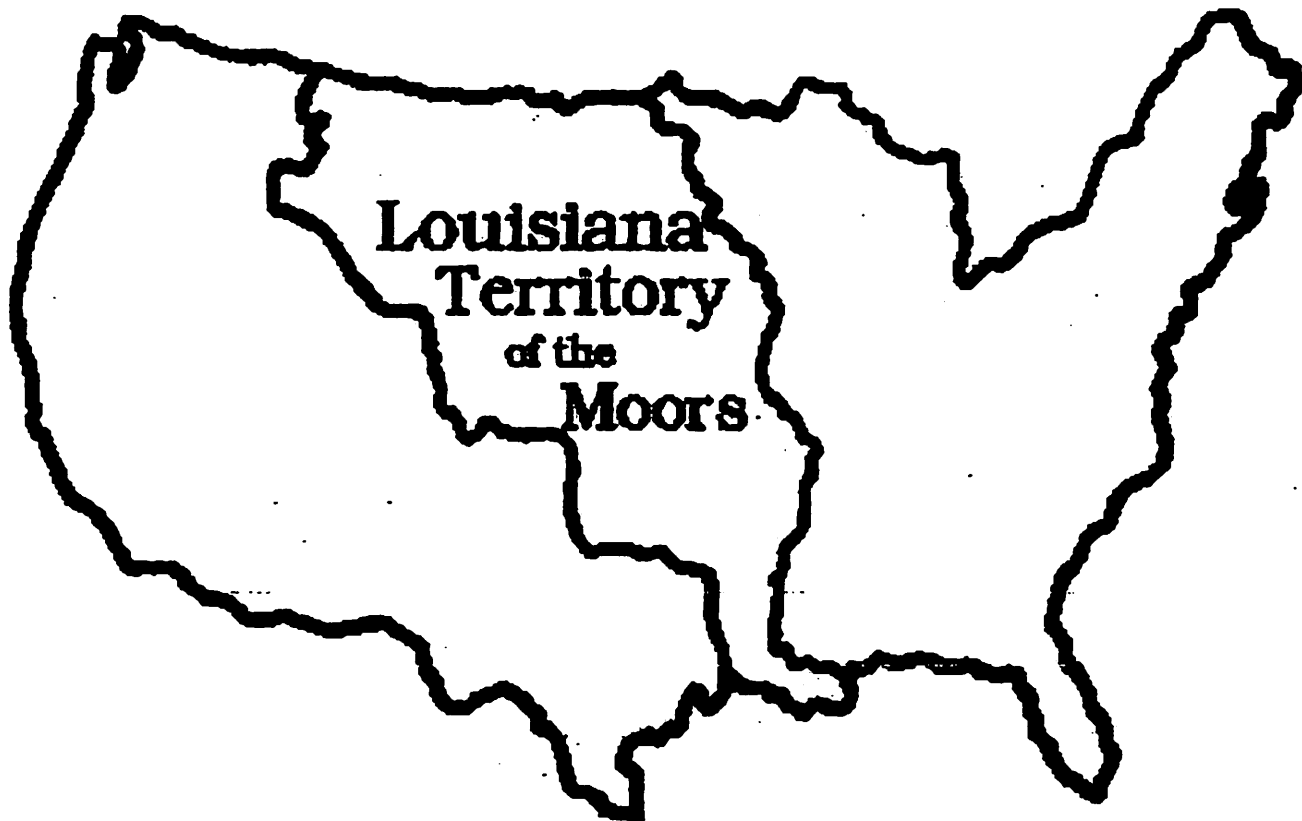
The Franciscan brotherhood is the combined Grand Body of the several Roman Catholic religious Orders. They were often called Gray Friars. The common garment worn by the Franciscans is called a HABIT. The Habit is long cloak-like garment with a loose fitted hood. The Habit is patterned directly after the old and ancient Moorish Jellaba.

To the Franciscan Brotherhood goes the political, historical and social Christian Honors (In Hoc Signo Vincas) for the overthrow of the Imperial Moorish Empire of the Order of Islam, in the Western Hemisphere. It would also benefit the reader to research the Daughters of the American Revolution (D.A.R.)

The Franciscan Brotherhood adopted the ruthless feudal system of the Blois and their methods of making fraudulent contracts. They would make non-mutual (fraudulent) treaties to steal land from the indigenous Moors. In the tradition of the Blois, they would deceive and slaughter the Indigenous peoples and steal the land. This method of conquering was polished to an art through the Spanish Inquisition (the Inquisition against the Muurs/Moors).

It must be noted that many of the wars and conflicts assumed to have taken place in what is known as Europe today, actually took place in the Western Hemisphere - the Al Morocs (Americas). The so-called Spanish of the Americas (Al Morocs) are Muurs/Moors. Mass colonial controlled education (indoctrination) is deliberately misleading and is designed to displace the Moors from the land (Al Morocs). This was done through geographical map alterations conjoined with rewritten histories and records (The Great Conspiracy).

### The Louisiana Territory Theft



One prominent example of land theft and slaughter of Moors in the Moorish territories and provinces (falsely called Spanish to displace history and geography), was this fraudulent **Louisiana Purchase** of 1800-03. This theft and sale was directly patterned after the **Blois** and the **Inquisition**. This same treaty and trade system was adopted and used successfully by the Union of States Society (U.S. of A.). The **Blois** would make a deal or treaty, break that deal or treaty and steal the land by whatever means necessary. The **"Make a deal and Cheat" Blois system** of usurpation, murder and the formulated "grab the land" tactics of the **Roman Church Inquisition** are very clear and evident in the Union of States' political makeup. The **Church Inquisition** never ended, upon examination of the historical records and the Colonists' treaty violations and war tactic patterns.

The **France** falsely claimed ownership of the **Moorish Territory** known today as the **Louisiana Territory**. **Napoleon Bonaparte** planned to establish a great **Roman Empire** in the Western Hemisphere of the weakened and falling **Moorish Empire**. He sent an army to accomplish this usurpation, but Napoleon's army was defeated in San Domingo by the brilliant military tactics of a Moorish Chieftain. It was this failure and defeat of Napoleon Bonaparte (1803) by a Moorish Chieftain, that influenced his negotiation and the subsequent fraudulent sale of the Louisiana Territory to the competing Union of States Society Colonial government (U.S. of A.).

The fraudulent Franciscan to Union States sale of the **Muurs/Moors' Louisiana Territory** created conditions which caused more **Moorish slave rebellions** than at any other time in **North African (North American)** history. **North Al Moroc** was also called **North Africa** after a Frenchman (**Africanus**).

The unconstitutionality of the acquisition of these lands (Louisiana Territory) and the sovereign rights of the Wachita De Dugdahmoundyah Moors (The Mound Building Muurs) were ignored by the Union States of America's President Thomas Jefferson. Keep in mind that false and reconstructed history refers to these Muurs/Moors as Indians or Spaniards. The Americas (Al Moroco) are not India and the indigenous peoples are not Indians, they are Moors!

The Louisiana Territory was often spoken of as being the last stronghold of Allah-Moors - (Alamo) - upholding the Crescent and the Star against formidable odds. The Isle of Orleans never gave up all of the Moorish culture and maintains the use of the Moorish Crescent and Star. The inverted use of the Crescent and Star implies the Moorish Nation (Al Moroc) is in distress and usurped.

The claimed justification for the so-called Louisiana Province/Territory Sale, relating to the French and the so-called Spaniards (1795 to 1800's), and the subsequent sale to the Union States Colonists was and is fraud. Continuing disputes and battles took place in the succeeding years between the Moors and the foreign Colonial usurpers. One of the most famous battles that took place in the Louisiana territory is known today as "Custer's Last Stand".

General George Armstrong Custer was carrying out one of the ongoing Treaty-breaking Inquisition campaigns of purging the land of indigenous Moorish peoples. June 25, 1876 was Custer's day in the Sun. He met his fate, along with his troops of well over two hundred men at Little Bighorn. General Custer gained notoriety and fame among his Christian armies for his well-known slaughter of Moors. His reputation was surpassed only by his ruthless massacring of thousands of indigenous people, especially women and children. This was usually done by surprise attacks.

### **Flower De Luce**

The **Flower De Luce** (fleur-de-lis) is a Heraldic Amoral Emblem used by the kings of France. This Amoral Emblem was to play a more sinister role in Al Moroccan (American) history than that expressed in Heraldry. It became a favored mark for branding irons. The Flower De Luce is a three petaled iris flower, stylized (Iris Germanica).

The Franciscan Brotherhood (The Roman Catholic Church) is credited with the overthrowing of the Imperial Islamic Moorish Empire of North Al Moroc (America). North Al Moroc is also called The Temple of the Moon and Sun.



**The Flower De Luce**

The conquering Christians (Europeans) of the Western Hemisphere would often use a Flower De Luce hot branding iron to brand (burn) indigenous Moslem slaves who resisted Christian dogma. Branding was especially used to mark those who would not willingly convert to Christianity. Anyone attempting to teach or maintain Moorish Culture or the sciences of Islam was subject to torture, ear cutting, branding or death. As slave trading mental warfare progressed in the Americas, branding slaves became less popular.

The disfiguring burns and cutting scars left by hot iron branding and torture, often reduced the selling prices offered for the slaves. A more profitable means or system of branding had to be found, to counter mounting loss of profits, due to the ritualistically inflicted scarring of the slaves. The Christian Dutch Masters devised an effective master plan to use as a substitute for physical branding, cutting scars and marks. The first step in that process was to remove the Noble titles of enslaved Moors. This branding system is best known as the **MARK THAT LEAVES NO VISIBLE SCARS**. The words NEGRO, BLACK, COLORED, etc., were also coined and used by the Albion masters as slave marks for permanent description labels on enslaved Moors. This clever branding system was later expanded to the public record. The defeated and enslaved Moors were now branded with the European slave masters' family surnames.

The European surnames were used to MARK the slaves as CHATTEL. This MARK or name branding system of description and ownership solved the sales problems caused by the traditional scarring of the bodies of the slaves. This brand system proved so successful that it was adopted countrywide and has lasted even until the present day (1993 +). One could easily identify a slave from a free man - simply ask the slave his or her name. If the slave answered affirmative to a European name, nothing else more needed to be said. With the acknowledgement of the slaveholder's surname, the slave could and would be seized, as she or he (the slave) just gave the PASSWORD, which revealed her or his political status.

### **The Witches of Salem (Salaam)**

The traditionally accepted burnings, lynchings and drownings of the WITCHES OF SALEM in Massachusetts by the Christian Peregrine (Pilgrim) Inquisitionists spread over most of North AL Moroc (America). It was a common religious ritual and practice to murder well over a hundred (100) women a day. These mass murders and burnings of indigenous Moorish women by the Christian Peregrines were ritualistically celebrated with song and food. The Pilgrims would often cut an ear, finger or toe from the bodies of the condemned women as souvenirs.

In the indigenous Moabite/Moorish culture, the women historically possessed the wealth of the family. The gold, silver and jewels of the Moorish tribes and families were commonly worn as intricate and elaborate jewelry, adorning the hair, turbans, keemars and bodies of the Moabite Women. In the Ancient culture, the family line was/is maintained and carried by and through the Women. The land and the wealth of the families were always passed from generation to generation through the highly cultured feminine gender- WOMAN.

The slaughtering of the so-called WITCHES OF SALEM in the Al Morocs (Americas) was, in truth, a concocted religious rationale for stealing the gold, silver, jewelry and robbing the Moorish Women, the Tribes and families of their LANDS. This is one of the reasons the Dutch Masters coined the words negro, black, colored, indian, Spaniards, etc., and used these appellations to separate the Moors from the LAND. The Christian Peregrinus (Pilgrims) were more wicked, debased and ruthless than any of the helpless women they murdered for their LAND and precious jewelry.



### **Salam - Salaam/Salaamu**

The Witches of Salam, in the true hidden history, is referring to the Women of Salaam-the Moabite/Moorish indigenous Women - falsely called indians, blacks and negroes. Their HIGH culture and civilization was built on the Divine Laws of Nature, Geometry, the Zodiac/Astrology, Al Cherny, the numbers 0 to 9, and the elevated operative knowledge of the electromagnetic color spectrum and its functional/applicable uses.

These combined sciences of the Ancient Ones is known as the Creed/Science of I.S.L.A.M. or Moabite/Moorish Science. The Europeans called these "Sciences" demonology. Salam is derived from Salaam. Salaam/Salaamu means "Peace". Peregrines burned, lynched, raped, drowned and quartered the Women of "Peace". The intent was to rob, kill and/or enslave the indigenous Peoples, destroying their Civilization and stealing their LANDS.

### **Autos da fe`**

Forcing Christianity on the defeated Indigenous Moors was a priority of the Church. Death, jail or torture came swiftly to those who resisted. The continuous mass burnings at the stake were affectionately called Auto da fe`, meaning "Acts of the Faith". Rosary beads, pieces of human flesh, trinkets and the confiscated jewelry, clothing, and property of the victims were sold and/or auctioned at these "burnings at the holy stake".

Autos da Fe` (plural) were well organized and often held in a carnival-like atmosphere. The participants had a joyous and profitable time. The accused women were often used in painful experiments before being burned at the holy stake. The common practice of forcing Christianity on the subjugated Moors comes directly from the INQUISITION and Articles 2, 3 and 5 of the past and presently modified BLACK CODES of 1724 A. D. The following are Articles 2, 3 and 5 of The Infamous Christian BLACK CODES.

#### **Black Codes - Art. 2,**

**Make it imperative on masters to impart religious instruction to their slaves.**

#### **Black Codes - Art. 3,**

**Permits the exercise of the Roman Catholic creed only, every other mode of worship is prohibited.**

#### **Black Codes - Art. 5,**

**Sundays and holydays are to be strictly observed. All negroes found at work on these days are to be confiscated.**

### **Ruthless Murders - with the Blessings of the Church (Capitalizing on the Carnage)**

Many European women secretly studied and adopted Astrology, herbal healing, meditation and the nature sciences of the indigenous Moors. If discovered by the Church or others, they would be tried as witches- beaten, raped, quartered and/or burned at the stake by order of the Church. This is the most common part of the witch-hunt history taught to the masses.

Anyone who recognized existing Natures' Laws or studied the stars was accused of being a sorcerer or a witch. If a Churchman coveted a woman's estate, all he had to do was accuse her of being a witch - she would be hanged, drowned or burned at the holy stake. The spoils (possessions of the accused) would be divided between the accuser and the Church. If a jealous Christian woman envied another woman, she could always use the "witch threat" to destroy or blackmail her rival. This was often carried out with cunning righteousness.

To expose and/or relieve the righteous community of a witch or sorcerer was certain to gain the support and blessings of the Church. The Witch Hunts and burnings at the holy stake made the Colonial Churches very wealthy institutions. The Church and the State became the largest land holders in a very short period of time.

Many innocent Peregrine (Pilgrim) women were accused of being a witch, stripped of their possessions and burned at the holy stake for refusing the sexual advances of vengeful Christian men. Many women suffered religiously justified rape and humiliation, with many other helpless women living in absolute fear, knowing they could be next. If a woman was accused of being a witch by the Churchmen, she would be tortured until she confessed - a no - win situation. This was always done in the name of God; therefore, it was considered holy, right and justified in the self-righteous eyes of the Church and the Men of God.

### **Idol - God Assimilation**

Over the years of European occupation, many of the Moabite/Moorish tribes and families mixed the Christian idol-god systems with their own culture, which was based on Natures' Laws. They were effectively hiding and disguising, yet maintaining parts of the original cultures throughout the Al Morocs (Americas). The Christians were killing the indigenous Moors who would openly live their own culture!

This mixing of cultures saved many lives through placation and assimilation, but it also corrupted the indigenous culture. As succeeding generations came and passed, much of the true Moorish culture, sciences and "self-knowledge" went to the grave with the elder generations. The present degenerated state of national, social and economic affairs among the subjugated Moors, therefore, speaks for itself!

In these CONTEMPORARY days, the descendants of the defeated Moors worship many different idol Gods. They propagate and make religious threats to each other of hell fire, death, damnation and poverty, if one does not give money to the other's Gods, Preachers, Rabbis, Imams, religious members, etc., to propagate their varied versions of God. This self-righteous and common activity is usually done in the name of DIVINE LOVE, SALVATION and promises of a heaven in the sky.

ONE obviously UNITED quality is displayed by the various GOD-SELLERS and their highly organized and profitable religious orders - THEIR GODS ARE ALWAYS PORTRAYED AS BEING IN ECONOMIC HARDSHIP. The Religionists claim that THESE GODS NEED THE CONSTANT FINANCIAL SUPPORT OF THE POOR AND OPPRESSED, or they will not communicate their life-saving message to the rest of the world.

THE STATE'S RELIGIOUS LEADERS CLAIM DIVINE ORDINATION BY THEIR GODS - DECLARING THAT THE PEOPLE OF THE WORLD WILL DIE, GO TO HELL AND NEVER KNOW THE WORD OR LOVE OF GOD, IF THEY DO NOT TITHE OR COMMIT THEMSELVES TO REGULAR MONETARY DONATIONS! LOOK OUT! THE DEVIL DID IT! LET'S RAISE MORE MONEY FOR GOD! IF YOU DO NOT GIVE MONEY TO GOD, GOD WILL NOT BLESS YOU! THE DEVIL IS GOING TO GET YOU!

Question: How many generations of poor, enslaved, oppressed, rejected and despised people must suffer and die before THE VARIED GODS OF RESCUE, PROPAGATED BY THE RELIGIOUS GOD-SELLERS, OUT-DO EACH OTHER, STOP THE INFIGHTING AND FULFILL THEIR OBVIOUSLY IDOL PROMISES?

WHERE ARE ALL THE COIN-OPERATED GOD-SELLERS, WHILE TIME HAS LONG SINCE PASSED FOR DELIVERY BY THEIR MORE THAN WEALTHY GODS? ### **Reclamation of Moorish Nationality**

There are many things and issues in need of resolution and reclamation within the Indigenous Moorish Nation. A proper forum for information, instruction and an enlightened "State of Mind", in reference to reattachment to our sciences, arts, culture and lands - the Al Morocs (Americas), is paramount. The reclamation of the Birthrights, Sciences and Heritage must first begin with the conscious National reclamation of oneself!

Moors must take on and accept the responsibility to organize, research, change their literature and teach their own! Those who have stolen the Moors' Birthrights are spoiled with the stolen wealth and land and are bloated with arrogance. They are not on some religious benevolent moral mission of exposing themselves by teaching truth about national sovereignty and its application. To tell the truth is to give back the LAND!

## **The SYSTEM**

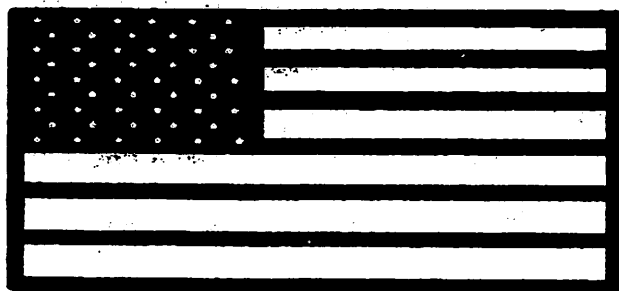

The Union of States' claims of legal jurisdiction over the land is colorable and fraudulent! Such claims are and have always been supported, not by De Jure law, but only by theft and the force of arms.



The six white stripes in the Star Spangled Banner stand for the Six European Colonial Company Nations. Those European nations are England, Ireland, Scotland, France, Germany and Holland.

Truth is not always hard to know or to find, it is just hard for some people to face! Truth does not always show a pretty face or express what some people would prefer to hear. Truth is just what it is! Can JUSTICE exist where falsehood and HYPOCRISY is PROTECTED. False national names, false law and fraudulent claims of sovereign authority has been perpetrated by these persons, as being real!

The present STATES' CORPORATE RELIGIOUS and CIVIL STATE WARD BLACK CODE SLAVE systems are now collapsing and continue to be too expensive to maintain! The costs of keeping these institutions on line already exceed the benefits! They enjoy and take for granted the civic normality of a PLEBISCITE. The Union of States' ordained leaders, clearly injected false history upon the people labeled negro, black, colored, etc. They have never addressed this disparity in its proper light. There is no need to insult the intelligence of a worm, claiming this to be an oversight. The literary misinformation by the States is direct policy derived from the Christian Black Code ordinances! Slave politics is rooted in the Church and is traditionally directed through and by ordained religious leaders and missionary agents.

The Black Codes are the result of the Union States governments effort to solve the ongoing problems of controlling and regulating (feigned as free) Freedmen. Though deliberately formulated to dehumanize the enslaved Moors (as blacks), the Black Codes varied in severity from State to State. As an example, the Black Codes, though cruel, were generally more lenient in the corporate Colony/State of Georgia.

Compared to Georgia, the Black Codes of Louisiana and Mississippi were extremely severe and reflected the most heinous practices of the religiously supported "Inquisition". The most troubling aspect of the Black Codes, as far as the Colony/States were concerned, was the problem of disguising the Codes into the general legislation of the Colony/State governments. The cover-up appears (due to ignorance) to be solved by the "laws for free negroes", the "vagrancy laws" and the crowning glory of them all - the 13th, 14th and 15th Amendments- the "Three dead badges of law". All Moors should do extensive research into the period of reconstructed history.

A most overlooked and least examined anomaly, in modern world history is the fact that while other nations of people, around the world, have regular and normal instructions in politics and civic institutions, there has not been and is no such instruction or order in the branded peoples' communities. To those who know the true history, this well established fact is NO SURPRISE OR REVELATION! Let those who have eyes to see and have the ability to face TRUTH, review a number of Articles from the OPERATIVE CHRISTIAN BLACK CODES OF THE UNITED STATES OF AMERICA CORPORATION.

The following are excerpts from the Union States of America's operative C.B.Cs

**THE CHRISTIAN BLACK CODES OF 1724:**

**Art. 1,**

**Decrees the expulsion of the Jews from the colony.**

C. B. Cs. Article number 1 reveals the fact that the so-called blacks are the true "Jews", and that it was always known by the Europeans.

**Art. 2,**

**Make it imperative on masters to impart religious instruction on their slaves.**

C. B. Cs. Article number 2 reveals the unquestioned blind faith and naive religious outlook exhibited by the labeled and branded Moors (blacks).

**Art. 3,**

**Permits the exercise of the Roman Catholic creed only, Every other mode of worship is prohibited.**

C. B. Cs. Article number 3 exposes the fact that Christianity was forced on the slaves, and did not originate with their forefathers in the form practiced today.

**Art. 4,**

**Negroes placed under the direction or supervision of any other person than a Catholic, are liable to confiscation.**

C. B. Cs. Article number 4 exposes the origin of the "NO ONE CAN TELL ME ANYTHING, BUT A CHRISTIAN WHITE MAN" attitude displayed by most people bearing the "black" brand.

**Art. 5,**

**Sundays and holydays are to be strictly observed. All negroes found at work on these days are to be confiscated.**

C. B. Cs. Article number 5 reveals the origin of the blind faith dedication to packing the Masters' churches on Sundays, by the slaves, who self-righteously accuse the prophets of the East of sanctioning such practices.

**Art. 6,**

**We forbid our white subjects, of both sexes, to marry with the blacks, under penalty of being fined and subjected to some other arbitrary punishment. We forbid all curates, priests, or missionaries of our secular or regular clergy and even our chaplains in our navy, to sanction such marriages. We also forbid all our white subjects, and even the manumitted or free-born blacks, to live in a state of concubinage with slaves. Should there be any issue from this kind of intercourse, it is our will that the person so offending, and the master of the slave should pay each a fine of three hundred livres. Should said issue be the result of concubinage of the master his slave, said master shall not only pay the fine, but be deprived of the slave and of the children, who shall be adjudged to the hospital of the locality, and said slave shall be forever incapable of being set free. But shall this illicit intercourse have existed between a free black and his slave, when said slave according to the forms prescribed by the church, said slave shall there by be set free and the children shall become free and legitimate; and in such a case there shall be no application of the penalties mentioned in the present article.**

C. B. Cs. Article 6 reveals the origin of the "Let the State have my children" attitude exhibited by slaves and wards.

**Art. 11,**

**Masters shall have their Christian slaves buried in consecrated ground.**

C. B. Cs. Article 11 exposes the origin of the common and obvious rejection of Eastern culture and religion by branded Moors (blacks). Encouragement to act contrary to one's own self and people is probably one of the most glaring character flaws observed among the slave descendants. This behavior apparently originates from a subverted people attempting to please their God-Master- the slaveholder, whose names they bear.

**These excerpts from the BLACK CODES expose only little of the vast and involved activities and investments of the Church in the past and current history of SLAVERY in the Al Morocs (Americas).**

**All Moorish Nationals, Master Masons, Doctors of Law and students of history- take note! Article 52 of the Christian Black Codes is the foundation for the DE FACTO, EX POST FACTO, UNCONSTITUTIONAL and FRAUDULENT (PRETEND THE SLAVES ARE CITIZENS OF THE UNITED STATES OF AMERICA) 13th, 14th, and 15th Amendment CIVIL RIGHTS FRAUD! Those among the people who know LAW are well schooled and are aware of these facts!**

**Religious and politically sponsored SNAKE OIL SALESMEN PROMOTE the false hopes, dreams, promises, aspirations, desires, wishes and prayers. Endless assumptions and promises of prosperity are**

imprinted in the minds of the unknowing. Opportunists leech on the unsuspecting and uneducated descendants of the DEFEATED MOORS - soliciting money, in the process! The **CIVIL RIGHTS TRADE** has created a MONSTROUSLY lucrative and entrenched industry in the United States of America Corporation. Many people owe their wealth and their fame to the cherished, yet unconstitutional Civil Rights Sacred Cow, knowing it was never constitutional LAW!

If there had been anything other than HIGHLY POLISHED HYPOCRISY AND GREED in the hearts of the COUNTLESS self-righteous opportunists, the truth about the **CIVIL RIGHTS TRADE** would have been revealed on a massive scale over a HUNDRED YEARS AGO! Again, truth needs no apology!

**Article 52 of the BLACK CODES** is the inspirational origin of over credited Civil Rights Color of Law. The Civil Rights Act was and is a cover up for continued slavery in the Union of States. The Civil Rights Act was, furthermore, declared unconstitutional by the Supreme Court of the Republic of the United States of America. Why is it so hard for State agents to reveal this foregoing truth to the unknowing masses whom they make their lucrative and comfortable livings off of.

#### **Art. 52,**

We declare that the acts for the enfranchisement of slaves, passed according to the forms above described, shall be equivalent to an act of naturalization, when said slaves are not born in our colony of Louisiana, and they shall enjoy all the rights and privileges inherent to our subjects born in our kingdoms, or in any land or colony under our dominion. We declare, however, that all manumitted slaves, and all free-born negroes are incapable of receiving donations, either by testamentary dispositions or by acts inter vivos from the whites. Said donations shall be null and void, and the objects of said donations shall be applied to the benefits of the nearest hospital.

C. B. Cs. Article 52. exposes origin of fake rights and privileges displayed in color-of- law ordinances and rules, used to deceive branded Moors (blacks).

Some of the definitions for the law terms used in the BLACK CODES have been placed in the **Ancillary** section of this Lesson Book. One may do research of other unfamiliar words and terms in an Unabridged Dictionary and a good Law Dictionary.

#### **Who are Free White Persons?**

Most people who have been educated through the standard public STATE (colony) school systems are not exposed to or aware that many of the words used in common conversations have a different meaning At Law. Assumptions are the accepted norm and commonly substitute for facts or actual knowledge.

We have inserted the true definition of FREE WHITE PERSONS, as defined At Law. Most miseducated victims of the corporate STATE controlled institutions think and believe, to the heart, that the adjectives, black and white, are nations and national pedigree/parentage names of human beings- namely, the dark and light olive complexioned Asiatics and the pale complexioned colonists- Occidentals/Europeans.



The controlling Industrialists, Professors, Politicians, most STATE ordained Religionists and other power wielding people are well aware that the words BLACK and WHITE, as used to describe people in the Western cultures are, in fact, STATUS CODE WORDS of CASTE and not the true national identity of any human beings.

Any so-called educated or qualified leaders or officials from the dark and light olive skinned subjugated peoples and communities should be aware of the true meanings of words and appellations which they use or attach to people. Due to their influence over the people, they have a responsibility to operate on facts, not on fictitious popular opinion. Mere beliefs cannot substitute for knowledge. Governments, law and economies function on mathematics, denotative words and functional scientific disciplines.

The following is an excerpt from H. C. Black's Law Dictionary- Forth Edition: West Publishing Co. All lawyers and judges are aware of this information- they are in possession of Black's Law Dictionaries for their law practice.

### **Free White Persons**

Free White Persons referred to in Naturalization Act, as amended by Act, July 14, 1870, has meaning naturally given to it when first used in Stat. 103, c. 3, meaning all persons belonging to the European races, then commonly counted as white, and their descendants, including such descendants in other countries to which they have emigrated.

It includes all European Jews, more or less intermixed with peoples of Celtic, Scandinavian, Teutonic, Iberian Latin, Greek, and Slavic descent. It includes Magyars, Lapps, and Finns, and the Basques and Albanians. It includes the mixed Latin, Celtic-Iberian, and Moorish inhabitants of Spain and Portugal, the mixed Greek, Latin, Phoenician, and North African inhabitants of Sicily, and the mixed Slav and Tartar inhabitants of South Russia. IT DOES NOT MEAN Caucasian race, Aryan race, or Indo-European races, nor the mixed Indo-European, Dravidian, Semitic and Mongolian people who inhabit Persia. A Syrian of Asiatic birth and descent will not be entitled to become a naturalized citizen of the United States as being a free white person. Ex parte Shahid, D.C.S.C., 205 F. 812, 813; United States v. Cartozian, D.C. Or., 6 F. 2d 919 921; Ex parte Dow, D.C.S.C., 211 F. 486, 487; In re En Sk Song, D.C. Cal., 271 F. 23. Nor a native-born Filipino. U.S. v. Javier, 22 F. 2d 879, 880, 57 App.D.C. 303. Nor a native of India who Belonged to Hindu race. Kharaiti Ram Samras v. United States, C.C.A. Cal, 125 F. 2d 879, 881.

### **Additional commentary on White Persons**

As one can clearly see the general public is not only ignorant of, but are sincerely convinced that there exists a nation of people, bearing the national name, **WHITE**. Ignorance is not only damaging to a civilized society, but it is also a socially dangerous state of mind and costly! The word WHITE is clearly defined At Law and is definitely a SOCIAL STATUS caste word.

For those who have been deceived by the States' institutions and their black, negro and colored agents, there is no longer a valid excuse for maintaining their use or propagating the false **black, negro, colored and white** people as being a nation. The generally accepted concepts of colors and shades, as national names, are fiction.

The people, falsely called negro, black and colored are **MOORS**, and they are the indigenous natural peoples.

The people, falsely called white are **Europeans**, and they are foreign aliens of colonial descent and are Magna Charta artificial corporate people.

The above is the true, yet hidden political state of affairs in the Western Territories known today as North America. The negro, black, colored and white people slave system is now exposed, dying in the light of the SUN! Mission accomplished!

### **Jamestown, Virginia - 1607**

On May 13, 1607, the London Company, known also as the Virginia Company, settled within the Moorish Dominions called, in these days, Jamestown, Virginia. Jamestown was the first permanent Anglo and Saxon European Chartered Colony Settlement. The Indigenous Moorish Tribes supplied the New Albion Settlers with food and assisted them in building housing. The Europeans knew very little of how to live off the land. Their agricultural and medicinal skills were so limited, that if not helped by the Moors, they would have perished as many had done before them.

Virginia is the most northern of the Southern States and was the first of the 13 New Albion Colonies. Virginia is a Commonwealth.

### **Lynchburg, Virginia**

Lynchburg is a town in Virginia Colony, named in honor of William Lynch. William Lynch was one of the most revered Christian slave masters in all modern Union States of America's history. His strategies of psychological and mental warfare control systems set the standard for the Union State's "NIGGER INDUSTRY".

The methodology of William Lynch's MENTAL ATTACK slave system has been proven so effective that it is still used in modern day Union States' religious and educational institutions. The Union States de facto State and Municipal institutions and governments reap high revenues from the Constitutionally unprotected negro, black and colored displaced persons. Most Union State's Cities, towns, boroughs and Municipalities depend almost entirely on revenues extracted from the government backed NIGGER INDUSTRY.

The NIGGER INDUSTRY is so well masked in the social structure of the Union States, that most abused people actually think that the States' governments and Municipalities are operating on mutual and sovereign Constitutional law.

...And you thought you were free.....just suffering from prejudice and a little race misunderstanding! A whole nation of people deceived and being destroyed for a lack of knowledge. For those who do not fear knowledge, here is a type copy of the famous William Lynch Letter used as a policy guide, along with the Black Codes, for State/Colony Institutions.

### The William Lynch Letter of 1712

1712, A.D.

Gentlemen:

I greet you here on the bank of the James river in the year of our Lord, One Thousand, Seven Hundred and Twelve. First, I shall thank you, the Gentlemen of the Colony of Virginia, for bringing me here. I am here to help you solve some of your problems with slaves. Your invitation reached me in my modest plantation in the West Indies where I have experimented with some of the newest and still some of the oldest method for control of slaves. Ancient Rome would envy us if my program is implemented. As our boat sailed south on the James river, named after our illustrious King James, whose Bible we Cherish, I saw enough to know that our problem is not unique. While Rome used cords of wood as crosses for standing human bodies along the old highways in great numbers, you are here using the tree and the rope on occasion.

I caught a whiff of a dead slave hanging from a tree a couple of miles back. You are losing valuable stock by hangings, you have uprisings, slaves are running away, your crops are sometimes left in the fields, your animals are killed, Gentlemen.....you know what your problems are; I do not need to elaborate. I am not here to enumerate your problems, I am here to introduce you to a method of solving them.

In my bag, I have a fool proof method for controlling your slaves. I guarantee everyone of you that if installed it will control the slaves for at least three hundred years. My method is simple, any member of your family or any overseer can use it.

I have outlined a number of differences among the slaves, and I take these differences and make them bigger. I use fear, distrust and envy for

control purposes. These methods have worked on my modest plantation in the West Indies, and it will work throughout the South. Take this simple little list of differences and think about them. On the top of my list is "age", but it is there because it starts with an "A"; the second is "Color" or Shade; there is Intelligence, size, sex, size of plantations, attitude of owners, whether the slaves live in the valley, on the hill, east, west, north, south, have fine or coarse hair, or is tall or short. Now that you have a list of differences, I shall give you an outline of action - but before that, I shall assure you distrust is stronger than trust, and envy is stronger than adulation, respect or admiration.

The black slave, after receiving this indoctrination, shall carry on and will become self-refueling and self-generating for hundreds of years, maybe thousands.

Don't forget you must pitch the old black vs. the young black males, and the young black male against the old black male. You must use the dark skinned slave vs. the light skinned slaves. You must always have your servants and overseers distrust all blacks, but it is necessary that your slaves trust and depend on us. They must love and, respect and trust only us.

Gentlemen, these kits are your keys to control, use them. Never miss an opportunity. My plan is guaranteed, and the good things about this plan is that if used intensely for one year, the slaves will remain perpetually distrustful.

### **Correlation of Church and State Operations**

It becomes undeniably apparent that the Inquisition against the Moors and Jews, by the Roman Catholic Church, is the foundation for modern Wardship and Slavery. The famous psychological war letter and social engineering program initiated by William Lynch on Plantations in the West Indies and later adopted in Jamestown Virginia in 1712, was apparently inspired by the Roman Catholic Church Inquisition. The Christian Black Codes of 1724 and the present day Church, State, City and Municipal civic ordinances, policies and programs are definitely related, organized and correlated.

When one discovers or uncovers the root to a problem or system, one then has some available knowledge for applying tools of remedy. Exposing the fact that the colonial States are operating by the Black Codes, allows insight for beginning a process for making solutions and corrections. Intelligent resolutions to the many spiritual, social and economic problems become obvious. Use them! Reject and render to the Romans their false claims of sovereignty over yourself, your people and your lands. Go back to the principles of your ancient Mothers and Fathers. Reclaim your Birthrights.

## **The Christian Black Codes of 1724 and the Motives of the States**

Generation after generation, people bearing the political caste word labels of black, negro, colored, indian, west indian, puerto rican, hispanic, latino, etc., spent futile efforts, time, life and finance trying to solve the- *appearing to be real* - PREJUDICE AND RACE PROBLEMS- in the United States of America (Colony/States of the Union). Black, negro, colored, latino, Hispanic and other displaced peoples are not and can never be citizens of the Union of States and are never viewed as such, by Union law. They are non-mutually governed by the States' laws of commerce, and are regulated as State property.

The highly promoted prejudice and race problems in the United States of America are actually tools of SOCIAL ENGINEERING. The States strategically ordain and place (black, negro and colored) agents in controlled "negro organizations" to give the "race and prejudice argument" credibility. They are used to cover up the operative BLACK CODES, the NEGRO ACTS and other rules and regulations which are integrated into ALL CORPORATE STATE LAW and their COURT SYSTEMS!

The BLACK CODES are used to control the defeated Moors, mainly through the STATES' enforced rules and regulations, feigned as law. Keep in mind that all the STATES use COLOR OF LAW, as they are colonists and foreigners, and the years of European occupation in the Al Morocs (Americas) cannot change that fact! Color of Law is not TRUE or REAL LAW. The CORPORATE UNION OF STATES and their sub- agencies always use BLACK CODE rules, regulations and policies to effectively maintain hidden slavery.

The hidden motive of operations of the STATES is to steal the land, enslave the people, steal their birthrights (heritage/sovereignty) and to force the people into volatile and one-sided agreements that aid in their own enslavement through coerced contracts, licenses, taxes, permit taxes, property taxes, etc. The economies of the indigenous Moors are further subverted by forced, non-representative State taxation, regulations, ordinances and State sponsored religious dogma beliefs. The following are some of the targeted areas, actions and systems used for perpetual CHATTEL SLAVERY AND WARD CONTROL:

### **Tuskegee "GERM WARFARE EXPERIMENT"**

In order to maintain "objects" for medical experimentation, the State hospitals and the State penal institutions cooperate very closely. Displaced persons (blacks, negroes, coloreds) have traditionally been used for disease and germ warfare experimentation. For example: the Colony/State government of Alabama's ongoing experiments on Constitutionally unprotected State ward (black, negro, colored) prisoners, such as the Tuskegee Incident. The Tuskegee experiment lasted approximately 40 years (1932 - 1972) and involved the deliberate injection of the syphilis germ into the bloodstreams of a large number of (blacks), keeping records of the progressive degeneration of the victims and their families. The only thing unusual about the Tuskegee incident is that it became public and was used to highlight ongoing "**Nigger Industry**" problems and violations.

**State/Colony Hospitals: "WARD REGULATIONS AND ORDINANCES"**

**Colony/State Hospitals** derive their authority to confiscate slave/ward children at the slightest provocation. Many so-called black, negro and colored State wards have and continue to suffer from such confiscation. This activity is currently carried out by the Union of States "Welfare agents with State ward regulations and ordinances". This is designed to maintain destabilization in the Moorish families. As State "property", the wards have no "self" rights. For references, see **Black Codes, Articles number 21, 34 and 52.**

**State/Colony Schools: GERM, VIRAL and DRUG EXPERIMENTS**

**The Colony/State schools and other agencies** have a long tradition of experimenting on ward children, with germ and viral injections into their bloodstreams. The State ward chattel (black, negro, colored, hispanic children), have no sovereign constitutional protection from these experiments, attacks or whatever the State governments mandate to be done to them. These State/Colony corporations and their agencies' activities are often made mandatory. Mandatory means that the victims have no "self" authority. Who can honestly argue that the Union of States Society is not the "slave holder" and enforcer of the Black Codes?

**F E A R**

The word, FEAR means: a feeling of anxiety and agitation caused by the presence of danger, evil, pain, etc.; timidity; dread; terror; fright; and apprehension.

Fear is the passion of our nature which excites us to provide for our security, on the approach of evil. Fear is a feeling of uneasiness; disquiet; anxiety and concern. Fear is to feel a reverence for; to have a reverential awe of; or veneration for a person, people, place or thing! To feel a painful apprehension for a person or thing of evil. Fear is to terrify or to affright.

Fear is a major servitude control tool used by the Union States Society. This fact must be remembered by all Moors, governed under the subversive States' color-of-law and ordinances. When the denationalized Moors (labeled black), learn the truth about **Nationality, Birthrights, Sovereignty** and the origin of law, a mighty truth will become glaringly exposed! That exposed truth is that the mean spirited social, physical and economic **FEAR** rooted in the **Union of States Society** is perpetuated by **FALSE EDUCATION APPEARING REAL!**

The unlawfully operating officials of the STATES' governments (European Colonial descendants and their hired indigenous agents) use threats, coercion, duress, legal theft, deceit, murder by State statutes, police powers acts, etc., to enforce fraudulent laws and

ordinances. The use of FEAR as the foundation and method of government is vital to any de facto government body. These Colonial States' laws and ordinances are designed for the benefit of the States, exclusive of the mutual agreement of the non-citizen, indigenous and subjugated Moors.

For lack of knowledge, the legally abused Moors think (incorrectly) that they are citizens of the Union of States, therefore, submitting to false law, which actually does not originate from their own sovereignty and does not apply to them, but only to the descendants of the Colonists. The loss and threat of loss of life, liberty and property, directed toward the indigenous Moors (labeled black, etc.), is the STATES' standard of operation.

The peoples of the UNION OF STATES governments and their sub-government agencies consciously use FEAR as a subjugation and suppressive SLAVE making mechanism. They have strategically put their NAMES on the SLAVES as a curse and MARK of property and possession! Remember this fact and teach your children. The revelation of these secret political functions will begin the final and inevitable destruction of the long-lived NIGGER INDUSTRY!

FEAR, as used in political subjugation, oppression and teaching IS ONLY:

**F = FALSE  
E = EDUCATION  
A = APPEARING  
R = REAL**

### **THE DEMONIC ILLUSION OF THE AGES!**

Fear not! Fear is a master tool of the SLAVE and WARD keepers of the dark side of uncivilized human behavior, and is used extensively in Colonized societies. Seek the knowledge and truth about Nationality, Birthrights, Sovereignty and how all and any De jure government lawfully makes law and operates by the Peoples' LAW.

All true and lawful governments emanate directly from the People over whom they govern! The people of a particular government must be part and parcel of that government's national contract. A Nation's contract is the LAW OF THE LAND and is known universally as a written Constitution! All real and true laws of a nation are measured by its Constitution, not by any other ordinances, rules or statutes. To be a lawful citizen of a said government, one must be an original member of the political body or pedigree descendant of that particular nation or government! This is the truth of Nations and governments all over the world! Know the truth and the truth will set you free!

In response to the States' agents who will certainly dispute these facts with their orchestrated beliefs, claiming that they have been teaching the people the truth... ask them this question;

"If we have been taught the truth, why are we not free?"

All Asiatic peoples (Moors) who cling to the NAMES, LABELS and MARKS put on them by the European Colonists and their descendants, must know or be taught the lawful facts that the use of these brands steal their birthrights and SEAL THEIR LEGAL ENSLAVEMENT! The use of the words NEGRO, BLACK, COLORED, WEST INDIAN, PUERTO RICAN, COON, AND ANY NON-ORIGINAL names as substitutes for their detached national names, makes them the legal property of the Union States of America Corporation!

The Union States of America (U.S. of A.) does not represent or relate to the people of the land, but only the foreign Corporation of alien European slavers, in juristic corporate capacity. They are operating fraudulently as the Sovereigns of the Land! The true Sovereigns of any land are only the Indigenous peoples of the land! Moors are the Indigenous peoples of the Continental United States - the Al Morocs (Americas).

To cover up and hide the necessary truth of the National Sovereign origin of the LAW OF LANDS, the COLOR CODES were coined by the Dutch MASTERS AND THE FRANCISCAN BROTHERHOOD (Roman Catholic Orders). This was done to steal peoples birthrights and their lands! This is the absolute truth of modern slavery and false racism! Hence, the blind faith belief that people are BLACK and WHITE!

White means purity. Purity means God. God means the ruler of the land! Black means political death and Civilliter Mortuus. Black also means foul, wicked, unconscious and everything negative. The SEAL of the BLACK CODES is broken. A ROOT of the once secure ALIEN LEECH SYSTEM is now exposed to the SUN! The names, marks, brands and labels must be returned to CAESAR (the Roman rulers)!

The BLACK CODES are at the heart of the Aliens' GOOD-OLD-BOYS' network of government. The BLACK CODES of the HOLY ROMAN EMPIRE is the source and order of LAW from which the Union States of America derive and comprise their laws and ORDINANCES to govern displaced persons (blacks)! The Black Codes is an offspring of the Inquisition and Magna Carta, with its siblings, the Knights of Columbus and the Ku Klux Klan.

It becomes undeniably obvious that the Black Codes is a primary Slave



document, adjusted and revised in modern State ordinances, rules and policies to serve the contemporary political servitude needs of the several States. With the States and their agencies enforcing the Black Codes, no Union States Citizen (colonist) appears to be the culprit.

Though wordings and social developments may have changed, to a degree, the spirit, function and purpose of the Black Codes have been clearly preserved and maintained in the Union of States' County, City and Municipal codes, laws and ordinances. The absolute and dedicated enemies of the indigenous Moors have disguised themselves as the government of all the people. Moors- labeled as blacks - unknowingly cast fraudulent votes, using European surnames. This unlawful use of the Allens' names perpetuates their own economic demise. This is one of the most successful forms of slavery and wardship ever devised.

**Beware: Keep this fact in mind while reading this information..! The word, COLONY was substituted with the word, STATE, in the Union of States' documentation and written history. The words COLONY and STATE are synonymous in STATES' law. For example:**

**A. The STATE requires slaves (blacks) to buy a license from one of the STATE agencies in order to work or practice a trade.**

Statement A. is equivalent to statement B., as follows:

**B. The COLONY requires slaves (blacks) to buy a license from one of the COLONY agencies in order to work or practice a trade.**

- See Article 15 of the Black Codes.

**Remember that any STATE mandated instrument (licenses, etc.), are taxes. No rights of any people can be taxable, At Law. It should be clear to the reader by now, that (blacks) have no rights!**

## **THE COLONIES AND THE STATES ARE ONE!**

### **Some Black Code Ordinance Effects**

The Corporate Union of States have strategically and logistically used the Christian Black Codes of 1724 to bring about specific social and economic effects. The effects of operating with rules and laws that the victims (blacks) are not aware of, affords the victim no defense, whatsoever. It is literally the equivalent of giving a poisoned piece of candy to a child. A small boy or girl will happily eat the candy and assist in their own destruction.

**EXAMPLES OF EFFECTS, BY CAUSE OF THE BLACK CODES USED BY THE SEVERAL COLONY / STATE CORPORATE JURISDICTIONS:**

A. The States use force of arms and regulations to deny any **Sovereign** activity among the defeated and enslaved Indigenous Moors labeled black, negro, colored, indian, west indian, latino, puerto rican, hispanic, etc. They, as blacks, have little to no knowledge of what Sovereignty is and the agents among them certainly will not teach such subject matters. Ergo, assistance from ignorant and willing slaves to assure their dependent and servile position to the States.

B. The States use regulations and coercion to deny legitimate status to all marriages, not sanctioned by the STATES. They ordain ransom fees for such marriages for the STATES' coffers. All non-STATE sanctioned marriages are labeled illegitimate, along with any offspring (progeny) coming from such marriages or natural unions not arranged through **STATE (G.O.D.)** agencies. Slaves must pay the STATE in order to legally mate. This infers control of the womb to the States' authority, thus, slave family birth control. Refer to Article 8 of the Black Codes to see origins of States' marriage license. For example, see Article 7 of the Black Codes, for the origin of State laws on conditions of marriage. Article 9 of the Black Codes reveals the origin of the Several States' use of the STATE WELFARE system and its sub-agencies' abuse of power, used to control adhesive contracted and enslaved families and especially their offspring. Article 9 of the **Black Codes** is used by STATE agencies to confiscate slave / ward (children) without lawful due process, as slaves (blacks) have no Constitution for their lawful protection. The States' foundation for the Welfare System subsidies is also found in Article 20 of the **C.B.Cs**. The origin for the States' welfare medical subsidies may be found in Article 21.

**C.** The States use force of arms, taxation and regulations to deny any enslaved Moors' (blacks) ownership of property or land. All property in the possession of SLAVES will be the property of the STATE. A **TITHE** (tax) or rental fee will be maintained, hidden as **USE** and **PROPERTY TAXES**. These **TAXES** will be extracted by force with confiscation as a legal threat and action, if not adhered to! No area of possessions or property held by the unsuspecting slaves will be left untithed. With all things **TITHABLE**, no slave will ever be free and all land and property will essentially remain in Church and Colony control. Slaves will build and maintain **STATE/COLONISTS** properties and stolen land with diligent determination, thinking that they are owners of the property they possess. This state of fiction lives merely and only by faith and belief! The **STATES** issue only **FLOATING** titles to any property, real estate or land. All slaves are forced to register their properties to the **STATE** (Colonists). This gives all **POWER OF ATTORNEY** and **PROPERTY RIGHTS** to the States/Colonists which legally, but unlawfully denies property rights to the indigenous Moors to whom the land and property truly belongs. With this process, Moors are charged with a tax debt in their own land on their own property to a foreign entity (fictional **STATE**) that actually does not exist. This is how the land, America (Al Moroc), is stolen from the indigenous Moors. The States/Colonists, posing as **THE** government, are the thieves, not some secret men hiding behind the mountains, belonging to some secret order. To see origin of the above effects, see **Article 22** of the **Black Codes**.

**D.** The **STATES** methodically **ORDAIN** burdensome taxes, rules and regulations on land, property and business to assure a general state of stress, duress and poverty among all the defeated Moorish slaves (branded as blacks). This domestic administrative war act serves to foster perpetual economic chaos and disorder in and among the Moorish families, with the **COLONY / STATES** growing richer and wealthy in the process. See **Articles 22 and 23** of the **Black Codes**. Any slave who is unable to or unwilling to produce a pre-determined level of income for the **STATES'** coffers are subject to fines and jail. Ordinances for controlling and regulating Moorish families are relegated to the **STATES' NIGGER**

**INDUSTRY** and enforced through **STATE** agencies. Punishment, fines or jail is mandatory for any parent unable or unwilling to maintain **STATE** mandated standards of **WARD** dependence. **WARD** and **SUBJECT** obedience to laws **ORDAINED** by any of the several **STATE** governments is obvious in all municipal and local laws, rules and regulations. Observe!

**E:** The integrated **NIGGER INDUSTRY** is essentially the **BLACK CODES** in their past and present operative state. These **CODES** pervade all **STATE**, County, City, Municipal agencies and courts. The ordinances rules, laws and regulations of the Union States Society are the very heart of their economic existence. The rest is history, leading up to the present corruption and social disorder in the United States of America, falsely labeled as racism, prejudice and the so-called "double standard" laws.

**F.** In modern times, the **STATES' SLAVE CATCHERS** carry the title of **BOUNTY**

**HUNTERS!** They work as municipal and county corporate contractors. Slavery in the Union of States did not end in the year 1865, as taught to the controlled subject public. The masses are encouraged to religiously believe that the EMANCIPATION PROCLAMATION of January 1, 1863, by President Abraham Lincoln, ended slavery in the United States of America, proper and became law in 1865. This is not the case. The fact is that the Emancipation Proclamation applied only to the STATES which were in rebellion. 1865 was actually the year when most all the STATES' governments adopted the BLACK CODES, officially! Even the most severely affected victims of the CODES often believe they are suffering from what has been called RACISM. Unfortunately, they have no idea of the brevity of the MONSTER, whom they, and their children have been dealing with and suffering from! Article 24 of the Black Codes shows the origin of forcing slaves / wards to pay the States for permits to MARCH or have PUBLIC ASSEMBLY. Article 24 also indicates the origins for slaves / wards having to pay the States for licenses to work or conduct trade. Article 24 also indicates the lack of any meaningful protections or self-authority in legal matters when it involves slaves / wards (blacks).

G. All Church and State sanctioned marriages, in all respects, come directly under the States' POLICE POWERS! The States' POLICE are ROMAN SOLDIERS! See Article 7 of the Black Codes. The marriage license, the unsuspecting signers of the States' licenses and the children from such marriages are (CHATTEL) State property, sealed by the marriage certificate contract with the State! The UNINFORMED people, who marry under the authority of the Church and the State, are made WARDS and SLAVES, by contract - sealed by their own signatures to the licenses and certificates of the Union States. How many people are aware of this fact? Very few! The slaves (blacks) have been taught to think that they have made their vows of marriage to and before the Divine Supreme Being. This is not the case and is the farthest thing from anything resembling truth! The unsuspecting victims of CHURCH and STATE MARRIAGES buy and sell themselves, never having a clue that they have made a PACT (contract) with the STATES/ COLONISTS, the avowed enemies of themselves and their forefathers!

H. Slaves, having no legal self-authority, shall be forced by the State, County and Municipal courts' colorable officers, to pay the State's lawyers of the English Bar Association, to represent them in all legal affairs. This activity takes place due to the legal fact that as (blacks) they have the status of child or a minor (minority) and cannot legally speak for themselves. This is why State judges always act as agents for the Bar Association of which they are members! The obvious CONFLICT OF INTEREST displayed by judges acting as solicitors for their Bar Association in the feigned-as-fair courts is proof beyond doubt that the STATE courts are operating with the Black Codes and not on Constitutional law. The origin of the laws and rules governing the status of the slaves (minorities) in the Union States of America's jurisdictions may be found in Article 25 of the Black Codes.

I. The origin of the common arrogance practiced by the officers and judges of today's Union of State's courts and their acting with assumed jurisdiction, in the affairs of people

labeled negro, black and colored may be found in **Article 26** of the Black Codes. For insight into the origin of the fraudulent property taxes, enforced by the States and their sub-agencies, refer to **Article 22** of the Black Codes!

J. The States' practice of taxing and confiscating enslaved Moors (labeled blacks) out of their homes, land and property may be referred to in **Article 40** of the Black Codes. The States' slave/ward child confiscation laws used by their "Welfare System" is again found in **Article 40** of the C.B.Cs.

K. The common occurrence of police brutality and murder of branded Moors at the hands of the States' officers is legendary in the Union of States' history. Police routinely plant evidence to trump-up false charges and use the power of the States and the force of arms to abuse constitutionally unprotected slaves / wards (blacks). The arrogant position usually displayed by the State, City and Municipal police is based on their knowledge of the STATE courts' leniency historically afforded them by influence of **Article 39** of the Black Codes.

For all the social, economic and legal abuses suffered by the branded people (blacks) in North Al Moroc (America), a serious study of the **Christian Black Codes of 1724** will reveal the true and actual body of codes, rules and ordinances that the Union of States Society uses to maintain modern bureaucratic slavery. The truth about what is called "racism" in the United States of America is clearly exposed for all to see! The Racism argument is a cover up for the true source of social unrest and abuses- the Union of States enforcement of the Christian Black Codes of 1724!

For those of who have been exposed to this revealing information - remember- **YOU HAVE BEEN TOLD!** If you are one who claims to be **NEGRO, BLACK, COLORED, WEST INDIAN, INDIAN, PUERTO RICAN, LATINO, HISPANIC**, etc., it is in your best interest to drop such false labels immediately and reclaim your De Jure Nationality. To cling to these slave brands (Nigger Industry) and to transact any business whatsoever, in the European surnames, makes one legally subject to the Black Codes! One who has and or maintains such status (black), has no rights in this society to discuss or act upon, At Law! If you did not know these facts, you now have that information. We have informed you! It is now up to you to reform yourself! The door is open!

## PRESENTING THE CHRISTIAN BLACK CODES OF 1724.

### APPENDIX

**March, 1724**

### **BLACK CODES**

Art. 1,

Decreases the expulsion of the Jews from the colony

Art. 2,

Make it imperative on masters to impart religious instruction to their slaves.

**Art. 3,**

Permits the exercise of the Roman Catholic creed only, Every other mode of worship is prohibited.

**Art. 4,**

Negroes placed under the direction or supervision of any other person than a Catholic, are liable to confiscation.

**Art. 5,**

Sundays and holidays are to be strictly observed. All negroes found at work on these days are to be confiscated.

**Art. 6,**

We forbid our white subjects, of both sexes, to marry with the blacks, under penalty of being fined and subjected to some other arbitrary punishment. We forbid all curates, priests, or missionaries of our secular or regular clergy and even our chaplains in our navy, to sanction such marriages. We also forbid all our white subjects, and even the manumitted or free-born blacks, to live in a state of concubinage with slaves. Should there be any issue from this kind of intercourse, it is our will that the person so offending, and the master of the slave should pay each a fine of three hundred livres. Should said issue be the result of concubinage of the master his slave, said master shall not only pay the fine, but be deprived of the slave and of the children, who shall be adjudged to the hospital of the locality, and said slave shall be forever incapable of being set free. But shall this illicit intercourse have existed between a free black and his slave, when said slave according to the forms prescribed by the church, said slave shall there by set free and the children shall become free and legitimate; and in such a case there shall be no application of the penalties mentioned in the present article.

**Art. 7,**

The ceremonies and forms prescribed by the ordinance of Blois and by the edict of 1691, for marriage, shall be observed both with regard to free persons and slaves. But the consent of the father and mother of the slave is not necessary; that of the master shall be the only one required.

**Art. 8,**

We forbid all curates to process or to effect marriages between slaves without the proof of the consent of their master; and we also forbid all masters to force their slaves into marriages against their wills.

**Art. 9,**

Children, issued from the marriage of slaves shall follow the condition of their parents, and shall belong to the master of the wife and not of the husband, if the husband and the wife have different masters.



**Art. 10,**

If the husband be a slave, and the wife a free woman, it is our will that their children, of whatever sex they be, shall share the condition of their mother, and be as free as she, notwithstanding the servitude of their father; and if the father be free and the mother a slave then the children shall all be slaves.

**Art. 11,**

Masters shall have their Christian slaves buried in consecrated ground.

**Art. 12,**

We forbid slaves to carry offensive weapons or heavy sticks under the penalty of being whipped, and of having said weapons confiscated for the benefit of the person seizing the same. An exception is made in favor of those slaves who are hunting or are shooting for their masters, and who carry with them a written permission to that effect, or are bring designated by some known mark or badge.

**Art. 13,**

We forbid slaves belonging to different masters to gather in crowds either by day or by night, under the pretext of a wedding, or for any other cause, either at the dwelling or on the grounds of one of their masters, or elsewhere, and much less on the highways or in secluded places, under the penalty of corporal punishment, which shall not be less than the whip. In case of frequent offenses of the kind, the offenders shall be branded with the mark of the flower de luce, and should there be aggravating circumstances, capital punishment may be applied, at the discretions of the judges. We command all of our subjects, be they officials or not, to seize all such offenders, to arrest and conduct them to prison, although there should be not judgment against them.

**Art. 14,**

Masters who shall be convicted of having permitted or tolerated such gatherings as aforesaid, composed of other slaves than their own, shall be sentenced individually, to indemnity their neighbors for the damages occasioned by said gatherings, and to pay, for the first time, a fine of thirty livres, and double that sum on the repetitions of the offense.

**Art. 15,**

We forbid negroes to sell any commodities, provisions, or produce of any kind, without the written permission of their masters, or without wearing their known marks or badges, and any persons purchasing any thing from negroes in violation of this article, shall be sentenced to pay a fine of 1500 livres.

**Art. 16, 17, 18, 19,**

Provide at length for the clothing of slaves and for their subsistence.

**Art. 20,**

Slaves who shall not be properly fed, clad, and provided for by their masters, may give information thereof to the attorney-general of the Superior Council, or to all the officers of an inferior jurisdiction, and may put the written exposition of their wrongs into their hands; upon which information, and even ex officio, shall the information come from another quarter, the attorney-general shall prosecute said masters without charging any cost to the complainant. It is our will that this regulation be observed in all accusations for crimes or barbarous and inhuman treatment brought by slaves against their masters.

**Art. 21,**

Slaves who are disabled from working, either by old age, disease or otherwise, be the diseases incurable or not, shall be fed and provided for by their masters; and in case they should have been abandoned by said masters, said slave shall be adjudged to the nearest hospital, to which said master shall be obliged to pay eight cents a day for the food, and maintenance of each one of these slaves; and for the payment of this sum, said hospital shall have a lien on the plantation of the masters.

**Art. 22,**

We declare that slaves have no right to any kind of property but that all that they acquire either by their own industry, or by the ability of others, or by any other means or title what ever shall be the full property of their masters; and the children of said slaves, their fathers, mothers, their kindred or other relation either free or slave shall have no pretensions or claim thereto, either through testamentary nor positions or donations inter vivace; which dispositions and donations we declare null and void, and also whatever promise they may have interred into by persons incapable of disposing of anything and or participating to any contract.

**Art. 23,**

Masters shall be responsible for what their slaves have done by their command, and also for what transactions they have permitted their slaves to do in their shops, in the particular line of commerce with whom they were entrusted; and in case said slave should have acted without the order or authorization of their masters, said masters shall be responsible only for so much as has turned to their profit; and if said masters have not profited by the dining or transaction of their slaves, the per curium which the masters have permitted the slave to own, shall be subjected to all claims against said slaves, after deduction made by the masters of what may be due to them; and if said per curium should consist in whole or in part of merchandises in which the slaves had permission to traffic, the masters shall only come in for their share in common with the other creditors.

**Art. 24,**

Slaves shall be incapable of all public functions, and of being constituted agents for any other person than their own masters, with powers to manage or conduct any kind of trade; nor can they serve as arbitrators or experts; nor shall they be called to give their testimony either in civil or in criminal cases, except when it shall be a matter of necessity, and only in default of white people; but in no case shall they be permitted to serve as witness either for or against their masters.

**Art. 25,**

Slaves shall never be parties to civil suits, either as plaintiffs or defendants, nor shall they be allowed to appear as complainants in criminal cases, but their masters shall have the right to act for them in civil matters, and in criminals ones, to demand punishment and reparation for such outrages and excesses as their slaves may have suffered from.

**Art. 26,**

Slaves may be prosecuted criminally, without their masters being made parties to the trial, except they should be indicted as accomplices; and said slaves shall be tried, at first, by the judges of ordinary jurisdiction, if there be any, and on appeal, by the Superior Council, with the same rules, formalities, and proceedings observed for free persons, save the exceptions mentioned hereafter.

Articles 27 to 32 of the Black Codes were not immediately available.

**Art. 33,**

Slaves who shall have made themselves liable to the penalty of the whip, the flower de luce brand, and ear cutting, shall be tried in the last resort, by the ordinary judges of the inferior court, and shall undergo the sentence passed upon them without there being an appeal to the Superior Council, in confirmation or reversal of judgment, notwithstanding the article 26th of the present code, which shall be applicable only to those judgments in which the slave convicted is sentenced to be hamstrung or to suffer death.

**Art. 34,**

Freed or born-free negroes, who shall have afforded refuge in their houses to fugitive slaves, shall be sentence to pay to the masters of said slaves, the sum of thirty livres a day for every day during which they shall have concealed said fugitives; and all other free persons, guilty of the same offense, shall pay a fine of ten livres a day as aforesaid; and should the freed or free-born negroes not be able to pay the fine herein specified, they shall be reduced to the condition of slaves, and be sold as such. Should the price of the sale exceed the sum mentioned in the judgment, the surplus shall be delivered to the hospital.

**Art. 35,**

We permit our subjects in this colony, who may have slaves concealed in any place whatever, to have them sought after by such persons and in such a way as they deem proper, so to proceed themselves to such researches as they may think best.

**Art. 36,**

The slave who is sentenced to suffer death on the denunciation of his master, shall, when that master is not an accomplice to the crime, be appraised before his execution by two of the principal inhabitants of the locality, who shall be especially appointed by the judge, and the amount of said appraisement shall be paid to the master. To raise this sum, and shall be collected by the persons invested with that authority.

**Art. 37,**

We forbid all the officers of the Superior Council, and all our other officers of the justice in the colony to take any fees or receive any perquisites in criminal suits against slaves, under the penalty, in so doing of, being dealt with as guilty of extortion.

**Art. 38,**

We also forbid all our subjects in this colony, whatever their condition or rank may be, to apply, on their own private authority, the rack to their slaves, under any pretense whatever, and to mutilate said slaves in any one of their limbs, or in any part of their bodies, under the penalty of confiscation of said slave; and masters, so offending, shall be liable to a criminal prosecution. We only permit, masters, when they shall think that the case requires it, to put their slaves in irons and to have them whipped with rods or ropes.

**Art. 39,**

We Command our officers of justice in this colony to institute criminal process against masters and overseers who shall have killed or mutilated their slaves, when in their power and under their supervision, and to punish said murder according to the atrocity of the circumstances; and in case the offense shall be a pardonable one, we permit them to pardon said master and overseer without it being necessary to obtain from us letters patent of pardon.

**Art. 40,**

Slaves shall be held in law as movables, and as such, they shall be part of the community of acquests between husband and wife; they shall be seized under any mortgage whatever; and they shall be equally divided among the co-heirs without admitting from any one of said heirs any claim founded on precipt or right of primogeniture, or dowry.

**Art. 41, 42,**

Are entirely relative to judicial forms and proceedings.

**Art. 43,**

Husbands and wives shall not be seized and sold separately when belonging to the same master, and their children, whom under fourteen years of age, shall not be separated from their parents and such seizures and sales shall be null and void. The present article shall apply to voluntary sales, and in such case sales should take place in violation of the law, the seller shall be deprived of the slave he has illegally retained and said slave shall be adjudged to the purchaser without any additional

**Art. 44,**

Slaves fourteen years old, and from this age up to sixty, who are settled on lands and plantations, and are at present working on them, shall not be liable to seizure for debt, except for what may be due out of the purchase money agreed to be paid for them unless said grounds or plantations should also be distressed, and seized and judicial sale of a real estate, without including the slaves of the aforesaid age who are part of said estate, shall be deemed null and void.

**Art. 45, 46, 47, 48, 49,**

**Are relative to certain formalities to be observed in judicial proceedings.**

**Art. 50,**

**Masters, when twenty-five years old, shall have the power to manumit their slaves, either by testamentary dispositions, or by acts inter vivos, but as there may be mercenary masters disposed to set a price on the liberation of their slaves; and whereas slaves with a view to acquire the necessary means to purchase their freedom, may be tempted to commit theft or deeds of plunder, no matter to set free his slaves, without the obtaining from the Superior Council a decree of permission to that effect; which permission shall be granted without costs when the motive for the setting free of said slaves as specified in the petition of the master, shall, appear legitimate to the tribunal. All future acts for the emancipation of the slaves freed shall not be entitled to their freedom; they shall be taken away from their former masters, and confiscated for the benefit of the India company.**

**Art. 51,**

**However, should slaves be appointed by their masters tutors to their children, said slaves shall be held and regarded as being set free to all intent and purposes.**

**Art. 52,**

**We declare that the acts for the enfranchisement of slaves, passed according to the forms above described, shall be equivalent to an act of naturalization, when said slaves are not born in our colony of Louisiana, and they shall enjoy all the rights and privileges inherent to our subjects born in our kingdom, or in any land or colony under our dominion. We declare, however, that all manumitted slaves, and all free-born negroes are incapable of receiving donations, either by testamentary dispositions or by acts inter vivos from the whites. Said donations shall be null and void, and the objects of said donations shall be applied to the benefits of the nearest hospital.**

**Art. 53,**

**We commend all manumitted slaves to show the profoundest respect to their former masters, to their widows and children, and any injury or insult offered by said manumitted slaves to their former masters, their widows or children, shall be punished with more severity than if it had been offered to any other person. We, however declared them exempt from the discharge of all duties or services, and from payment of all taxes or fees, or any thing else in relation to their persons, or to their personal or real estate, either during the life or after the death of said slave.**

**Art. 54,**

**We grant manumitted slaves the same rights, privileges, and immunities which are enjoyed by free born persons. It is our pleasure that their merit in having acquired their freedom, shall produce in their favor not only with regards to their**

persons, but also to their property, the same effects which our other subjects derive from the happy circumstance of their having been born free.

### **Ancillaries**

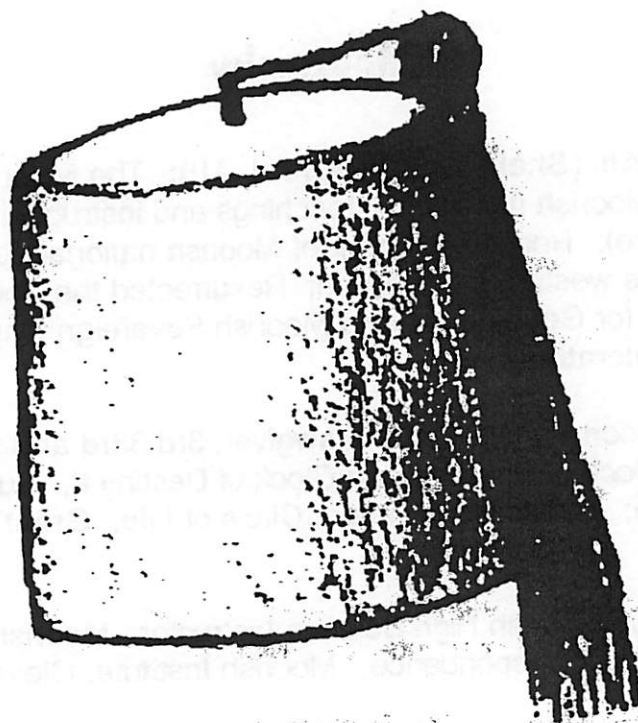
**Indemnity:** Reimbursement. An action or undertaking whereby one agrees to indemnify another upon the anticipation of a loss.

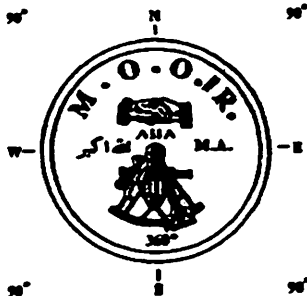
